QUESTION OF SENIORITY RIGHTS WILL BE OBSTACLE IN STRIKE SETTLEMENT

Railroads Accepted New Employees With Promise That They Would Be Given Full Seniority and All Rights of the Former Shopmen.

(By United Press.)
WASHINGTON, July 22.—The great obstacle in the path of a settlement of the strike of four hundred thousand railroad shopmen is the question of restoring seniority rights to strikers, Ben W. Hooper, chairman of the railroad labor board, summoned from Chicago, told President Harding today. Hooper gave the president a complete resume of the labor and to terminate the strike.

Hooper told President Harding that western and southern roads generally are ready to restore seniority rights to workers but that eastern roads feel that they are unable to do so because they have hired men to take the place of the strikers and the roads advertised that these workers would have the same rights as former employees. The roads, in event they restored the seniority of their former employees, might be forced to break up virtual contracts with the strikebreakers.

Senators Kellogg and Watson were the White House during the conference between Harding and Cooper, Kellogg and Secretary Weeks joined the conference shortly after noon.

Upon leaving the White House Hooper issued the following statement: "I have gone over the whole strike situation thoroughly with President Harding and have undertaken to give the complete history of the controversy in all of its phases down to the present time. I do not feel at all that we have reached the end of the road."

He expects to leave tonight for Chicago. The three senators who also attended the conference at the White House likewise declined to discuss the details of the meeting except to state that they believe the situation is serious.

Says Radicals Are Active.
CLEVELAND, July 22.—(By United Press.)—Daniel B. Robertson, president of the Brotherhood of Locomotive Engineers and Firemen, one of the "Four" brotherhoods, today stated that communists and other radicals are active in the ranks of the big railroad brotherhoods with the ultimate objective of overthrowing the government.

Robertson displayed a circular signed by J. Davis, secretary of the Committee of the Communist Party in America, in which the brotherhood officials were branded as traitors for submitting to the editors of the railroad labor board. The circular urged them to strike with the women and miners in defiance of the federal government.

Federation Pledges Support.
WASHINGTON, July 22.—(United Press.)—The United support of the American Federation of Labor pledged to the striking shopmen miners today as a result of action taken by legislative representatives of all labor unions. Samuel Gompers sent a telegram to Jewell and Hooper, expressing full sympathy and wishing the strikers every success.

Mines Reopened.
WASHINGTON, Penn., July 22.—(United Press.)—Scores of Western Pennsylvania soft coal mines opened yesterday under federal protection.

Posters Ordered Removed.
TOPEKA, Kan., July 22.—(Associated Press.)—The arrest of William A. White, of Emporia, author and editor for displaying a poster symbolizing with the striking railroad shopmen, will probably take place today, Governor Henry J. Allen announced following a report from Judge McCreary of the industrial court on his trip to Emporia and his failure to persuade White to remove the poster from his newspaper office window.

White determined whether or not a play of posters in violation of the Kansas industrial court act will allow White's arrest, but meanwhile Governor stated that "strike cards" have to come down from every window in Kansas.

Spencer Nolan, said to be a striker is held under \$500 bonds charged with kidnapping an employee of the Southern Pacific shop.

Clerk Strike Postponed.
CHICAGO, July 22.—(By Associated Press.)—The threatened strike of seven thousand three hundred clerks of the Chicago and Northwestern railroad is postponed for the time being at least, according to reports to the labor board. The company is reported to have made some concessions.

TEXAS PRIMARIES ARE ON TODAY

DALLAS, Texas, July 22.—Texas opened its democratic primary polls today. Voters will choose candidates for a warm campaign in which the Ku Klux Klan has been the chief issue. Six candidates including Senator Culberson, sought senatorial nomination. Candidates not receiving a majority at today's election will enter a run-off primary August 26.

MANDATES ARE GIVEN APPROVAL

LONDON, July 22.—The Palestine and Syrian mandates were approved today by the council of the League of Nations with the understanding that they will take effect as soon as France and Italy reach agreements concerning certain minor details. The Council announced that it is encouraged by the reported willingness of the reparations commission to suspend its claim against Austria for twenty years and let Austria regain her financial footing. Austria thus may pledge customs duties, salt monopoly and other assets as security for loans.

"LAST MAN'S CLUB" FEASTS.
STILLWATER, Minn., July 21.—Originally comprised of 43 members of the first Minnesota Infantry company, famous in Civil War days as "the last man's club," held its annual banquet here today in historic Sawyer house, with its five surviving members present.

Organized in 1884, the club members agreed to meet annually for banquet and get together on the anniversary of the battle of Bull Run.

In 1886 a bottle of wine was presented to the club by one of its members and it was agreed that bottle should grace the banquet table each year until only one member survived, and this "last man" should drink it as a toast to the departed members.

The bottle of wine is kept in a vault in a local bank and today it was taken out and from the banquet room under heavy escort. It reclined in a cherry wood case and held the honor position in the center of the banquet table.

FORD CARAVAN COMING TONIGHT

Will Arrive Here Late In the Evening and Will Remain Until Wednesday.

EXPECT LARGE CROWD

Parade on Monday Morning Will Usher In Two-Day Program Which Will Attract People From All Parts of County.

Making numerous stops enroute from Grants Pass, from which point the caravan departed northbound at 4 o'clock this morning, the Ford and Fordson power exposition will reach Roseburg about 8 o'clock this evening, remaining over Sunday for the Monday and Tuesday programs at Laurelwood park, and elsewhere in and near the city.

The southward journey of the caravan being chiefly in the nature of an introductory parade, actual demonstrations, lectures and other features were not undertaken until the caravan had reached Ashland. Since that time there has been a constantly increasing attendance on the return trip. Roseburg has arranged so fine a program, however, that it is doubtful if any other point between here and Portland will turn out a larger crowd.

Ushered in by the big Ford day parade, scheduled to leave Rose and Oak streets at 10:30 Monday morning, the caravan will provide sufficient variety to claim and hold the attention of farmers, business men, contractors, public officials and all others who are even remotely interested in the application of modern methods to the commercial and industrial problems of the day. Good movies will interest young and old alike, the DeLco washer and other household appliances electrically operated, will attract Madam Housewife, and word from W. G. Munro, of the Standard Oil company, is to the effect that the radio outfit now is rendering efficient service.

"We are vastly pleased with the reception accorded the caravan at every stopping place," said J. D. Jordan, assistant manager of the Portland branch, Ford Motor company. "Shortly after leaving Portland, we began to receive word and promise of a royal reception all along the line, and I am happy to say that even our most optimistic expectations have been more than realized."

"Owing to the crowded schedule to which we must adhere in order to complete the tour on time, we felt it absolutely necessary to omit certain stops and to curtail many others. However, upon traveling northward, we encountered so insistent a demand for actual demonstrations, or at least a stop of an hour or two, with educational talks, that we made slight changes in the schedule prior to entering Roseburg. It was for this reason that we decided upon leaving Grants Pass at 4 o'clock this morning in order to make Canyonville, Myrtle Creek, Riddle and Glendale Saturday and still reach Roseburg not too late to give the boys a greatly needed Saturday night and Sunday rest."

"A good deal of hard work is attached to the caravan," added Mr. Jordan, "but we feel more than amply repaid for our effort today, and we are particularly pleased with the splendid program arranged by the citizens of Roseburg. You may depend upon us to do our level best for the success of the show while here."

C. A. Lockwood, of the Lockwood Motor company, left this morning to join the caravan and accompany it to Roseburg. Mr. Lockwood is equally enthusiastic and predicts a program that will surprise and delight the large crowds for which preparation has been made.

"The caravan is a costly and ambitious undertaking," said Mr. Lockwood this morning, "but we are assured of so fine an attendance both Monday and Tuesday that we cannot help but be conscious of public appreciation of the project. I am sure the caravan will fully meet the expectations of all visitors, and we are prepared to receive and entertain one of the largest crowds in Roseburg's history."

FIGHT OPENED ON WOOL SCHEDULE

WASHINGTON, July 22.—The thirty three cents per pound duty on scoured wool proposed in the administration tariff bill would enable wool producers to make an average profit of ten per cent per year over a period of five years, Senator Bursum, republican, of New Mexico, declared today in the senate opening the debate on the wool schedule. Opposing the democratic attack, Senator Walsh said it could be shown that the cost to wool manufacturers of thirty three cents would be \$72,600,000 annually.

KLANSMEN ASSESSED FOR HALL RECOUNT

SALEM, July 22.—Salem members of the Ku Klux Klan are being assessed \$15 each to help finance the proposed recount for Charles Hall, according to a circular letter sent Klansmen with instructions to "read and then burn" a copy of which was given out today by the governor's office. The appeal declared that Hall is the "true and legal republican nominee."

FIVE KILLED IN TRAIN COLLISION

SPRINGFIELD, Mo., July 22.—Five persons were killed and several hundred were injured this morning when the eastbound San Francisco passenger train struck a San Francisco passenger westbound head-on in collision at Logan, Mo., twenty-five miles west of Springfield. Apparently a misconstruction of orders by Engineer Ring, who was killed, was the cause of the wreck, railroad officials reported.

Both engines were demolished and two steel coaches telescoped. The baggage cars were totally wrecked. Striking shopmen from Monett, Missouri, rushed to help in the rescue work. The injured were taken to the hospital at Springfield. Train number 2 and train number 9 went into an open switch, striking the standing train at full speed.

In addition to Engineer Ring of Sapulpa, Oklahoma, dead in the wreck, were Mr. and Mrs. Andrew Hammer of Stoutland, Mo., and two small sisters of Mrs. Hammer.

OREGON EDITORS DISCUSS PROBLEMS

CORVALLIS, July 21.—"The relation of the press to the government" was the subject of the talk by Roy Rogers, associate editor of the San Francisco Bulletin, before 150 persons attending the meeting of the Oregon State Editorial association this afternoon. He told of the great progress being made by the press of America and said that it is forward because it has tried to bring liberty and knowledge to the people.

The newspapers, in Mr. Rogers' opinion, are trying to bring a clearer realization of conditions politically, economically and socially. The politician fears the gibes of the editorial and the cutting cartoon more than the adverse remarks of his constituents, said the San Francisco editor.

Frank Jenkins, editor of the Eugene Register, spoke on the value of syndicate features. He said human interest is the value of the features and that the most conservative papers are coming to the use of features.

The real exciting stuff in the newspapers, such as the Los Angeles hammer murder, will die out, but "Bringing Up Father," "Mutt and Jeff," and "Gumps" never die, declared Mr. Jenkins.

Telling a story, giving statistics, quoting Shakespeare, calling somebody a liar are four things that are expected of a speaker, according to Bert Moses, of Ashland. He said he thought briefly in news articles really worth while, but he did not like the brevity in hair, skirts and modesty.

TAX COMMISSION WILL NOT CONDUCT HEARINGS IN SOUTHERN OREGON

Walter Pierce States Intention of Making Trip If Commission Goes and Other Commissioners Refuse to Complete Schedule as Announced.

Again politics have been allowed to enter into the affairs of the state tax commissioner, and the members of that organization refuse to complete the scheduled hearings if Walter M. Pierce, democratic candidate for governor, accompanies the commission. As a result of this decision the meeting which was set for July 25th in this city, has been cancelled, notice to this effect having been received by County Judge George Quine this morning.

Once before, the commission took similar action, that time being during the primary campaign when Mr. Pierce was seeking the democratic nomination. It was held that his position on the tax commission as it touched the state allowed him to, in a measure, conduct a political campaign at the expense of the tax payers and consequently the schedule was abandoned, after Mr. Pierce announced his refusal to resign.

Some time ago it was decided that the hearings would be resumed and that Mr. Pierce should stay at home. Mr. Pierce, however, decided otherwise. He was appointed to the commission with a certain duty to perform and he stated that he would be present to take his place on the commission and participate in the hearings.

His refusal to stay at home and allow the other members of the commission to proceed without him has caused I. N. Day, chairman of the commission, to call off all scheduled hearings and none will be held in southern Oregon. A hearing was scheduled for Medford on Monday and the commission would have come on to Roseburg Wednesday. Mr. Day states, however, that under the present circumstances, none of the commissioners will make the trip and the commission will proceed at once to draw up its report and terminate its activities.

A full explanation of the affairs is made in a letter received this morning by County Judge George Quine. The letter follows:

"I have been instructed to advise you that the meetings scheduled for Roseburg and other southern Oregon cities by the tax investigating committee, have been cancelled for the reasons embodied in the following telegram to Walter M. Pierce:

"Under instructions of the members of the tax investigating committee I have cancelled the public meetings scheduled for Medford and other southern Oregon cities. The committee is convinced that participation in the hearings by a member who is a candidate for governor would be an impropriety and lend a political tinge."

TWO PLANES ARE ADDED TO PATROL

EUGENE, July 22.—Two more patrol planes were added to the squadron of four already here yesterday with the arrival of Lieutenant Maxwell from Camp Lewis, Tacoma, and Sergeant Templeman from Crissy Field, San Francisco. Sergeant Templeman's plane ran out of gas on the last lap of his flight from California and he was forced to land just east of the golf links at the Country club, slightly damaging one of the wings.

Seven small fires were discovered yesterday in western Oregon in the Coast Range mountains. The patrols reported that these fires are all small and are mostly located in green timber. Lieutenants Maughin and Morgan were in the plane which flew northward over the mountains. Sergeant Fowler made a flight up the McKenzie and reported that the blaze started when the Blue River hotel burned Thursday night was running through the timber at a fast rate.

Lieutenant Goldsborough flew to Portland and remained in that city last night. He took Forester Scott over the northern part of the state yesterday afternoon.

APPLE CROP INSURANCE CAUSING HEAVY LOSSES

MARTINSBURG, Va., June 22.—Insurance men are doing a big business here with a new policy permitting the insurance of apple crops against damage by hail stones on the per barrel basis. Hundreds of thousands of dollars' worth have already been underwritten. The rate is \$30 on \$1000 of the valuation or nine cents on a barrel of fruit valued at \$3. The change in the form of the insurance has brought about a much lower rate. The crops are being insured by varieties. The insured period dates from issuance of the policy until October 20.

TEN MILLION DOLLAR MORTGAGE REQUIRES MANY REVENUE STAMPS

MARTINSBURG, Va., July 23.—If you are thinking of plastering a \$10,000,000 mortgage on property you own don't forget the little item of revenue stamps, which must be duplicated in each county wherein the mortgaged property is situated. The \$10,000,000 mortgage recently executed by the Potomac Service company, operating the Martinsburg Power company along with a number of similar industries, has been placed on record in the county required \$956.50 worth of revenue stamps.

MONEY APPROPRIATED FOR "MOON EXPLORER"

WORCESTER, Mass., July 22.—The trustees of Clark university have voted a special appropriation in order that Professor Robert H. Goddard may continue his work on the "Moon Rocket," with which he expects to explore the uppermost regions of the air.

Professor Goddard and his "Moon Rocket" attracted widespread attention a short time ago when he hoped to reach the moon with his invention.
