Umpqua Harbor Bill Accepted

REEDSFORT, July 29.—The local chamber of commerce has received a telegram from Senator Charles McNary as follows: "Senate accepted harbor improvement bill today." Judging from the telegram, the Port of Umpqua is making progress and that Senator McNary is still on the job. The way now seems clear unless some unforeseen obstacle arises that the Umpqua harbor will be certainly a recognized project by the government. How soon money will be available from the government for the improvement of the harbor will largely depend upon the future appropriation made by congress for this purpose. It is up to the people who are interested in the development of

the port and the harbor to be keenly alert at all times and not go to sleep in the matter with a feeling of certainty that their object has been accomplished.

The port should without any unreasonable delay begin to prepare for the improvement of the harbor and not wait until the government has made an appropriation for this purpose. We understand that a considerable portion of the last issue of port bonds have been bargained for and the bids for the sale of the bonds, the highest has been accepted. It is now up to the port to get the money as soon as possible and proceed toward the development.

Election Recount to Begin Monday

SALISBURY, July 29.—Attempts to saddle Olcott with at least a part of the responsibility for the Hall-Olcott recount for the republican nomination, by demanding that his answer to the petition of R. R. Coster, the figurehead and contestant of the May primaries, be stricken from the records unless he file a bond of \$20,000 failed when Circuit Judge George G. Fingham and Kelly overruled a motion to that effect yesterday and took under advisement until Monday the application of the Hall attorneys to file an amended petition.

The grounds upon which the Hall attorneys based their assertions that Olcott was now a contestant instead of a contestant, is the counter-content part of his answer. They hold that having filed a counter-content, the governor is therefore contesting the votes of Hall, and plainly a contestant.

"There is only one person in the state of Oregon over the age of majority who can not bring a contest suit," said Judge Fingham hotly at the end of the arguments, "and that is Ben W. Olcott. His nomination in the republican primaries is being contested and he wouldn't likely contest it himself. He has a right to file anything which will defend his election, providing it is in the regular procedure. Therefore the court feels constrained to overrule your motion."

The first outward injection of religious prejudice and hatred was brought into the case yesterday thru the application of the Hall attorneys to file an amended petition, which contains the added allegation that priests and officers of the Catholic church violated the corrupt practices act by exercising undue influence on and before the primary election among the voters of certain precincts.

This influence, as defined by the Hall attorneys, was other than "the spoken or printed word," and thru the peculiar hold which such officials of the Catholic denomination had over the voters in certain precincts, Olcott received a large majority over Hall. No specific instance of the exercise of this influence is mentioned in the petition.

These precincts are named as East Mount Angel, West Mount Angel, St. Paul, Sublimity, McKee, and West Gervina, all in Marion county, where Olcott received 842 votes and Hall 23.

Protesting against such an allegation being added, Jay Bowerman, attorney for Governor Olcott, said that the governor might find it necessary to allege undue influence on the part of leaders of the Ku Klux Klan, and that the allegation implied to them and other fraternal orders as well as to the Catholic church.
