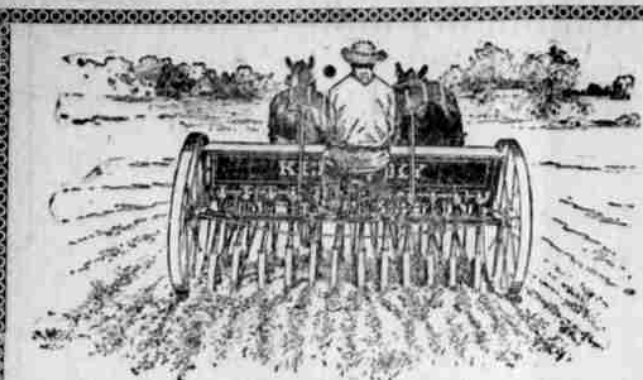
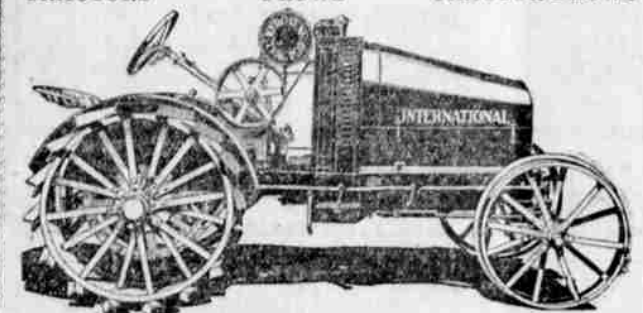

GOVERNMENT GIVES AID TO ERADICATE T.B. FROM CATTLE

WASHINGTON, Aug. 24.—Efforts of many states to eradicate tuberculosis among cattle have gained such headway that officials of the Department of Agriculture regard the end of the fight against the great cattle plague as a practical possibility.

"Many counties are now raising large amounts of money for this purpose," the department states, "and the clean counties have set an example that stimulates others to follow. Progressive communities are beginning to realize that they cannot have diseased herds and expect to compete with farmers and breeders in localities that are entitled to advertise that all of their cattle are free of tuberculosis."

According to records of the department, a dozen states now have one or more counties in which all of the cattle have been tested one or more times.

Oregon Takes Lead.

Oregon now has seven counties in this class; Washington and Wisconsin, four each; Michigan and Mississippi, three each; Nebraska and Montana, two each; and Idaho, North Carolina, Utah, Virginia and West Virginia, one each.

Intensive work directed toward the eradication of tuberculosis is now being done by 128 counties in 22 states. In this list Missouri has 18 counties; Nebraska, 16; North Carolina, 14; Maine, 11, and New York, 10. Preliminary work is being done in 256 counties and 79 communities in 33 states. Iowa has 31 counties in this list; North Carolina, 30; Idaho, 26; Kentucky, 28; Oregon, 23; New York, 17, and Nevada and Wisconsin, 10 each. Forty communities in Georgia, 31 in South Carolina and a few in Louisiana and Vermont have started eradication work.

Michigan Appropriates Money.

Michigan seems to be leading in the amounts of money appropriated by county authorities to assist the federal government and the state in eradicating the disease.

To date the largest appropriation made by any county in the country is the \$15,000 fund voted by the county commissioners of Huron county, Michigan, according to available records. Other appropriations in Michigan are given as follows: Eaton county, \$8,000; Calhoun county, \$5,000; Oceana, \$4,000; Clinton, \$3,000; Muskegon, \$2,000, and Monroe, \$5,000. Hillsdale county, the first in the country to have all cattle tested, has made an additional appropriation of \$10,000.

North Carolina Follows Suit.

The board of supervisors in a number of counties in North Carolina have made appropriations to assist in fighting tuberculosis on the "area plan." Some Kentucky counties have used money for this purpose from the general tax levy. In Missouri, where a large number of counties are doing area work, the county courts appropriate money to assist in paying for animals slaughtered because of being infected with tuberculosis. Nebraska is also making long strides in the area work. California was one of the last states to enter into co-operative work with the agriculture department, but the work is now being carried on actively in two counties.

CHURCH ON WHEELS TAKES GOSPEL TO ISOLATED REGIONS

CHICAGO, Aug. 24.—A church on wheels—that is the latest religious innovation in this part of the country. It is an exhibition at Wilmette, a suburb of Chicago. It is one of the three chapel cars of the Catholic Church Extension Society, of which the Right Rev. Mr. Francis C. Kelly, of Chicago, is president.

Daily hundreds of Catholics and others visit the "church on wheels" and attend services.

The car, named the "St. Paul," is a combined church and rectory. Seating and kneeling accommodations are provided for fifty-four people; it has a permanent altar, a confessional, a library, a kitchen and quarters for the missionaries and attendants.

The Rev. E. J. McGuinness, L.L.D., is in charge of the car. It will remain at its present location for a week or two and will then be taken on a tour of the east to demonstrate to eastern Catholics the work that has been done elsewhere. The "church on wheels" has had four years of continuous service in Texas and Louisiana, carrying the ministrations of the church to Catholics isolated in some cases hundreds of miles from a Catholic church.

Thousands of Catholics, who have been unable to hear mass in years, have been located by the three chapel cars now in operation. The other two are known as the "St. Anthony" and the "St. Peter." All are under the supervision of the Extension Society. Almost limitless territory still awaits the visit of chapel car missionaries.

ILLINOIS TO HONOR LINCOLN'S MEMORY

FREEPORT, Ill., Aug. 24.—This city expects 50,000 visitors here on August 26 for the 64th anniversary of the famous Lincoln-Douglas debate on slavery.

Senator Pat Harrison, Mississippi's fiery democratic statesman, and Albert J. Beveridge, republican candidate from Indiana for the United States senate, are to be the speakers.

The gathering promises to be the biggest political meeting of the year in Illinois. Governor Len Small, Mayor William Hale Thompson and the political enemy of the two, Attorney-General William Brandegee, as well as all Illinois congressmen, members of the state assembly and former Governors Pifer, Dunne, Lowden and Deussen, will be invited to attend.

The historic debate took place here August 27, 1858, but as the 27th falls on Sunday this year the meeting has been advanced one day. More than 15,000 gathered that day to hear of the national problem—slavery—from the dominant political figures in the state.

"Can the people of a United States territory in a lawful way against the wishes of any citizen of the United States exclude slavery from its limits prior to the formation of a state constitution?" the Great Emancipator asked.

And Douglas replied: "The people of a territory can by lawful means exclude slavery from its limits prior to the formation of a state constitution. It matters not what the supreme court may hereafter decide, for the reason that slavery cannot exist unless it is supported by local police regulation."
