RADICAL MOVEMENTS.

The people who complain most bitterly about social and economic wrongs, frequently do a great deal themselves to create these wrongs of which they complain. A considerable element of people are working for some form of social revolution. They feel bitter about the disparities of wealth and the difficulties encountered by struggling people. They go about the country preaching discontent. Many of them say frankly that conditions must be worse before they are better. If disturbance and suffering were increased such ones would feel it was a gain, because it would augment discontent, and make it easier to promote political overturns. Such folks will urge wage earners to go on strikes when their grievances could be settled by arbitration. These strikes cut down the purchasing power of a mass of people. When all these idle workers stop buying, the factories and farms find less demand for their products. The result is to throw a lot more people out of employment and suffering and want spread over the country. Then these radicals will go around into centers where unemployment and want exist, of which needless labor troubles have been a leading cause, and talk about the necessity of overthrowing capitalism. They should go to Russia and learn what happens when a nation fails to give incentive to production by permitting people to retain the results of their own effort and ingenuity. It of course does little good to denounce these radicals, who are largely well meaning though misguided people. The thing to do is for every business man to be so kind and considerate toward those who work for him, so anxious to consider their welfare and work harmoniously with them, that mischief making talk will fall on deaf ears.

President Harding is to ask congress for a constitutional amendment stopping the issue of tax exempt securities. The sale of bonds and stocks bearing this privilege enables a multitude of wealthy people to avoid taxation, simply by paying a trifle more for their security. Also it encourages these folks to put their money into bonds based on municipal or state undertakings, when the same is needed more to develop the industries and resources of the country, so that labor can be kept employed and our national advantages utilized. The privilege of exemption from taxation ought not to be handed out as it has been, and all kinds of property should pay a fair share toward the costs of government. The proposition to cease extending this privilege ought to appeal to the mass of the people.

There is room for a great many more people in Douglas county than live here at present. It is, however, unwise to ask people to settle in the towns and villages where they will have no means of livelihood, but additional population is needed on the farms and to extend the orchard industry. More than that, every effort should be made to develop the lumber industry of this county. There are billions of feet of merchantable timber here that is ready for the logger and saw mill. The industry would furnish employment for thousands of men, and a pay roll in keeping with the vast amount of timber awaiting the saw here would of necessity build up the cities and towns to a remarkable degree. So, after all, it is a pay roll that we must have to bring the expansion that everybody hopes for.

Mrs. Clara Phillips, the hammer "expert" who killed Mrs. Alberta Meadows at Los Angeles, is now credited with a "weak mind," having only the "mentality of a child," according to her attorney. The deed she committed would make any normal woman's mind a little unbalanced and we don't wonder that her counsel is taking advantage of the insanity dodge to clear her of the terrible crime charged against her.

That the United States government will not be officially represented at the Near East parley soon to be held in Lausanne, is stated from Washington. That is just as it should be. The less this country has to do with old world quarrels the less trouble will the government have.

We sincerely hope there will be no mud-slinging among local candidates before election day closes. Candidates for state offices should be given all the "glory" for this much regretted lot of political bunk spread about the state.

Next Sunday is "Forget-Me-Not Day." Candidates at the coming election should have had the date changed to Tuesday, November 7. That's the day most people have a lapse of memory.

It does not occur always when you advertise for something that you get it delivered to your front door the next morning. Thank you, boys, for your expediency.

The man whose name appears on the official ballot as the republican-democratic nominee, is the only fellow who has no worry over the final outcome.

GAS CONSUMPTION LAST YEAR BROKE RECORD.

(International News Service.)
 NEW YORK, Nov. 1.—Sales of manufactured gas last year touched the record volume of \$26,000,000,000 cubic feet, an increase of 7,000,000,000 feet over 1920 and 20,000,000,000 feet over 1919, according to the third annual survey of the gas utilities of the U. S. just completed by the American Gas Association. An analysis of the per capita consumption of gas for the last 20 years shows that the per capita increase for the 10 year period of 1901 to 1911 was 30 per cent, while for the period of 1911 to 1921 it was 80 per cent.

Another "13" in Brumfield Case

Records in the office of the auditor of King county, Washington, show that Mrs. Merle Brumfield, under the name of Berestord, and Howard Mozena, were married there on Sept. 25 just 13 days after Brumfield committed suicide and thus another "13" is added to the long succession in the famous Brumfield case. It is a peculiar coincidence that 13 figures so prominently throughout the entire case and it appears that the jinx will hold good and another 13 has been added to the chronology of the case. The marriage license was issued on Sept. 26, 13 days after Brumfield hung himself in the state penitentiary upon the same day, according to the records. The marriage return was filed on Sept. 29, three days later.

The marriage was performed by Rev. W. H. Bliss, rector of Trinity Episcopal church, with Vernita F. McClure and William H. Walker as witnesses. Vernita McClure who acted as one of the witnesses was formerly Vernita Eilenburg and was a nurse in this city and was a close friend of the Brumfields and accompanied Mrs. Mozena on her recent trip through this city.

Immediately after returning to Roseburg Mr. Neuner shipped a box of prunes to Mr. Langer and these were placed on the restaurant menu and were in such demand that they were quickly exhausted and an order placed for an additional 100 pounds. Today Mr. Neuner received a telegram asking for the immediate shipment of 500 pounds of choice Umpqua valley prunes and these are being forwarded as soon as they can be packed. Only the largest sizes will be sent.
