ACCEPTING THE SITUATION.

One of the best traits of the American people is the calmness and good nature with which they accept the results of elections. It is not considered good form for defeated candidates and their supporters to show feeling. They are supposed to take a licking as good sports, and to turn up the next day with a smile. The average man whose party was beaten reflects that things seem to go on a good deal the same, no matter which crowd runs things. While he feels disappointed that the majority could not agree with him, yet he admits that his party must have made mistakes, alienated independent voters, or it would not have encountered the adverse verdict. There is lacking the sullen spirit that keeps many foreign countries seething after an election, with masses of inflammable people waiting for some firebrand to come along and apply the torch of revolt. Also the statesmen never act in an extreme way in public office as they feel in their hearts. If a conservative element wins, they recognize the power of progressive movements, and modify their policies to attract some of those who are demanding experiments and changes. And if a radical party wins, they are apt to be sobered by the responsibilities of power. They discover that it is quite a different thing to sit on the side lines and criticize, and get in themselves and make the complicated machine of business and economics work smoothly. So although the politicians are always prophesying that the nation will go to smash unless they are chosen to save it, yet the country jogs along fairly well, no matter who runs it. The people who are elected to office know that they must get results or they will be thrown out. They do not defy the will of the people after the people find out what they want.

The politicians are busy "lining up" things for the 1923 session of the Oregon legislature. But this little occurrence does not interest the public, regardless of the fact that the law-makers of the state are a bigger factor in state government than the governor himself. If half the interest were shown in the election of representatives to the legislature as was given the gubernatorial race there would be some likelihood of reaching a climax in tax reduction. Fortunately, Douglas county is represented by a set of men who may be depended upon to give their best in the way of economy and general conservatism. Several other counties in the state were not so fortunate in the recent election.

Commenting on the reason for not issuing a daily edition on Armistice Day the Corvallis-Gazette Times gives the following summary which is quite appropriate and in keeping with the average daily newspaper of this state: "The Gazette-Times regrets to miss any issue, perhaps more than any reader regrets missing the perusal of its columns, and has not much doubt that the readers will stand the lapse with more composure than the publishers. These are days of hard figuring with newspapers all over the country, for not only do prices of labor remain the same or get higher, but print paper is again on the increase and contracts hard to make at any price, the market being so uncertain."

When Walter Pierce, governor-elect, assumes charge of state affairs he should not overlook the fact when signaling out office appointments that his election was not wholly due to the democratic party. In fact, it was put over by the republicans of the state, cooperating with the democrats. Therefore, if he acts wisely, he will distribute state patronage accordingly. By so doing Mr. Pierce will have a combination of state employes not altogether one-sided that will go a long way toward harmonizing things generally. Such a procedure, while entirely out of the ordinary in this state, is worth trying out, now that Oregon is "taking on" every new wrinkle under the sun.

Political prognosticators now have it summed up that the election to be staged in 1924 is going to be a "wet" and "dry" fight. Now, if Oregon continues to keep some of the issues alive until 1924 that were dominant factors to stir up strife in the recent state election every voter will go to the polls with his finger on the trigger.

The "earmark" of moonshine have been quite conspicuous in our midst the past few days. Living examples of the result of imbibing too freely in the poison liquid were exhibited frequently during Saturday and Sunday. The dope sure gives the patient a glassy stare and haggard appearance—with the "morning after" symptoms thrown in.

Oregon Wins Game on Armistice Day

EUGENE, Nov. 11.—After being outplayed in the first quarter, the Oregon team came back strong in the second period of their game with Washington State college and launched a powerful attack that wound up across the Washington State goal line, the lemon yellows scored again in the final period and the final count was Oregon 13, W. S. C. 9. Throughout the rest of the game the lemon yellow consistently outplayed the visitors and though the Cougars looked formidable in the first period the Oregon goal line was never in danger from the opening of the second quarter.

Once the attack got under way the Oregon backs marched steadily thru the Cougar line. The Lemon Yellow varsity made 242 yards from scrimmage against 127 for the visitors and 13 first downs against five for Washington State.

Four of the Cougar's first downs were made in the initial period and after that their offensive remained but a latent threat. In the third period Oregon took the ball on the 45 yard line on an exchange of punts and marched it straight to the Pullman goal only to be turned back within the five yard line and four downs to go. The Webfooters scored their final touchdown when the 4th quarter opened with half in Oregon's possession on the five yard line, Chapman smashing over on the first play.

With less than 20 minutes to go the Cougars unleashed a desperate aerial attack but it was unsuccessful and twice Oregon intercepted Cougar and attempt to forward pass themselves. The game ended with the ball in Oregon's possession in the Washington State territory with the Lemon Yellow backs tearing off steady yardage.

Circuit Court In Session Today

STATE SPENDS \$20,724

SALEM, Or., Nov. 10.—(Special) The state emergency board, at a special meeting held here today, created deficiency appropriations aggregating \$20,724.16.

The appropriations included \$5,000 additional money for the erection of a new dormitory at the state industrial school for girls, \$850 to care for the expenses of the supreme court and \$15,000 to meet the demands of state-aided institutions for the care of homeless, neglected and abused children, foundlings and indigent orphans.

The legislature appropriated \$150,000 for the support of the institutions caring for needy children two years ago, but this appropriation has been exhausted. Additional money for the supreme court was necessitated because of the employment of an additional stenographer at a salary of \$190 a month.

The emergency board a few weeks ago appropriated \$22,500 for the construction of the girls' school dormitory, but when bids were received it was found that this amount was not sufficient.

Contracts for the dormitory were entered into today. Tranchell and Porellus of Portland have been awarded the general construction work at a cost of \$30,650, while C. C. Inman of Silverton will install the heating plant at a cost of \$2418. Theodore Barr received the contract for the plumbing at a cost of \$2300.

Work on the structure probably will start within the next few weeks. The new building will replace the dormitory which burned last summer.
