NATIONAL EDUCATION WEEK

A drive for educational progress has been planned for the week of December 3 to 9, by the United States bureau of education, National Education association, and the American Legion. It is hoped that one result will be a public realization that more money must be spent on public schools. The mere mention of such a distasteful subject makes the taxpayer squirm. However, the facts should be looked in the face. It was revealed at the army camps during the war that nearly one-fourth of the young men were illiterate to some degree. With so many un-Americanized citizens, many things must go wrong; unfit men will get elected to office, and government will be costly and inefficient. What can the schools do to help these conditions? Some of the faults of our educational system could be remedied without much increased expense. More practical instruction for boys and girls who do not learn easily from books, would wake up some sleepy and backward students and give them a better start. What is needed more than anything else is to keep children longer in school. Results will be unsatisfactory so long as a great mass of youngsters quit when they finish the grammar grades or before that time. American communities must wake up and try to find out if the schools are really educating the children for practical life, and if they are turning out good citizens; and if not, why not. Public opposition to modern educational ideas and parsimony in school appropriations do more harm than faults in the teaching system. National Education week will do good if it arouses some communities to take a greater interest in their schools and make more effort to find out what they are doing. American institutions are built on successful education, and you can't have good government without it.

Schools to Observe Educational Work

Schools throughout Douglas county will observe Education week from Dec. 3 to Dec. 9. A uniform program is to be carried out throughout the entire county and some very interesting topics have been suggested by County School Superintendent O. C. Brown, who is sending out the following letter to all teachers in the county.

The week from December 3rd to December 9th, 1922, has been set aside for Educational Week by the National Educational department. The idea grew out of plans of the American Legion for the development of better American citizenship, and Star Spangled Banner. Universities who have come to the United States to live.

The purpose is to awaken greater interest on the part of the public in education, especially as it develops American citizenship and patriotism.

Every teacher in Douglas county should be sure to have the flag over the school house during the week. If anything is the matter with the flag or the pole have the repairs made before December 3. Take this matter up with your board if you need their help.

The following subjects for each day of the week should be taken up during morning exercises, and also emphasized by working into the language, history, and civics classes during the day:

Monday—Patriotism Day. The flag, the emblem of freedom. Music as a nation builder. Sing America and Star Spangled Banner. Universal use of the English language in United States. Tuesday—American

Citizenship Day. Children today, citizens tomorrow. Naturalization for all men and women. Help the immigrants to become Americans. The duties of citizenship.

Wednesday—School and Teacher Day. The necessity of schools. The teacher as a nation builder. The school's influence on the coming generation. America as an educated nation.

Thursday—Illiteracy Day. Illiteracy as a blot on our nation. No literacy by 1927. How can it be done? A citizen's duty toward the uneducated. No immigration until illiteracy among native and foreign born is removed.

Friday—Equality of opportunity and physical education. Equality of opportunity in education for every American boy and girl. Rural schools, city schools, high schools, colleges. American institutions. Play grounds. Physical education and hygiene. The country's need in conservation and development of forests, soil, roads, water power, and other resources.

RED CROSS ROLL
CALL IS NOW ON

Every Community In America
Is Pledging to the Red
Cross This Week.

WANTS GOOD RESPONSE

Meeting To Be Held Wednesday To
Determine Upon Activities To Be
Undertaken Locally This
Year.

This month in every city, town and village in America men and women are renewing their annual membership in the American Red Cross. There is hardly a citizen of Douglas county that will refuse to sign their names for annual memberships if we can only secure sufficient workers for a period of two hours to assist in this work. In Pittsburgh, Pa., over 1500 people attended a Red Cross gathering and gave their time and efforts to their annual campaign. Coming nearer home we find Bend raising \$3900, Astoria nearly \$3000, and other counties from \$2500 to \$3000, to take care of the poor during the coming winter. Is Roseburg going to be a slacker? We think not.

Nineteen centuries ago the Master gathered a handful of disciples around him and enunciated to them the new rule which was left to stand for the guidance of those who aspired to greatness upon the earth. Down through the centuries and to our day we are called upon to go out in the by-ways and highways and take care of the needy and relieve their distress, and the Red Cross in Douglas county, which is your Red Cross and your money, is doing this work.

Wherever war has set its crushing heel, disease, pestilence, fire, flood, or other calamities have overtaken nation, city or town, or even a family, the Red Cross is now going and is supplying with the money you contribute, their immediate necessities.

It is your money and you are the Red Cross, and you are asked to meet with Miss Agnes Pitchford at the Chamber of Commerce rooms this Wednesday, November 29th, at 4 o'clock to determine whether the Red Cross activities and the relief work that it is now doing is to continue during the coming winter.

Public spirited men and women in every city in the United States are giving of their time and energies as never before to help gather in the money in order that all might be prepared to meet the call when it comes, and not wait until after famine, distress and death have overtaken our people.

There is hardly a spot in Douglas county that has not received more than its quota back in supplies to a needy family. Clothing, shoes, underwear, and milk have been supplied through our social service worker and the methods under which we are now operating. Is this work to stop?

We ask that public spirited men and women of Roseburg and vicinity attend this meeting and be willing to give at least one or two hours of their time in order that they might be prepared and able to meet the constant needs that are upon us. It is inconceivable that anyone will be silent and fail to respond when they are properly approached, but we need workers. Will you be one of them? Every church, lodge and civic organization in Roseburg should have a representative at this meeting without further personal solicitation.
