PRUNE SITUATION DISCUSSED

Roseburg, Oregon, Jan. 10, 1924.

Editor News-Review:

Having been asked by various growers at different times concerning the outlook of the prune situation from the standpoint of a member of the Oregon Growers Cooperative association, I would appreciate the privilege of stating my views in your paper. At the present time, I would say the prune situation in the Northwest is at a low ebb largely from lack of organization.

If prune growers as a whole had been thoroughly organized the past three or four years, we would not be in the plight we are in today. Many people knock the Oregon Growers association, and yet the Oregon and Washington Growers associations have demonstrated beyond a doubt what proper advertising and handling can do for our prunes. In 1922 the two associations handled in round numbers 28,000,000 pounds of prunes, nearly half the crop in the northwest, they were advertised and sold under and in brand and most of them were out of the way of the 1923 crop.

Now, the question comes why do they not move the 1923 crop faster? The reason is, only a part of the 1922 crop, not in the hands of the associations, had been sold by other packers, and remained a menace to the disposal of the new crop and has kept the market unsettled. To make a long story short, much has been said about the means of consolidating the prune
