

REPUBLICAN NATIONAL CONVENTION OPENS

(continued from page one)

called the convention to order promptly at 11 o'clock. John Philip Souza, the march king, from a place on the speaker's stand, led the band which took places on the floor and played the Star Spangled Banner.

At the conclusion of the march, Bishop Anderson offered prayer while the convention stood.

At the conclusion of the prayer the convention remained standing and sang two verses of America.

Then the official photograph of the convention was taken. The cameras were placed in the rear of the hall. The photographer had the job of inducing a couple of thousand delegates and alternates to turn around in their chairs. The convention managers did a little more conferring. William M. Butler, the new political general, took a place at the platform rail and calmly and carefully looked over the assemblage. He had the air of a general looking over his troops.

Secretary Lockwood of the national committee got the first applause of the convention when he stepped forward to read the official call for the convention.

Former Governor Grosbeck of Michigan sent word to chairman Adams that he did not wish to serve on the platform committee and asked that A. T. Roberts be placed there instead.

Chairman Adams then addressed the convention, saying:

"This is the eighteenth republican national convention.

"It is only sixty years since Lincoln was president. In that brief period our country has founded the greatest moral and material advancement in all history.

"This has been brought about largely under republican rule. And at no time have the problems of government been more effectively met than during the last three years.

"Our party has always stood for constructive progress. It has always endeavored to promote the welfare of the average man. It has always adhered to America's best traditions both in domestic and foreign affairs.

"Today, Europe is torn by class cleavage and hatred which threatens every social order. America, alone, in the great family of nations, is united and stable, prosperous and free and at peace with all the world.

"We are here, now, to pledge anew our faith in American institutions and to name the next president and vice-president of the United States."

Chairman Adams made a picturesque figure with his shock of snow-white hair.

Mr. Adams, then proposed Representative Burton of Ohio, for temporary chairman, amid a burst of applause led by the Ohio delegation and visitors.

In the hurry and modesty of getting it over with, chairman Adams forgot to put a vote to the convention on the selection of Mr. Burton until after he had appointed the committee to select him to the chair.

Smilingly, Mr. Adams returned to the front of the platform and put the vote which was carried with a rolling chorus of ayes and much laughter.

Chairman Burton moved about a bit during his delivery and at times got away from the microphone which was carrying out by radio to many millions of listeners the proceedings of the convention. If anybody missed some of the speech it was not static, rather, Burton.

There was applause, when the chairman referred to the participation of the women in the convention but it seemed to come especially from the women.

As Mr. Burton proceeded, alternately reading from his manuscript

and then speaking extemporaneously, a rate which indicated that it would take him probably an hour and a half or a little less, applause punctuated his remarks. There was one burst when the chairman said it was to be regretted that the president was not given time to take up the matter of Japanese exclusion by diplomatic negotiation before the exclusion act was passed.

The first prolonged cheering and applause came when the chairman declared:

"The republican party stands now, as always, for law enforcement."

The statement plainly was construed by the audience as referring to the enforcement of the prohibition laws.

Mr. Burton drew more applause in his remarks concerning conservation of natural resources. He did not mention Muscle Shoals nor Henry Ford by name, but he did say "no hundred year franchises should be given." The delegates got the point and applauded.

There was more prolonged applause and cheering when the chairman, referring to the recent congressional investigations at Washington, condemned in strong terms character assassinations, rumors and the like.

Guilt, he said, should be punished and that it was important that the innocent should be protected. He disclaimed any reflection on any investigator seeking to expose crime or delinquency in good faith. His declaration that the republican party stood firm "as a rock" for punishment of the guilty regardless of party, brought more applause.

There were more cheers for the chairman's declaration for party solidarity and his call for a republican congress "made up of members tried and true who will stand united."

That brought out the first real demonstration. Delegates rose to their feet cheering and waving hats and handkerchiefs. Many of them turned to the Wisconsin delegation where the La Follette delegates remained silent without taking part in the demonstration. There were cries of "Stand Up Wisconsin" and one delegate stood up. The first mention of President Coolidge's name brought out a new demonstration which approached the fervor of the previous one. Speaker Gillette of Massachusetts sprang to his feet and Senator Lodge rose beside him.

The demonstration subsided in a moment but was renewed when the chairman declared "the people have chosen in Calvin Coolidge" and his further statement that "others may have lost their nerve; Calvin Coolidge has not lost his."

When the chairman, speaking of the league of nations declared "it is not for us," there was another outburst of applause and more applause when he said he judged the sentiment of the American people was against cancellation of the foreign debts.

Chairman Burton finished just after one o'clock, having spoken an hour and a half and the convention responded with a demonstration of applause and a prolonged cheering to his prediction of party victory in November.

The applause over, chairman Burton took up the further business of perfecting the temporary organization. Chairman Adams of the national committee introduced Secretary "Lafe" Gleason of New York, who presented the roll of temporary officers for the convention. They were approved.

The organization proceedings were then interrupted for a moment while a gavel was presented made of oak from one of the great trees where the first republican convention was held. Another gavel was presented made from a part of one of the beams on the Ohio canal where Garfield worked once as a canal boy. After disposing of more organization proceedings the chairman

recognized Secretary Mellon who got as great a demonstration as had yet been seen. Secretary Mellon was escorted to the platform amid prolonged cheers and applause.

Secretary Mellon spoke so softly that chairman Burton repeated his words which were to offer a resolution creating the platform committee.

The resolution was adopted without dissent.

The reading clerk then read the names of those elected to the platform committee and called the names of some of the vice-presidential candidates.

Addison G. Proctor of St. Joseph, Mo., 86 years, was invited to the platform by the chairman. Mr. Proctor, the chairman told the convention, was the last survivor of the 466 delegates in the convention that nominated Lincoln.

Mr. Proctor was invited to make a speech and soon got to reminiscing about Lincoln at such length that the clerk had to remind him he was under a five minute limit.

The members of the union league of Youngstown, Ohio, then lined up in front of the speakers platform to sing a song.

CLEVELAND, June 10.—Fighting to prevent the incorporation in the republican national platform of a light wine and beer plank, a section of prohibition advocates met today to draft a dry plank for submission to the resolutions committee. Acting independently of the anti-saloon league, Clinton N. Howard, representing the National Reform Association, Rev. Charles Carlisle of the Moral Welfare Board of the Presbyterian church, Robert Watson, appearing for the World Prohibition Federation, and Canon Chase, representing the New York Civic League, began work drafting a dry plank which they will urge. They will present a similar plank to the democratic national convention in New York City.

In the tentative draft prepared by Canon Chase opposition is declared to oppose any change in the Volstead act. A light wine and beer amendment, would, the draft declared, increase the difficulties of law enforcement.

The preamble of the resolution denounces the corruption which it asserts is incident to the present methods of prohibition enforcement, asserting that the new methods are necessary "to protect the public welfare from those officials whose duties put them in special danger of betraying the commonwealth."

CLEVELAND, June 10.—Frank O. Lowden, former governor of Illinois, has sent a sealed letter to Cleveland to be opened and read to the republican national convention in event he is given nomination for the vice-presidency.

The letter is understood to be a reiteration, formal and final that Mr. Lowden will not accept the nomination even if tendered him and after his receipt some of those who had hoped he would yield to an overwhelming convention demand declared they believed the former Illinois governor to be irrevocably out of consideration.

CLEVELAND, June 10.—Half an hour after the convention adjourned, the resolutions committee began an open hearing to receive suggestions as to the platform. Charles B. Warren of Michigan, was elected chairman of the committee and Ogden Mills of New York, secretary. The full committee decided to conduct the hearing rather than to have a sub-committee proceed at once to the drafting of a platform.

Mr. Warren said opportunity would be given all to be heard even if a session through the night is required.

Arguments in favor of a plank declaring against such organizations as the Ku Klux Klan were presented by Dr. Charles F. Thwing, president Emeritus of Western Reserve University, former Representative Isaac Siegel of New York and William Liberman, a delegate from New York.

Avoiding direct reference to the Klan they declared there was no place in the United States for societies which tended to stir up race, creed or color antagonism.

A stand against the Klan also was urged by Bishop A. J. Carey of Chicago, heading a delegation of Negroes, who in addition, advocated strict enforcement of the fourteenth and fifteenth amendments.

Disfranchisement of Negroes in the south was deplored also by Dr. George E. Cannon of New Jersey, who declared the republican party should see to it that Negroes everywhere be permitted to vote.

Richmond Pierson Hobson, who gained fame in the Spanish war and later served in congress, urged a tightening of laws regulating the use of narcotics.

Representative Cooper of Wisconsin, designated to present the insurgent republican platform proposals drafted by Senator Robert M. La Follette, asked if he might make the presentation before the committee in executive session. He was assured by chairman Warren that he would be given an opportunity to do so.

American Federation of Labor officials, acting for Samuel Gompers, distributed copies of "labors proposals" to the committee men.

LATE WIRE NEWS

MORGAN CITY, La., June 10.—William Learsch, 22, messenger for a brokerage concern in New York, walked into a bank here today, deposited \$45,000 worth of negotiable bonds and told how he was kidnapped by bandits in New York a week or ten days ago and how he had managed to recover the loot.

TOKIO, June 10.—Personnel of the new Japanese cabinet, headed by Viscount Taka Aki Kato and composed of Representatives of the three parties opposing former Premier Kijoura, was announced tonight.

The new government will be inaugurated tomorrow morning.

PORTLAND, June 10.—Approximately 2,000 members of the Oregon national guard entrained today and started for Camp Lewis for the summer encampment. They will return June 21.

Company and unit heads say a larger percentage of enlisted personnel is making the trip than ever before.

Four trainloads of soldiers and supplies are making the trip.

NEW YORK, June 10.—Robert Legendre of the Newark A. C. former inter-collegiate champion, today captured the final Olympic tryout from a trackfield of all-round stars.

Legendre finished first in three of the five events contested, the javelin, discus and broad jump and had a minimum total of ten points for his performances.

NEW YORK, June 10.—Conditions are becoming "increasingly serious" in the Kwansei province of China, where one American missionary is known to have been killed and several others are in danger, the Christian and Missionary Alliance was informed in a cablegram today from the Rev. R. A. Jeffrey, who was recently released by Chinese brigands. Definite confirmation of reports that Rev. Cunningham of Salem, Va., had been killed was contained in the cablegram.

SALEM, June 10.—James Anderson and G. C. Patterson have applied to the supreme court for permission to practice law in Oregon, the former on a certificate from the state of New York and the latter on a Utah certificate.

Anderson is now located at Marshfield and Patterson in Portland.

SALEM, June 10.—Pending appeal in the supreme court, Portland city officials are restrained, by an order signed by Chief Justice McBride today, from enforcing against M. George and others a city ordinance prohibiting foreigners from selling soft drinks. The plaintiffs lost in the lower court for Multnomah county and appealed. The case will test out the validity of the ordinance.

SALEM, June 10.—Harry and Alex Goldstein, Portland, second hand dealers, must serve their sentences of two and two and one half years in the state penitentiary for receiving stolen property. Governor Pierce announced today that he refused to interfere with the judgment of the courts where the case has been pending for four years. He declared he had considered the case carefully.

Wealthy Portland citizens, he said, intervened in behalf of the two men.

CHICAGO, June 10.—Former Governor Frank O. Lowden of Illinois passed through Chicago today enroute to his farm at Oregon, Illinois, and told friends that his determination not to run for vice-president was unalterable.

SEATTLE, June 10.—Police dragging the Lake Washington Canal today found the body of Miss Wilma Talmage near the campus of the University of Washington.

A canoe in which Miss Talmage, whose home is in Roseland, B. C., and Norman B. Strickland of Middlesex, N. C., a senior at the university went upon Lake Washington last night floated ashore in the canal without them. In the overturned canoe were Strickland's coat and vest and a vanity case. Strickland's body has not yet been found.

PORTLAND, June 10.—The Oregon wheat crop will most likely be less than 40 per cent of a normal crop, says F. L. Kent, agricultural statistician, in a bulletin today.

Weather conditions during the month of May caused a further reduction in the condition of all growing crops from the below normal condition of May 1. Dry hot winds, and practically no precipitation throughout the month brought about a situation on June 1 in which the condition of all crops was the lowest in many years. Local showers early in June afforded some relief in a few localities but generally speaking the whole state, as well as the whole Pacific coast is experiencing the driest spring and early summer known to the "varliest inhabitant."

Plant 76,000,000 Years Old

The horsetail rush or its ancestors dates back some 76,000,000 years, to the day when the world was uninhabited by human life. It is one of the ten species of the sole genus of plants that has survived from the carboniferous era, when its forefathers reared their majestic heads to a height of ninety feet and more on stumps six feet thick. The plants of this era ceased growing many millions of years ago, when the world was swept by oceans which buried forests, but for more than half a century they have provided the greatest agent of modern industrial development and have been the bone of contention under the atlas of coal, in many a federal investigation. It has the oldest genealogy of any living thing.—Detroit News.

Odd Formations Found in the "Hoodoo Region"

The Hoodoo region, near the head of Miller creek, beyond the east boundary of Yellowstone National park, is said to furnish probably the most striking example in existence of the effects of erosion and wind action upon masses of moderately solid rock. The region was discovered by miners in 1870, and was first explored and reported upon by Col. Norris in 1880, who thus described it:

"Nearly every form, animate or inanimate, real or chimerical, ever actually seen or conjured by the imagination, may here be observed. Language does not suffice to describe these peculiar formations; sketches may probably do something, and photographs more, to convey a conception of their remarkable character, but actual observation is necessary to adequately impress the mind with the weird security appearance of these eroded hoodoos of the hoodoo land. These hoodoos are from 50 to 200 or 300 feet in height, with narrow, tortuous passages between them, which sometimes are tunnels through permanent snow or ice fields, where the highest sheep hide in safety; while the ceaseless but ever changing moans of the wild winds seem to haunt fitting repurgations to these ghastly monuments of the legendary hoodoo gods."
