### BLASTING FALLS MEETS OPPOSITION

Sportsmen of this vicinity are up in arms as the result of an announcement made by members of the commercial fish commission that a passageway is to be blown in the falls at Smith river in order to allow salmon through for spawning.

Various agencies and organizations which have the recreational advantages of the community at heart, have been concerting their efforts to prevent fulfillment of such a plan is possible. With powder on the ground to blast with, through the good graces of Governor Pierce, blasting at the falls has been postponed until a hearing is given.

Opponents of the project to blast a pass through the falls at Smith River claim that to make such a pass would not benefit the fishing industry one iota. It is pointed out that the river bed above the falls is all rocky and therefore not feasible for a spawning ground.

Damage to game fishing above the falls, which at present is the best in the state is feared if a pass is opened at the Smith river falls. It is pointed out that chubs, states and salmon if allowed to pass above the falls, will soon spoil the excellent cut-throat trout fishing.—Port Umpqua Courier.
