DELEGATES FREED ON 83RD BALLOT

presidential candidates the vote includes:

- Arizona 6—years 5; days 1.
- California 26—years 26.
- Idaho 8—years—8.
- Nevada 6—years 6.
- Oregon 10—years—10.
- Washington 14—years 14.
- Alaska 6—years 6.
- Hawaii 6—years 6.

There was a strong effort in the Iowa delegation to switch the vote of that state from McAdoo to E. T. Meredith, former Secretary of Agriculture. Some member of the delegation predicted that the change would be immediately. Between the 80th and 81st ballots a motion to adjourn until 7:30 p. m. was voted down and the clerk went on with the next call.

The state of mind and the state of near exhaustion which affects almost everybody in the convention was illustrated by the 81st ballot when the announcer in the Michigan delegation announced 32 votes—two more than the state has. "You have cast too many votes," said the clerk.

"Then take two away from Senator Ferris," replied the delegate. "I'm so groggy I can't count 'em." The McAdoo people passed the word that Mr. McAdoo wanted all his people to vote for the resolution as he did not wish to appear as an obstructionist. The result was that the votes in favor of the movement tumbled in so fast that its passage was assured before the roll call was half over. The effect of releasing delegates from instructions and pledges, while retaining the unit rule and the two thirds rule, will be developed in the balloting immediately.

There are delegates in the convention instructed by state primaries who say they are ready to change their votes.

The vote on the motion by Mr. Gilchrist was 98 1/2 in its favor and 105 against it and 8 not voting. It was 258 more than required to pass it.

Chairman Walsh stated his interpretation of the resolution. It doesn't abrogate the unit rule, which prevails wherever it was ordered. It merely expresses the sense of the convention that instructions and pledges are and ought not longer to be binding. The idea being that when instructions and pledges were given it was anticipated that nomination would be made in a reasonable time and a reasonable number of ballots.

No delegate, the chairman said, would be subject to legitimate criticism for now changing his vote if he wished to do so.

Still divided into non-majority groups, the democratic national convention returned today to its task of selecting a presidential nominee with its course undecided.

Its first business was to receive a report from permanent Chairman Walsh and National Committee members on their conferences with representatives of the 16 aspirants for the presidential nomination. The report as drafted contained the declaration signed by all of the candidates excepting Wm. G. McAdoo, releasing their delegates unconditionally and also the declaration of Mr. McAdoo releasing his delegates conditionally upon abrogation of the unit and two thirds rules and on agreement for progressive elimination of minor candidates.

The report was the sole accomplishment of the week end conference conducted by Chairman Walsh and Hull and opinion differed as to whether it represented any accomplishment at all.

Some of the McAdoo people went into the session believing that little had been accomplished and that after a parliamentary wrangle the situation would revert to the status of Saturday.

Norman E. Mack, one of the floor managers for Governor Smith, said he saw no change in the situation except that he believed that some of the McAdoo delegations were showing signs of disintegration. The Smith forces, he said, were standing firm. McAdoo leaders expressed the same sentiments in reverse fashion. All sorts of opinions were expressed as the delegates assembled. The most favorite was the one that was that it was going to be a boiling hot. The many canvasses conducted on the floor to find out where the favorite son delegates were going developed only that, although released from pledges, the sentiment of the individual delegates seemed to be to stand with their native sons.

SOCIALISTS ARE FACING CONFLICT

Reports Submitted to Convention in Cleveland Conflict on Will of Party.

REPORTS ARE MADE

Six Distinct Recommendations Made for Formation of Party Which Majority Claims is Organized.

(Associated Press Leased Wire.)

CLEVELAND, Ohio, July 7.—Faced with conflicting reports, one recommending endorsement of Senator Robert M. La Follette, as a presidential candidate on his platform and the other calling for nomination of a separate party ticket on its own platform the national convention of the party today plunged into a long debate on the subject.

The La Follette proponents numbered 13 of the committee members. His opponents were two.

The majority report held that the conference for progressive political action had to do with intent and purposes already established a new party. "Opposed to the old capitalistic parties" and recommended that the socialist party concur in its action and cooperate in the 1924 campaign.

The minority described La Follette as a "Life long republican" and declared the conference platform "one that might have been written by W. J. Bryan 20 years ago."

The convention disposed of some routine business while waiting for the committee of 15 to report, but the latter overshadowed all other affairs before the gathering. Immediately after receiving the two reports, the convention recessed for luncheon.

The committee report made six specific recommendations as follows: 1 That this convention concur in the endorsement by the conference by progressive political action of the presidential candidacy of Senator La Follette of the platform submitted by him.

2 That it authorize the incoming national executive committee to endorse the candidate of vice-president to be chosen as La Follette's running mate.

3 That the socialist party request for an increased representation on the enlarged national convention of the conference.

4 That in the coming campaign the socialist party cooperate with the conference in the national elections and in all such state and local elections in which the labor candidates are nominated with the cooperation of state and local socialist party organization.

5 That the socialist party send a full representation to the convention to be held in January, 1925, for the purpose of considering the formation of a permanent and independent new party.

6 That the representatives of the socialist party to the January convention call for the roll of the states for balloting.

Totals in the 78th ballot: McAdoo 511; Smith 363; Davis 73; Underwood 49; Glass 21; Ralston 5; Robinson 22; Ritchie 16; Walsh 6; Saulsbury 6; Ferris 17; Bryan 2; Gerard 1; Roosevelt 1. Totals 1,096. Absent 2.

The call of the roll went on for the 79th time. Then a resolution was offered by former Governor Gilchrist of Florida. It proposed that the rules be suspended for the adoption of a resolution which in turn would adopt the proposals embodied in the report of the conference on the over-Sunday negotiations.

The proceedings were held up for a moment while McAdoo leaders conferred on the platform. A delegate wanted the resolution read again, but it developed the official stenographer had disappeared with it.

The reading was postponed until the end of the next ballot.

The roll call developed little but a challenge of the vote of the Canal Zone six which had been voting for McAdoo under a unit rule.

On the poll three of the Panama Canal delegates cast their votes for McAdoo and three for Smith. The challenge contended that there was no unit rule imposed by the home convention and that the delegates should be permitted to vote their convictions. The chair had ruled last week that the delegation was voting as a unit.

E. M. Robinson of Ancon was given permission to address the convention.

Robinson argued that the delegates were bound to vote for McAdoo. Chairman Walsh reversed his previous ruling and ordered the Canal Zone vote recorded three for McAdoo and three for Smith.

Between ballots the convention heard an announcement that former Governor Campbell of Ohio was celebrating his 81st birthday. To his place in the Ohio delegation the Texas standard was carried with a bouquet attached to it.

Ed M. Seams of Oklahoma City, then offered a resolution proposing that it be expressed as the sense of the convention that the delegates vote on the next ballot only for the two leading candidates. John J. Fitzgerald of Brooklyn, objected and on a viva voce vote the "noes" had it overwhelmingly. Once more the majority of the convention expressed itself in favor of a prolonged fight.

With that the convention went

vention be instructed to vote and work for the formation of a new party, entirely distinct from the old parties, with complete national, state and local organizations and upon a platform containing as a minimum the planks adopted by the convention of the conference last Saturday.

In a preamble the convention told the socialist convention that the conference of last Friday and Saturday "representing about three million organized workers substantial sections of the working farmers, several independent progressive political organizations and the socialist party, adopted a progressive labor platform and took an independent step to cut loose from the old political parties."

CLEVELAND, Ohio, July 7.—Endorsement of the proposal that socialist convention nominate no presidential candidate was received by the gathering this afternoon from Eugene V. Debs, who is ill in a sanatorium at Elmhurst.

Gorilla Not Ferocious

Animal Long Pictured

Apparently the gorilla has been a much maligned beast. The old stories of his ferocity must have been all wrong, for now we are told on what seems to be indubitable authority that these biggest of apes are most sensitive creatures, and that the difficulty hitherto experienced in keeping them alive when captives was due to failure to treat them with the delicate consideration, without which they soon die of broken hearts.

What they really want is to be loved. Without that they fall into a lethargy of despair that passes for stupidity, but when the recipients of tender and delicate attentions they reveal the intelligence to be expected of man's nearest relations.

As Dr. Hornaday countenances these new characteristics of the gorilla nature, they cannot be ascribed to the ingenuity of overzealous press agents, as they are tempted to suspect who rather enjoyed—when at a safe distance—bearing about gun barrels broken over hairy arms, the threatening clash of monstrous teeth in preparation for attacks on lions and the beating of resonant breasts in the working of murderous rage.

But perhaps gorillas have changed and deteriorated since Du Chailu's day. That bold traveler and fine writer did not see them as pretty pets for ladies or as sufferers from any angioneuroses.—New York Times.

Rhinoceros Can Scent

Enemy Two Miles Off

Many animals give off scent through their feet. The bloodhound can "scent" his object many hours after it has passed.

Scent depends a great deal on atmospheric condition; on a sharp, dry day it does not "lay." On a muggy, still day, however, even human beings will scent a fox, as their odor sticks to surrounding objects, such as bushes and hedges.

Elephants have a wonderful sense of smell, either from breath or body, but the keenest-scented animal is undoubtedly the rhinoceros. One big game hunter has stated that in favorable conditions this animal can "wind" a man for two miles. This may be considered a tall order, but in Africa the atmosphere is wonderfully clear.

What is the explanation of dogs and cats finding their way back to their original homes after being taken many miles away? The explanation is believed to be "ether." Scent is conveyed to animals "on the wind" by this means.—Exchange.

April Fool

Many attempts have been made to account for "All Fool's day" or "April Fool day." The most satisfactory explanation seems to be as follows: Before the English changed their calendar in 1752 the legal year began March 25 instead of January 1. Most all of the feast days and festivals were originally celebrated eight days after New Year's day, March 25. It was therefore the day on which the New Year festivals reached the highest point and ended. The Roman festival known as the "Feast of Fools" on February 17 may have influenced April Fool, because on that day the Romans also played tricks and practical jokes. The Hindus have a spring festival on March 31. Some have tried to connect "All Fool's day" with the mock trial of Christ, but the connection is probably only imaginary.
