COUNCIL HOLDS LONG SESSION

Much Important Business Conducted and Routine Matters Considered.

WILL PAVE STREETS

Paving Ordinances Passed and Bids Accepted for Several Streets; New Petitions Are Presented.

The city council last night maintained its session until almost midnight, most of the time, however, being devoted to the purchase of fire apparatus. Prior to the opening of bids the council disposed of a great deal of important business.

The remonstrance of the Sisters of Mercy against the construction of a sidewalk along their property was read and laid on the table at the request of Attorney Compton. A remonstrance of a number of physicians was also submitted and the council was informed that residents who would be affected are also circulating a remonstrance and action was delayed until the latter objection is received.

The residents of Harvard Avenue asked for immediate action on the paving petition submitted by them and were assured by the council that such action would be taken at once. The petition has been held up while the street committee investigated the value of the property on the street. A report was given that the property is worth the paving and the ordinance providing for the paving was passed.

A communication from Lloyd Cole asking for action on the proposition submitted by Florence Alkin Danks for an ordinance restricting cats in order to protect the song birds, was read and placed on the table.

A petition for the paving of Parrott street between Lane and Oak was read and referred to the street committee for investigation.

An agreement between the contractors and residents of Glenn street to eliminate the intersection at Hamilton street and run the curb and sidewalk unbroken across the street was read. As Hamilton street is located on a high bank at the intersection with Glenn street and will never be opened the agreement was approved by the council.

The audit of G. Ed Ross who has been experting the city books was read. He found the books in good shape and complimented the city for the manner in which they have been kept and praised the system used. He made a number of suggestions which have been referred to the current expense and accounts committee.

It was reported that the excessive number of fires during the past two months had caused a deficit in the fire department funds of \$250. It was voted to appropriate \$250 to help the department over the existing difficulty.

The marshal was instructed to order property owners on East Douglas street to construct a stairway in place of the one now reported to be in a dangerous condition.

It was reported that Sheridan street merchants have been complaining of boys selling cherries at the trains. The council refused to take any action in the matter.

The Laurelwood paving ordinances were lifted and Chapman street, Madrone avenue, East avenue, and Spruce streets were ordered paved. The bids of L. W. Metzger for the paving of Haynes street in the sum of \$5,359, Harvard avenue, \$2,463.21, Liburn street \$2,842.76, and the construction of the Block 53 sewer in
