BUSINESS AND SPECULATION.

Business has been rushing on Wall street of late, which at least indicates that a lot of investors and business men have confidence in the future. Within reasonable limits, that is a fine thing. The business world can not accomplish satisfactory results unless there is a general faith in the future. As long as business men hang on to their dollars and refuse to take chances with them, industry will drag. It is well for people to have the speculative instinct to realize, however, that the insiders have a way of buying up stocks when they are a bargain, and after they have forced prices up to a high point, then the public is apt to come in with a rush and buy at high prices. When that point comes, many cautious operators have quietly realized on their profits, leaving the public in a shaky position. It is hard to draw the line where legitimate and necessary confidence ends, and a hazardous speculative spirit begins. Back in 1920, in the general field of trade, the majority of business men felt there was good ground for confidence in the future. The public seemed willing to absorb an indefinite quantity of goods at the extremely high prices then prevailing. So people bought merchandise far beyond their needs at high prices. All at once a wave of public reaction against prices swept over the country. Merchants found themselves loaded with goods that would not sell, and we all know the disastrous results. No one wants to spread a spirit of unjustified pessimism. Business ought to be very good from now on, if people can go slow on speculation, learn from the experiences of 1920 and 1921, and avoid the errors of that period. Those experiences are so recent that they will probably do so. This gives reason to hope that business will be good for several years, with work for all at fair wages.

WORKING FOR YOU EVERY DAY.

Lightning may be erratic and no one can tell whether it will strike, but printers' ink gets in its fine work every day and modern, progressive business men know it is a factor in making for success. A copy of The News-Review was read by Mrs. N. M. Kolkens, who lives in Hawaii, and like all well informed women she took care to read what Roseburg advertisers had to say. Among other messages from Roseburg merchants that was broadcasted in that issue, and regularly through the weeks that go and come, was one of Bubar Bros., local jewelers. That particular ad described a Cymbal chime clock, colonial design, made by the Seth Thomases people. The thing was so alluring and the price so seductive that Mrs. Kolkens immediately wrote to Bubar Bros. and enclosed an order for the timepiece, accompanying her order with a check covering the amount. That's what advertising does. A drop of printer's ink just keeps everlastingly on the job, pulling from the four winds for business—and gets it. Every business man has the choice of advertising for business or waiting. If he does not mind waiting and has the money to pay rents and support himself while he is waiting perhaps he can afford to keep silent. But if waiting in idleness gets irksome, call in the ad man, who is willing to help solve the problem. This little incident just coming to light is but one of the countless "pulls" that that business enjoys through advertising. Yes, it pays.

C. E. Ingalls, now serving Corvallis as postmaster, but prior to entering the services of Uncle Sam editor of the Corvallis Gazette-Times, is quoted in the Oregon Voter of this date on the subject, "Stanfield, Four Years Later." After a prelude covering a few inches of space, the Corvallis postmaster tells of a "love feud" he had with the junior senator quite recently, wherein the former pencil pusher had been won over and convinced of the great capabilities and other things that had been hung on Mr. Stanfield during his career as United States senator, and concludes with the following political bank: "We have an idea that those senatorial aspirants who have an eye to Stanfield's seat will find him a harder opponent in the primaries than they have been figuring on." This short sentence, when properly assimilated, means that the junior senator is going to go strong for the Corvallis postmaster for another term, and that the Corvallis postmaster is going the limit for Bob, both as a postmaster and part owner of the home town paper. All of which is fine stuff. But it will take more than a government employee and his newspaper strength to put the junior senator over at the next primary election. Mr. Stanfield's political fences are in bad shape for another term as United States senator, all glowing accounts to the contrary notwithstanding.

The merchants of Roseburg have prepared for the holiday trade more thoroughly than ever before, and it seems only fair to them to do our buying at home. It makes a big difference to them, after they have shown all the enterprise that is involved in buying big stocks of holiday and winter stuff, whether or not they get the business of their home community and the near by territory. If many of our people go or send to other centers and distant cities for the goods wanted at this season, it is a pretty poor recognition of the good business spirit our home merchants show. Let us back them up, remembering that out of every dollar we spend here, a large part remains to build up the prosperity of our own city.

Present and future needs must receive the attention of the people of this school district at this time, otherwise one of the greatest assets of the community will be in jeopardy.

OS WEST SELLS INTEREST IN CO.

PORTLAND, Or., Nov. 29.—Oswald West has sold his controlling interest in the North Canal company to W. H. Wehring and associates, so announced today.

The North Canal company is undertaking reclamation of 20,000 acres of land near Bend and Redmond. The company owns a dam across the Deschutes river near Bend, where the water for irrigation is diverted from the river through the north canal to the land which it is proposed to irrigate. The north canal is now constructed for a distance of one and one-half miles, and about three miles or additional canal must be built before the boundaries of the tract are reached. The company has recently constructed a dam at Crane prairie for storage purposes.

The reservoir as now constructed holds about 50,000 acre feet and when the dam is built to its proposed height, the reservoir will hold more than 50,000 acre feet. This stored water will be released during the irrigation season and used to supplement the flow of the Deschutes river. The construction of the canal and distribution system had been delayed until the Crane prairie reservoir had been tested and the adjudication of the waters of the Deschutes river had been undertaken by the state water board.

These matters being now out of the way, it is the intention of those who have purchased control of the company to prosecute the construction work as rapidly as circumstances and conditions will permit, said West in his announcement.

LAST INSTALLMENT OF TAX COLLECTED

(Associated Press Leased Wire.)
SALEM, Or., Nov. 29.—State Tax Commissioner Earl Fisher is preparing to send out notices for the collection of fourth installments of income taxes from individuals, corporations and partnerships that have chosen to pay by the installment plan. About 4,000 notices will be sent out as a result of a recent opinion of Attorney General Van Winkle holding that the unpaid portions of the income tax can be collected notwithstanding the repeal of the act at the election of November 4.

It is presumed that some one will seek to enjoin the state from the collection of the taxes, since the Attorney General in his opinion suggested that there should be a supreme court opinion on the question. If the state is successful in making the collection the additional revenue derived from that source is expected to run from \$600,000 to \$700,000.

Although the law provides that fourth installments must be paid by December 10, Mr. Fisher said that he does not expect his department to finish its work before February or March of the coming year.

The judge, however, stipulated that the sentences should run concurrently so that the maximum actual sentence to be served by each of 25 years.

NEW RADIO RECORD

MORE SPOOK STUFF GRABBED IN RAID

SAN FRANCISCO, Nov. 29.—The district attorney's office had before it today additional evidence in the case of ordination certificates, crystal gazing sets and other paraphernalia connected with what the authorities term as "spook parlors," being operated in San Francisco. The material was seized in a series of raids here last night by the police on warrants issued by the San Francisco district attorneys office and the attorney general in an investigation to be conducted here and in other parts of the state of persons operating as "ministers of the gospel." Many such persons, it was stated, were using "diploma mill" ordination certificates and church charters.

According to the authorities much of the evidence already before them indicates that some of the spiritualists whose activities were investigated were ordained ministers of the gospel, empowered at the rate of \$7.50 up by fake churches, to perform marriages and officiate at burial services.

Although three establishments were raided last night the officers did not arrest any one.

TREATY IS RATIFIED

(Associated Press Leased Wire.)

MEXICO CITY, Nov. 29.—The Mexican senate has unanimously ratified the Mexico-Japanese amity, commerce and navigation treaty which was signed on October 8, and which displaces the treaty of 1888. The most important point in the agreement is connected with the damage of citizens of either country may suffer owing to revolutions, each government agreeing not to hold the other responsible on that score. Japan also withdraws all claims for revolutionary damages suffered previous to the signature of the treaty.

Regarding immigration the pact specifies that this may be limited according to the laws and interests of the respective countries. Mexico being at liberty to study and decide to what extent Japanese immigration is desirable. The treaty becomes effective a fortnight after the exchange of ratifications.
