DYING YEAR OF 1924 WILL GO DOWN IN POLITICAL HISTORY AS NOTABLE ONE

Sensational Scandal Develops in Political Circles—Coolidge Victory Outstanding Feature—Division of Democratic Party Unequaled in History of Party Conventions.

WASHINGTON, Dec. 29.—(United Press)—Of many epochs it is said that they "came in like a lion and went out like a lamb," but history records few that are more faithfully characterized than the political and legislative year 1924 just drawing to a close.

The year dawned with a sensational series of revelations of alleged graft and corruption in the federal government that shook the nation. It is going out with the investigations a vague memory, a conservative President in the White House and the Secretary of the Treasury harking back to the days of '96.

The Senate investigations and the return of President Coolidge to the White House for four years in a three-cornered election were unquestionably the outstanding political events of the year. The fields of legislative and executive accomplishment were marked by further tax reduction and another slice from the public debt.

Congress was in session from the beginning of January to the 11th of June, mainly engrossed with the investigation with various reducing taxes, passing the bonus, enacting restrictive legislation having Japanese and generally keeping the country in a turmoil. It returned on December 3, a chastened body, the insurgent Republicans largely defeated, with an emancipated legislative program, designed only to keep it busy until its constitutional demise on March 4 next.

No sooner was Congress adjourned for the summer than the quadrennial Presidential was ushered in with a bang. Less than a week after adjournment, Calvin Coolidge, of Vermont, was acclaimed the nominee of the Republican party.

General Charles G. Dawes, of Chicago was named as his running mate. The Democrats, intent upon capitalizing the unrest and discontent incident to the revolutions of official corruption under the Republican administration, went into convulsion in New York early in July, full of hope.

They emerged 16 days later, after 183 ballots in the most turbulent political convention in history, torn and bleeding from bitter religious quarrels and factional disputes between Governor Al Smith of New York, and William G. McAdoo, with a candidate of sterling worth, according to his political foes as well as his friends—John W. Davis of West Virginia—cut with a party divided and scant chance of victory through the victors. Governor Charles Bryan of Nebraska was the Democratic Vice-Presidential nominee.

Meanwhile, Senator Robert M. La Follette laid plans for his own campaign. On July 4, at Cleveland, at a convocation of the Conference for Progressive Political Action, La Follette was formally acclaimed the leader of American Independence and launched himself on the scene of Presidential politics, with Senator Wheeler of Montana, his own Federation of Labor endorsed the ticket.

Victory for Coolidge. The upshot of the first three-cornered campaign in 22 years was a sweeping victory for Coolidge, who obtained 522 electoral votes, Davis 126, and La Follette 17. Coolidge's popular vote approximated 17,200,000, Davis 4,500,000, and La Follette 4,500,000.

Influenced by this defeat, the La Follette crowd voted just before the year closed to "carry over" and temporarily their movement as a movement to the future.

MOBILE, Ala., Dec. 29.—An unidentified man, believed to be the man who robbed a branch of the Marine Trust and Banking company of New Orleans of \$13,999 on Christmas Eve, was shot and killed in a pistol fight at the Louisville and Nashville depot early today, but not until after the man had seriously wounded Charles Ferrer, special agent of the L. and N. and Patrolman Walter Pistole, of the Mobile police force. The shots that killed the man were fired by Detective Gibby Wilcox after a running fight from the platform of a Pullman car through the station to the fruit wharf, where the man dropped dead.

Superintendent of Police Guy Molony, of New Orleans, and William Priesa, manager of the bank which was robbed, are en route here today. The sum of \$2,033 was taken off the man's body, mainly in twenty dollar bills. The money was strapped to his body beneath his shirt. He also had two pistols, said to have been stolen from the New Orleans bank. Four dynamite caps were also found in his pockets and a quantity of ammunition.

A notebook also was found in his pockets. It bore the name of W. E. Wright and had been pierced by one of the bullets which killed him. DES MOINES, Iowa, Dec. 29.—William E. Wright, killed in a pistol fight with police at Mobile, Ala., today and in whose possession was found a confession that he killed a Des Moines detective in 1923, was identified by the state investigation bureau as a man who has been convicted and served time both in Iowa and Kansas. 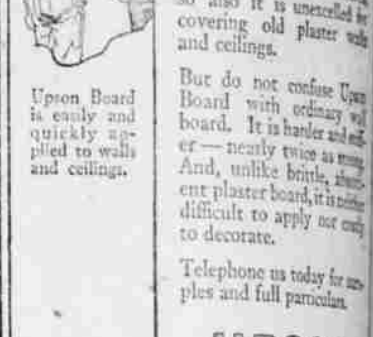
