

MAN SUSPECTED OF BURGLARY IN ROSEBURG HELD

Marshfield Police Capture Man Thought to Have Entered Local Stores.

REVOLVERS FOUND

Numbers on Guns Taken From Suspect Correspond to Those Taken From Montgomery.

Lee Duncan, who is believed to be an ex-convict, is being held at Coquille charged with robberies at Marshfield, it is thought to be one of the three men who recently robbed four business houses in this city, and Sheriff Starmer, accompanied by Roland Agee, and Deputy Sheriffs Shambrook and Grubbe, left this morning for Coquille to see if some of the clothing found in Duncan's possession could be identified as that which was stolen from the Wilder and Agee store.

Three men broke into the machine shop at the corner of Rose and Oak street, Wilder and Agee's clothing store, the Imperial Cleaners, and Economy grocery, and also broke out a window at the Highway service station. They obtained two revolvers, about \$35 in cash, three suits of clothing, together with three suitcases, groceries and cigars.

Yesterday Chief of Police J. W. Carter, at Marshfield, arrested Duncan at the St. Lawrence hotel in that place. Duncan had been under suspicion for several days, because of his erratic behavior, and the chief set a watch upon the man's room. Duncan was out all night, returning early in the morning carrying a small hand bag. When he entered his room he was taken under arrest, but not before he had made an effort to secure one of the three revolvers carried in the bag.

In his possession was found a bewildering array of burglar tools, together with a large quantity of goods believed to have been stolen at various places.

In the hand bag which he carried at the time of his arrest there were Jimmies, files, picklocks, a small vice, micrometer and hundreds of keys.

In another bag was found a quantity of clothing including silk pajamas, a new suit, several pairs of socks, ties and underwear, which are believed to have been taken from the local clothing store.

Two of the revolvers stolen from the Montgomery machine shop in the old Central Hotel building here, were found in Duncan's possession, and identification was made yesterday by telephone, the numbers of the guns held by the Marshfield officer corresponding with the numbers given by W. O. Montgomery to Sheriff Starmer.

One is an old style cap and ball pistol, which was easily identified. It is thought from the description of the suitcases found in Duncan's possession, that two of them were stolen from Wilder and Agee's store here. Mr. Agee accompanied the officers to Coquille this morning and will check over the articles to determine if they are his property.

Duncan, if guilty of the robberies here, was not alone in the crime, officers believe, for the tracks found around the places robbed indicate that three men were engaged in the robberies here, while the manner in which the places were entered is proof that one man alone did not perpetrate the crimes.

The Marshfield authorities have been advised of this fact, and it is hoped that the other two men may be found in that locality.

The agent was away for only a short time, so that the robbery was evidently committed by some one who made a rapid entrance and exit. TORNADO TAKES TOLL OF LIVES, MUCH PROPERTY

Swoops Down Upon Florida Razing Building and Dealing Death.

Many Injured, Hundreds Are Homeless; Damage to Property Placed at \$150,000.

MIAMI, Fla., April 6.—Four persons were dead here today and 23 others were in hospitals, the toll of the tornado which swooped erratically down from the Everglades yesterday and left \$150,000 property damage when it raved over the Atlantic. The death of Mrs. John T. Simpson of Westwood Park today increased the death list to four. The bulk of the damage was done at a dairy six miles west of Miami, where Mrs. Mathilda Shultz, 70, was killed. Several injured and six buildings demolished before the twister rose to strike again at a road house near Little River. Two died there, John Wadsworth Simpson, aged 8, and F. E. Sullivan. Several others were injured.

DEFENSE RESTS IN ATTEMPT TO SHOW INSANITY

Prosecution Takes Inning to Prove Dot Ellingson Mentally Sound.

GIRL IN CALM POSE

Displays Amusement When Doctor Testifies She "Apprehends, Not Comprehends."

(Associated Press Leased Wire.)
SAN FRANCISCO, April 6.—Shortly before noon today the defense closed its case to prove Dorothy Ellingson insane, and the prosecution began its effort to establish mental competence in the 17-year-old girl who killed her mother last January 13 in a quarrel over the girl's devotion to the night life.

While Dr. Jan Don Ball, a defense alienist, was being cross-examined the better part of the morning, the girl, displaying perfect composure, smiled broadly at some of the psychiatrist's statements and several times shook her head emphatically.

The defendant, recovered from the serious state of hysteria that brought on a dozen fainting spells last week, folded her hands calmly and followed the testimony closely. Once when a date was mentioned, she turned around and studied a calendar on the wall behind her.

In a very brief opening statement for the prosecution, Assistant District Attorney Harmon D. Skillis said he expected to establish that the girl was sane.

He promised to prove that she was not a "pathological liar," as contended by her attorneys; that the x-ray photographs introduced in evidence did not show abnormalities in the teeth and head, and "established sanity."

Questioned by Assistant District Attorney Skillis, Dr. Ball said it was "impossible to define insanity." He added that roughly "it was any deviation from the normal."

Under further questioning Dr. Ball said he did not apply the "right or wrong" test to patients because it entered the field of philosophy and was not of interest to the psychiatrist. He contended that medicinally there was no such test.

Asked whether the girl understood of what she was accused the alienist said she "apprehends it, but does not comprehend it in all its relations to society."

Interrogated further, he said he believed the girl could tell her attorneys what happened before January 13 (the day her mother was slain) and the events since.

The witness said he definitely formed the opinion of insanity the last time he saw her in jail, when she slumped down a chair, cursed and left the room in a rage.

The girl, decidedly more calm than on previous days, smiled at this testimony.

Dr. Ball said it was impossible to fix a conclusion on a single incident and when he asked the girl about a previous time he had given her, she could not remember and "a blank look came over her face."

Dr. Ball, answering another question, expressed the belief that the girl knew what he was saying from the witness stand, but did not "comprehend it in all its relations or realize the gravity of the situation."

ARCHBISHOP CHRISTIE DIES THIS AFTERNOON AFTER LONG ILLNESS

PORTLAND, Ore., April 6.—Rev. Alexander Christie, head of the Catholic Arch-Diocese of Oregon City, died at a hospital here this afternoon after an extended illness. He was 72 years of age.

Archbishop Alexander Christie was noted for his work in the development of his archdiocese, particularly in the construction of schools and religious institutions. "The Catholic History of Oregon," written by the Rev. E. V. O'Haren, refers to the archbishop's work as a builder, as follows:

"A few days after his installation the archbishop laid the cornerstone for the handsome new monastery of the Benedictine Fathers at Mount Angel. The event was to be typical of his work in the northwest, for his time will be known as the building epoch of the archdiocese."

It was said of Archbishop Christie that he built schools before churches and one of his cherished aims was the development of a church school system with a Catholic college like that of Notre Dame as its apex. It was in the hope of fulfilling this vision that old Portland University was bought from the Methodists in 1901 and renamed Columbian University. Formation of the Catholic Educational Association under his direction some years ago was another evidence of his interest in the school work of the church.

Passage of the Oregon compulsory public school law, which is upheld by the United States supreme court, is expected to wreck the parochial school system, was said by John F. O'Hara, editor of the Catholic Sentinel, to have been a severe blow to the archbishop.

The campaign against the proposed law was said to have been a drain upon the prelate's strength.

Archbishop Christie succeeded Archbishop W. H. Gross in 1893, about six months after the death of the latter. Less than a year previous he was consecrated by Archbishop Ireland in the St. Paul Cathedral, and assigned to the see of Vancouver Island. He was born in 1852 at Highgate, Vermont, and grew up in Wisconsin. He received his classical education at St. John's university at Collegville, Minn., and carried on his ecclesiastical studies at the Grand Seminary, Montreal, where he was ordained a priest for the St. Paul diocese by Monsignor Fabre, archbishop of Montreal, December 11, 1877. Before his elevation as a bishop he held pastorates in Wausau and Minneapolis, Minn.

LIBRARY COMFORT STATION PLANNED

Plans for the construction of an annex to the Roseburg Public Library building, to be used as a public comfort station exclusively for women, are being discussed this afternoon at a joint meeting of the library directors and a committee of the Roseburg Business and Professional Women's club, consisting of Dr. Lucetta Smith, Mrs. L. J. Barnes and Miss Agnes Pitchford.

The need of a public comfort station for women, particularly visitors, has been recognized in Roseburg for many years, but until the women's club took action on the matter recently no definite steps were made to establish one. The club, it is understood, has offered to share in the financing of such a project, and it is expected that the library board will also favor it. If the money is available from the city library fund, at the present time the station may probably be built within the next two or three months. If the fund does not permit the construction this year, the station will be erected next spring, at the latest.

The board plans to repaint the library building and make other improvements this year, and this may absorb what money is at hand, or at least so much thereof that the building of the station would have to be deferred.

A definite decision on the matter is expected at this afternoon's conference.

INSANE PATIENT ENDS HIS LIFE

SALEM, Ore., April 6.—D. D. Wilder, a photographer, whose home address was 250 East Stephens street, Portland, committed suicide at the state hospital for the insane last night by strangling himself with a bed sheet which he first attached to a water pipe. He was 52 years old.

Wilder was afflicted with melancholia according to Dr. R. E. Leister, superintendent of the hospital, but had never shown suicidal tendencies. He had been committed to the hospital several times and on March 17 last committed himself voluntarily. His last court commitment was in 1922 and he was later released. Since his voluntary commitment less than a month ago Dr. Leister said Wilder had shown improvement.

GAS MASK USED IN MURDER OF WAR VETERAN

Chloroform Administered to Victim After Being Made Helpless.

SAILOR'S WORK SEEN

Police Looking for Former Sweetheart on Theory She May Furnish Information.

BELMONT, Mass., April 6.—State police joined with the authorities of this town today in an effort to solve the mystery of the "gas mask" murder, the victim of which, Alexander Buchanan, Nova Scotia carpenter and war veteran, was found on Saturday in an abandoned cellar hole in the woods near the McLean Hospital in Waverly. A gas mask of a type used in the United States navy had been fastened to the man's head and enough chloroform to kill 25 persons, police said, poured into the chemical chamber of the mask. A gas had been inserted so tightly that the man's tongue was split.

The strings holding the mask in place were tied with what sailors call "ebb tide" knots. It was believed that the man was carried some distance to the place where the body was found.

Search was made for Miss Jessie McKenzie, formerly employed as maid for a Brookline family, whose engagement to Buchanan was broken last November. Miss McKenzie is believed to be residing in Detroit at present.

A few letters written in Italian, a girl's photograph and a list of girls' names discovered in the man's pockets, and a reported attack on the carpenter in his Boston lodging house last December were among the focal points of the police investigation.

OREGON DRY LAW CHIEF APPOINTS FIELD DEPUTIES
