PLAN FOR PARK STARTS FIREWORKS; WILL BE PROBED

PORTLAND, April 14.—Carl D. Shoemaker, retiring general manager of the state fish commission, made a tactical error today when he appeared before the county commissioners to meet objections of the board to his building a refreshment stand at the east end of the bridge across Eagle creek, on the Columbia river highway, land formerly owned by the fish commission.

Several years ago the county had an option on the land, but when the fish commission made known its wish to use it for propagation the county stepped aside. The land, about 20 acres, was purchased by the state for \$4000. Propagation of fish did not prove successful and about a year ago the land was sold by Shoemaker, as general manager of the commission, to Elmer M. Ries of the Warren Construction company. The plan now afoot is for Shoemaker and Ries to form a partnership to conduct a free camp ground and a refreshment stand on the tract.

The tract is situated on the north side of the highway, opposite the camp ground of the U. S. forest service, although a small triangular bit of it is on the south side. It is ideally adapted for park purposes, Shoemaker told the board.

Commissioner Taft became interested in the matter and said every effort should be made to obtain the tract for public use. He seemed amazed that the tract had been sold by the fish commission to a private citizen, when it was known the county had an option on the land before the commission purchased it.

BARNES TO GIVE SELF UP IN TAX CASE

PORTLAND, April 14.—Al G. Barnes, internationally known circus magnate and head of the amusement world, today declared his name, arranged through his attorneys to surrender to the United States authorities today, following his indictment by the federal grand jury on two counts, one of which charged that a false return had been filed in the payment of income tax of himself and company for 1921.

The circus man was to post \$50,000 bail, the sum fixed in a bench warrant issued by Federal Judge James, following the voting of the indictments by the grand jury in a special session last afternoon.

The federal charge, a representative of Barnes declared, was the entrapment of a dispute with the government over the depreciation allowance. It was reported that the depreciation charge-off made by Barnes was greater than the sum the government was willing to allow.

STUDENTS BUYING LAND TO ADD TO ATHLETIC FIELD

Arrangements have been made and all papers are in order, providing for the purchase by the student body of the Roseburg high school of an acre of land which will be added to the athletic field recently purchased as a part of the high school site in West Roseburg.

The student body has bought a strip 125 feet long and 355 wide on the east end of the field this tract being in Laurelwood addition, and bordering Riverside Drive as it is extended upon the plat of that addition. This purchase will make the athletic field 525 feet long, 355 feet wide on one end and 499 feet wide on the other. The narrow section will be 125 feet long, and the wider section 400 feet long. The grandstand will be built along the wider section of the field.

The strip procured by the students, also includes a small grove, which can be used for a park. The money, with the exception of \$500 has been raised by the student body, and the deed and all other papers are in the bank, awaiting the action of the school attorney on the abstract which is being submitted to him for examination.

Student activities will raise the balance necessary to pay for the land, which is costing \$2,000.

GUARD WITHDRAWN FROM MANSION OF WOMAN GOVERNOR

(Associated Press Local Wire.) CHEYENNE, Wyo., April 14.—Guards who have been patrolling the vicinity of the executive mansion of Governor Nellie T. Ross have been withdrawn. It developed last night, but the reason for their vigil during the last few days and night, remained a mystery.

M. C. Wachtel, state law enforcement commissioner, at whose orders the guards were placed, declared that the espionage that had aroused the curiosity of all Cheyennes, would cease and the guards be taken away because a "new lead" had been found and "we propose to run it down."
