BISHOP BROWN PLACED UNDER BAN

(Associated Press Leased Wire.)
NEW YORK, April 18.—Bishop Montgomery Brown, convicted of heresy at Cleveland last fall, has been forbidden by Bishop William T. Manning of the Episcopal diocese of New York, to preach to-morrow at St. Mark's "In-the-Housteria". Bishop Manning also has censured the rector of St. Mark's, the Rev. Dr. William Norman Guthrie, for having extended an invitation to the former bishop.

Bishop Brown was tried on charges of heresy by a board of bishops and convicted. The conviction was sustained by the court of review of the church. Bishop Manning ruled that he shall not speak or officiate in any parish or mission within the New York diocese.

LIBEL ACTION OF MAYOR LATEST IN KELSO'S CITY WAR

KELSO, Wash., April 18.—New offenses were opened today in the Kelso city war when a suit for \$27,500 damages was filed by Mayor A. Turice. Today against the publishers of the Kelso Tribune for an alleged damaging editorial.

Forces opposing Mayor Todd announced that injunctions are to be filed today to prevent the city clerk setting a date for a recall election against five councilmen and the city attorney. The election date is scheduled to be designated on April 24. Mandamus proceedings are to be filed the first of the week in superior court to compel the mayor to sign salary warrants which have been approved by the council, according to City Attorney Stone.

COOLIDGE GIVEN PROTEST ON LAND OFFICE PRUNING

WASHINGTON, April 18.—Protest against the reduction in public land offices in Oregon and South Dakota were lodged with President Coolidge by representatives of those states. Senators Murray and Stanford and Representative Sennott, republicans of Oregon, asked that the proposed elimination of two of the seven offices in Oregon be reconsidered. Senator Norbeck, republican, South Dakota, likewise urged that all three of the offices in that state be retained, whereas it is proposed to have only one office there.

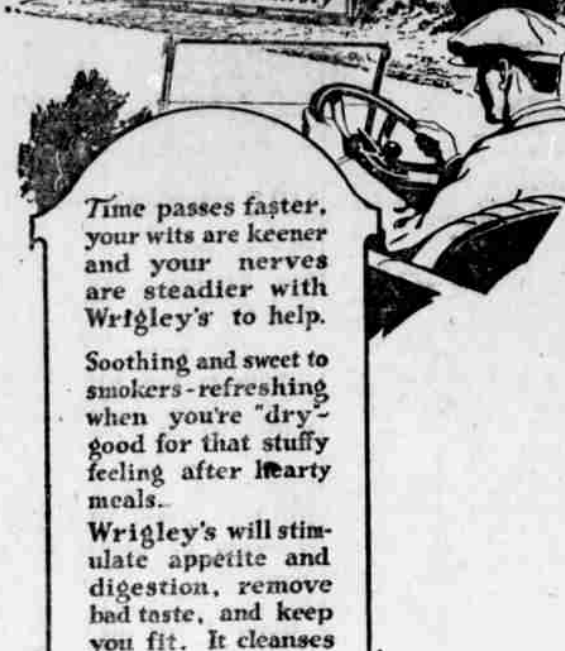
