OREGON TRUNK LINE EXTENSION ROUTE PUBLISHED

(Associated Press Leased Wire.)

PORTLAND, Ore., May 6.—The detailed route of the proposed extension of the Oregon Trunk from Bend to Klamath Falls is set forth in an application prepared for filing with the Interstate Commerce commission today, says a special dispatch at \$40,900 a mile.

The plans provide for a single line sixty five miles from Bend to Skookum, formerly known as Odell. At this point the line would branch off in two possible routes to Klamath Falls. The petition is quoted as follows: "A line from Bend, Ore., southwesterly, following generally up the Deschutes valley, a distance of approximately 65 miles to the height of land or summit between the Deschutes and Williamson river drainage; thence southerly and southeasterly approximately 49 miles to the summit between the Williamson river and the Sycan river; thence in a southerly direction approximately 24 miles to the Sprague river; thence in a southerly, southwesterly and westerly direction, approximately 43 miles to Klamath Falls.

Also a line connecting with the aforementioned line near the summit between the Deschutes and the Williamson river drainage; thence southerly and finally easterly, following generally the west side of upper Klamath Lake to Klamath Falls, 56 miles.

"The applicant does not now propose to issue any securities for constructing the extensions," the application sets forth, "but will file separate application therefor should occasion require. The applicants' outstanding shares of corporate stock are owned by Spokane, Portland and Seattle Railway Company (herein referred to as the S. P. & S.) whose capital stock in turn is owned, one half each by Great Northern Railway Company and the Northern Pacific Railway Company (herein referred to as the Northern lines)."

The Northern lines have invested more than \$100,000,000 in the construction of the railroad of the S. P. & S. and in the acquisition or construction of the railroad of the S. P. & S. subsidiaries, including the railroad of this applicant.

"The required funds for the construction of the proposed extensions will be furnished by the Northern lines. The Northern lines own (one half each) about 98 percent of the capital stock of the Burlington. The Burlington owns 48.3 percent of the stock of the Colorado & Southern Railway Company. The cost of construction is estimated at \$40,900 a mile."

BURNING FLOOR COLLAPSES; SIX FIREMEN KILLED

ATLANTA, Ga., May 6.—Six firemen were killed and four injured here early today when the upper floor of a building in which they were fighting fire collapsed, the men being buried beneath bales of cotton that had been stored on the second floor.

The building was a two story brick structure used for storing cotton. The firemen were fighting the blaze from the ground floor when the roof and upper floor fell in, sending them down beneath a weight of cotton bales.

Captain C. O. Bone and Lieutenant R. L. Dennard, were among those killed. Four other firemen, F. F. Wilson, L. M. Smith, E. S. Konkle and C. C. King were dead when their bodies were taken from the ruins.
