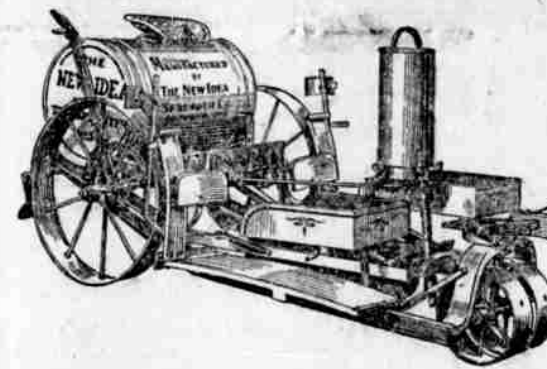

FRENCH MACHINE GUNS MOW RIFFS IN BLOODY FRAY

(Associated Press Local Wire.) PARIS, June 5.—The Riflian tribesmen have launched the strongest and best organized offensive since their invasion of French Morocco with a drive against Taounant in the middle of the front. Official reports say Abd-El-Krim's men temporarily gained some ground, crossing the Ouergha at several points but were repelled by the French. The latter in a series of counter attacks re-occupied some of the posts north of the stream which were abandoned during the voluntary evacuation of that zone last week. The Riflians used no artillery, but their forces were larger than in any previous operation of the campaign. The pitched battle lasted from daybreak to sunset yesterday, French reports said. Abd-El-Krim's "shock troops" got their first real taste of modern warfare in a stinging defeat in which the Riflian warriors fought valiantly but were forced back by the French from all points north of the Ouergha river, which they had briefly occupied. The fierceness and stubbornness of Abd-El-Krim's attack was interpreted by the French as meaning his original intention to reach Fez. Taounant, his immediate objective, is the key to the crossing of the Ouergha.

It was learned that a Franco-Spanish mixed commission will be appointed soon to discuss methods of establishing a blockade by France and Spain of the north African ports of Adjir and Alhucemas, where the Riflians have been receiving arms and munitions. POTTERS FIELD CLAIMS EDISON'S DAUGHTER-IN-LAW (Associated Press Local Wire.) NEW YORK, June 5.—An inquiry is being made in behalf of Thomas A. Edison of a report that Mrs. Elizabeth Heyzer, mother of Mrs. Thomas A. Edison, Jr., died in obscurity and narrowly missed burial in the Potters field. William Meadowcroft, the inventor's secretary, in saying yesterday that an inquiry would be made added that the inventor was not aware of Mrs. Heyzer's death and did not know where she lived. Mrs. Heyzer died Tuesday in a modest boarding house owned by and partly occupied by Charles A. Benedict, an undertaker. Estranged from her daughter's father five years ago, she kept secret her connection with the Edison family, Benedict said. She did not want to trouble her daughter with her infirmities or financial condition. For two days the body lay in the morgue unclaimed. Authorities had given permission to carry the body to the Potters field, undertakers say, when William Heyzer, a son, and friends paid the funeral expenses. Mrs. Edison, Jr., formerly Beatrice M. Heyzer, was among those who attended the services. She married the younger Edison in 1910.

PLOTS TO MURDER SPANISH MONARCH HOLD UP JOURNEY

(Associated Press Local Wire.) BARCELONA, Spain, June 5.—Existence of bomb plots to kill King Alfonso has been revealed and the sovereign's return to Madrid is being postponed. One bomb was discovered on the tracks traversed by the royal train on the way to this city. Two other plots are reported, one to blow up the entrance to the hall where Alfonso presided at a meeting last Saturday and the other to kill him during the return journey to the capital. The bomb found on the rails has been placed in a museum here, and the king took time from his scheduled program to view it. It is of considerable size and has been placed so that for the vigilance of guards, it would have been exploded by the impact of the royal train. The attempt at the meeting hall was frustrated by discovery of plots shortly before his majesty appeared. The delay in returning to Madrid is said to have been because of the discovery of the third plot. The king's visit here has been extremely quiet and there have been few decorations in honor. Barcelona, the principal city of Catalonia, has been the center of the Catalan movement for independence from Spain. It was also the seat of the military revolt under General Primo De Rivera which in September 1923, overthrew the cabinet and established the military directorate ruling the country. Fourteen persons have been arrested in Barcelona in connection with the bomb plots against King Alfonso, according to travelers arriving over the frontier, who say news of the plots is being suppressed in the Spanish newspapers. Those arrested were young students and functionaries, members of an extreme Catalan group which had been camouflaged as a literary and touring association. The prisoners denied any connection with the plots. The bomb, which was intended to blow up the royal train between Barcelona and Madrid is said to have been a large one, weighing 175 pounds, arranged to be exploded by electric mechanism. It was found several miles outside the city near the tracks of the Madrid line. The travelers say the police also found a map showing the location of a bomb under one of the numerous tunnels on the route to Madrid. Several days ago, they assert, a bomb was exploded, which seriously damaged a palace of the Marquis De Castell, at Barcelona, the day after a ball held there in honor of the king.
