MICKY SHANNON IS KILLED IN BOXING BOUT LAST NIGHT

(Associated Press Leased Wire)

LOUISVILLE, Ky., July 22.—Mickey Shannon, Chicago light-heavyweight, died in the arena before hundreds of boxing fans here last night at the end of the fourth round of his bout with Harry Fay of Louisville. When Fay drove him to the ropes and so weakened him with head and body blows he collapsed and fell through the ropes, breaking his neck when his head hit the floor.

Fay was arrested on a technical charge of manslaughter, but was released on a \$1,000 bond. The Louisville boxer was depressed over the accident, but refused to comment except to express his regret over the outcome.

By coincidence last night's fatality marked the second time that a Micky Shannon had been killed

BLAZE ON SOUTH MYRTLE DESTROYS HOME; LOSS \$3000

Fire attributed to a defective five yesterday forenoon totally destroyed a dwelling belonging to W. C. Bates and situated on South Myrtle Creek, 13 miles east of the town of Myrtle Creek. All of the contents of the house, belonging to the tenant, Mrs. Charles Potter, were also burned up. The fire's toll also included a small shed containing about \$500 worth of insured mining tools belonging to Bates. The house was worth about \$1000 and the contents about \$1500, neither insured. The flames were readily communicated to the brush on both sides of the narrow canyon in which the house was situated, but the prompt action of neighbors in combating them averted what otherwise would have resulted in a serious forest fire.

LOSER IN 30-YEAR DIVORCE RELEASED

NEW BRUNSWICK, N. J., July 22.—Jonathan Meeker, loser in New Jersey's longest divorce litigation, lasting thirty years, has been ordered released from the Middlesex county jail where he has spent nearly three years for failure to pay alimony.

The Meekers were married in 1888 and began litigation in 1892. Several suits by one or the other were dismissed or denied before Mrs. Meeker was awarded a decree in 1922. In November of that year, Meeker was jailed when the \$12 weekly alimony he was ordered to pay was \$400 in arrears.

Meeker's petition for freedom was seconded by the Middlesex county solicitor, who asserted that the county no longer wished to support him.

Anna G. Lines of Riverdale, his former wife, opposed the release.

BRUMFIELD MYTH IS STILL ALIVE SALEM MAN SAYS

The Brumfield myth is still alive, says the Salem Capital Journal.

According to a Salem man who recently returned from Douglas county, there are people in that county who yet firmly believe that the dapper, haughty dentist murderer of Roseburg, who shot a legless man, but the body in the dentist's automobile and sent it over a bank and then set the machine on fire to destroy the victim's identity, is still among the living.

They believe that somewhere the former Dr. Brumfield is existing under an assumed name, perhaps with his wife and children, and that the body which was destroyed at a Portland crematorium was one substituted to permit Brumfield to escape. They also go so far as to declare that the fact that the restricted marriage of Mrs. Brumfield in Seattle to another man shortly after Brumfield's death, was merely a blind and that Brumfield himself is reunited with his wife and family.

Brumfield, it will be remembered, was sentenced to die on the gallows, but cheated the official gallows by making one of his own and died hanging in his death cell in the prison.

Shortly after his body was cremated the rumor sprang up in Douglas county that it was not Brumfield who hanged himself at all in the death cell at Salem, that the authorities, or someone, had substituted the body of a convict who had died, and that Brumfield was smuggled out of the prison.

The fact that this was an allegation story, started in the heat of one of the most sizzling elections ever held in the state, has not altered the belief in the minds of many Douglas county people, regardless of the fact that numerous persons who knew Brumfield saw his body in the prison after his death and there could possibly be no doubt as to its identity.

Apparently, declares the Salem man, there are people in Douglas county who will go to their graves firmly convinced that Brumfield cheated the gallows, that his life was never choked out by his own act, and that somewhere he took up the thread of his old existence to weave it as he saw fit, with the shadow of the dead behind him, lurking in the background.

The message added that St. George had said he had trouble in the Philippine Island, and that if for some one at the navy yard at Mare Island had him under a hypnotic spell. St. George said he belonged to the submarine No. 18. He was wearing a navy uniform when found.

PREDICTS RISE OF HAWAIIAN ISLANDS TO BIG CONTINENT

WASHINGTON, July 22.—A prediction that Uncle Sam will be presented by Mother Nature with a fair-sized continent in the mid-Pacific was added today to the profusion of discussion and conjecture that has followed recent seismic disturbances.

Edwin Fairfax Nauty, of New York, who has studied the earth movements for many years, said he was convinced that the Hawaiian Islands gradually and quietly were being pushed upward and within a generation would comprise a high and dry territory as large as Japan.

Only the peaks of a great range now arise above the surface of the sea at Hawaii, he said, but a constant "squeezing" process at work in the bed of the Pacific may push these peaks constantly upward.

He added that all the signs pointed to a gradual rise over a period of years entirely unaccompanied by serious earth shocks.
