

PEACEFUL DEATH ENDS CAREER OF FAMOUS STATESMAN WHO WAS EXHAUSTED AFTER SCOPES TRIAL

(Continued from page 1) afternoon ceremony. The guard will be in uniform and without arms. The children of the dead leader have been summoned by telegraph by their mother to join the party in Washington. The son, William Jennings Bryan, Jr., left Los Angeles for the East today. Mrs. Ruth Owen left Mount Vernon, Ohio, for Dayton today, but will divert her course so as to reach Washington before the body of her father, Mrs. Richard Hargreaves, the other daughter, is with her brother traveling east. The decision to bury the former democratic chief among the country's military great in Arlington, was the result of the expressed wish of Mr. Bryan, his widow told friends here. Mr. Bryan was a colonel of volunteers in the Spanish-American war. A huge spreading maple tree shades the spot where the files of friends will look for the last time upon the face of their beloved champion. In this grassy eminence, raised four feet above the level of the street, Mr. Bryan was wont to sit and rest during the intervals of the fight over the Tennessee anti-evolution law. Here he chatted with his friends and grasped the hands of hundreds who had come from the Cumberland slopes or from distant cities to witness the noted controversy in the Rhea county court. Funeral arrangements had not been completed early today, but Mrs. Bryan indicated the body would be interred in Arlington cemetery, as Mr. Bryan, who was a colonel in the Spanish-American war, several times had expressed a desire to be buried there. The commoner had been living under a strenuous program since he came here three weeks ago to assist in the prosecution of John T. Scopes, found guilty of violating Tennessee's anti-evolution law. Mrs. Bryan, who has been an invalid a number of years, bravely stood the shock of her husband's unexpected death. She immediately took charge of funeral arrangements and received a few of the hundreds of persons who called at the residence to express sympathy. "I am happy that my husband died without suffering and in peace," she said. His last words to her, as he entered the room for his nap, were: "I am so sleepy."

of perfect contentment. In the front room, across the hall, Mrs. Bryan rested in bed. Her attendants said she slept little, if at all, during the night, although she lay quietly most of the long hours. It was in the room just in the rear of where his widow lay today, that the commoner breathed late yesterday his last breath unwatched by the eye of man. Later he was removed to where he reposed today, in the parlor of the simple home. Definite plans for the removal of the body and the final services were still lacking this morning. Attendees reported that Mrs. Bryan waited further information from her children, the first of whom, Mrs. Owen, is expected to arrive in Dayton tomorrow morning. It was the belief of her friends that the funeral party would not leave Dayton until tomorrow and more probably not before Wednesday, when the movement would be begun toward Washington. The national color was displayed throughout the town's business portions today, flying at half staff in honor of the dead. Every protection and comfort were being given to the widow by a group of her chosen attendants who forbade callers to speak with the bereaved and invalid woman. Body to Lie in State. DAYTON, Tenn., July 27.—The body of William Jennings Bryan will lie in state this afternoon between the hours of 2 and 4 o'clock where the public will be invited to view the remains. Friends decided today the place will be the home where Mr. Bryan died or the Rhea county court house, where he fought his last great battle. Sunday Pays Tribute. HOOD RIVER, Ore., July 27.—William A. Sunday, spending the summer at his home here, paid the tribute to William Jennings Bryan: "The friend of God, the enemy of the devil, to know William Jennings Bryan was an invitation to do right. Although he chose politics as a career he was essentially a crusader for Christianity. He was at his best when fighting on moral rather than on religious issues. He fell with his face to the enemy. He was Lutheran in his faith, a Napoleon in his battle for God, a Lincoln in his patience. Crown him as one of the world's immortals. He never dipped his colors to compromise. His great hold upon the American people was due to his sincerity of purpose. It was a rare privilege to count him as my friend and collaborator for God." To Lie in State Tomorrow. DAYTON, Tenn., July 27.—William Jennings Bryan's body will lie in state tomorrow afternoon instead of this afternoon on the lawn of the Richard Rogers residence, friends of Mrs. Bryan announced this afternoon. The change was made just before the hour when the commoner's body was to be carried into the Rogers' yard. Mrs. Bryan believed that a longer interval between the announcement and the viewing of the remains would give a better opportunity for his friends in Eastern Tennessee to reach Dayton. A rain also threatened here this afternoon. TOKIO, July 27.—Prime Minister Shidehara, when apprised of the death of William Jennings Bryan said: "The death of Mr. Bryan is a great loss not only to his own country but to the whole world. His courage in supporting the cause of international peace and friendship has been inspiring and benefit from his example, feel we in Japan, while continuing to have sympathy for the active sympathy he always displayed towards Japan." Select Burial Spot. WASHINGTON, July 27.—A spot high on the slope of Arlington, overlooking the capitol and near the monument erected to those who died on the Maine, was the place selected today as the burial place of William Jennings Bryan. WINCHESTER, Tenn., July 27.—Before leaving here Saturday afternoon for delivering an address, William Jennings Bryan, who died suddenly in Dayton yesterday, made the following statement to a reporter: "If I should die tomorrow I should feel that much had been accomplished in the greatest campaign ever known. I believe that on the basis of the accomplishments of the past few weeks, I could truthfully say, well done." Satiety is Eliminated. NEW YORK, July 27.—Out of respect for the memory of William Jennings Bryan, New York theaters have decided to delete scenes satirizing his part in the recent Scopes' trial. A scene in the "Garrick Gallop," portraying Mr. Bryan as the prosecutor in a "monkey trial" will be dropped tonight. Lines from the Grand Street Y referring to the commoner are to be deleted and other comedies in Manhattan theaters which have been satirizing Mr. Bryan by word, suggestion or tableau have had all such parts stricken out. Plans of Bryan Published. CHICAGO, July 27.—Charles N. Wheeler, a staff political writer for the Chicago Herald and Examiner, in a signed story published today, declared that William Jennings Bryan had told him that in the event of his nomination a fourth time for president, his first campaign speech would be to an audience of millions in New York City. He had thought it not inconceivable that the New York convention last year might be unable to nominate any of the active candidates and might turn to him Wheeler wrote, although Bryan said he would not seek the nomination, but on the other hand was

working for his brother, Charles, then governor of Nebraska. "If I should be nominated, I would be elected," Wheeler quoted Bryan as saying to him confidentially immediately after the republican convention in Cleveland. "I would startle the country with my first campaign speech. It would be in New York and to an audience of millions. No one would be admitted, who could not vouch for the possession of at least one million. "It was the great moneyed class that defeated me for president in my three campaigns. But they would not be so selfishly opposed to me in another campaign. I am a man of considerable means. While not in the millionaire class, I have a large fortune as the average man views such matters. "I am not opposed to these men accumulating large fortunes. I am for the full protection of property rights and worldly goods rightfully accumulated. "But these men must be made to understand that they cannot much longer employ the power of money to retard the progress of the great masses. I would tell this millionaire audience that I did not propose to take one penny from them but I would tell them they must become less selfish in the use of their money power." Funeral Held Friday. WASHINGTON, July 27.—Funeral services for William Jennings Bryan will be held here on Friday afternoon and burial will take place late that day at Arlington. Details of the funeral ceremony are still to be determined, but it is probable that a simple service will be held at some Presbyterian church in the capitol. It is not likely that the body will lie in state in any public building nor that military ceremonies will accompany its entombment. The delay from Thursday morning when the funeral train reached Washington, to Friday afternoon was decided on to permit William Jennings Bryan, Jr., to reach the capitol from the Pacific coast. Mrs. Bryan at Dayton, Tenn., has given her approval to the time selected for the funeral services and to the selection of a burial place on the Arlington slopes overlooking the city. Overcome With Grief. DES MOINES, July 27.—Father J. F. Nugent, lifelong friend of William Jennings Bryan and who had many times occupied the same speaking platform with the great commoner, suffered a nervous collapse last night when informed of the death of his friend. Father Nugent, who has been in ill-health or some time, was so overcome with grief that friends who conveyed the message to him in his bed feared the shock might cause a serious relapse. He was unable to make a statement. KNOXVILLE, Tenn., July 27.—Clarence Darrow and J. T. Scopes here today commented on the death of William Jennings Bryan. Mr. Darrow's statement follows: "Mr. Bryan was a man of very extraordinary powers as a speaker and campaigner, or in any cause in which he believed. I always considered him fairly honest in his opinions and very able and brave in their defense. He was essentially a crusader. He was not of philosophical turn of mind but especially an earnest lover of his death and extend my sympathy to his grief-stricken family." Mr. Scopes said: "Bryan's death represents the death of a great force in economics and politics in the United States. Whether one agreed with all his ideas and principles matters little at this time. Honor must be paid to Mr. Bryan for his fearless stand on issues that he thought were right." FIRE CAUSES BIG LOSS. BORING, Ore., July 27.—Fire early today destroyed the S. E. Waller business building and the home of S. M. Morgan at a combined loss of approximately \$7,000. Waller was awakened at 2 a. m. by a fire in the structure, which houses a store, confectionery, pool hall, barber shop and theatre. The flames quickly spread to the Morgan home next door. Both buildings were partly covered by insurance. Origin of the fire is unknown. J. H. Ellis today paid a fine of \$250 for cutting corners. PORTLAND, July 27.—(Market Notes)—Decreasing production of butter and lower volume of cold storage holdings at primary points on the Pacific coast, coupled with firmer prices as compared with a week ago, are features in today's dairy market. A week ago the price of extra quality butter in the local wholesale market was 46c a pound. Today it is 1c higher. A further advance this week is probable. This is the season when production of butter fat and butter prints decline and remain at the low mid-summer level, while demand is not lessened to any appreciable degree. Compared with a year ago at this time, best cube butter in the Portland market was 40c a pound. Strictly fresh eggs are firmer in the Portland market today than at the opening of last week. The advance was 1 cent a dozen to 37 cents. A year ago the price was 35 cents and two years ago 30 cents. Dealers are talking of further price advances. Cold storage stocks of eggs in Portland, Seattle and the six principal egg storage cities of California totalled 4,676,269 cases July 18, an increase of 13,443 cases over the corresponding date of last year. The Portland storage stock of 80,278 cases last week was 26,941 cases larger than at the middle of last July. Cheese in firmer in price. Stock in store in six Pacific coast cities July 18, totaled 2,847,350 pounds, or 1,078,793 pounds less than a year ago. However, at the Portland end of the latest report, 594,108 pounds, were 389,122 pounds greater than at the same time last year.
