WOOD MARKER STANDS AT HEAD OF BRYAN GRAVE

Commoner Sleeps in Arlington Among Military Heroes of Past.

MRS. BRYAN IS BRAVE

Invalid Widow Borne Up in Great Sorrow By Her Faith—Relatives and Friends Leaving.

WASHINGTON, Aug. 1.—A simple wooden marker, set aside the withering clusters of blossoms that hid his grave, alone marked the last resting place of William Jennings Bryan in Arlington National cemetery.

Just over the hill crest stand the row on row of white headstones above the soldier dead who lost their lives in France. Closer about the more imposing monuments of the officer dead with whom he keeps his last encampment, and all about are the signs of the orderly reverent care with which the nation surrounds the last sleep of those it has called to its service.

One day a stone memorial will be erected to tell in green lettering that the commoner lies here on this peaceful slope. But it is yet too soon for the stricken widow, the brother, the children and the grandchildren of the dead to have made their plans for that permanent testimonial to their love.

The broken family circle was still in Washington today gathering again the threads of every tiny thing of life, to which they must turn back.

Other members of the family planned to leave tonight for their homes. Former Governor Charles W. Bryan expected to go direct to Omaha and prepare to fill the lecture engagement he has made for the weeks ahead. Those of them who could planned to stay on a day or two with the mother.

After the last services at the grave late yesterday, many of the old political and personal friends of the commoner left for their homes and others boarded their trains today. There was no definite step taken among them toward a memorial to the dead leader, nor is it likely that the question will be opened until Mrs. Bryan has indicated her wishes.

The widow appeared well and cheerful today after a night's restful sleep, and it was considered probable that she would leave for Florida with her household tonight. William Jennings Bryan, the son, will accompany her.

Mrs. Bryan continues to be a marvel of resolution, of faith, and trust. Walter E. Thompson, the Bryan secretary said, "She is deeply grieved, but is sustained in a wonderful way in her sorrow by her great faith. She is quite cheerful."

Today a group of the faithful friends and attendants of Mrs. Bryan in her hours of grief visited places of interest in the city and of the beloved woman. The party included Richard Rogers, in whose home at Dayton, Tenn., Mr. Bryan died; Wallace Haggard, Dayton attorney, associated with the fundamentalist leader in the prosecution of the Scopes trial; Kelso Rice, Chattanooga police officer, who came to Washington as a special guard for the casket by (Continued on page 6.)

Misery and Suffering Face Germans Expelled From Polish Soil; Many Hundreds Seek Refuge in Fatherland

NEW YORK, Aug. 1.—While the populace of the Ruhr valley, in the western section of Germany is arranging fetes to celebrate the departure of the last of the French occupational forces there is misery and suffering near the Polish frontier in the northeastern corner of the country. The cause is the arrival there of thousands of Germans who have been virtually expelled from Poland because they voted in favor of Germany in the upper Silesian plebiscite.

Upper Silesia formerly belonged to Germany, and the plebiscite, held in 1920, to determine the disposition of the territory was provided for in the Versailles peace treaty. Schneidmuhl is the scene of a great encampment where the evicted Germans are living temporarily and dispatches from that place describe their condition as pitiable. They have been coming across the frontier in droves for the last two days, as the time limit for their voluntary departure expired at

PREMIUM LIST OF LAND SHOW IS APPROVED

Committee Decides to Make Feature of Fruit Display.

AMOUNTS ARE FIXED

Committees Appointed to Take Charge of Finances, Publicity and Program for Coming Show.

A meeting was held yesterday of the committee forming plans for the Home and Land Products show to be held September 24, 25 and 26. The meeting was held principally for the purpose of considering the premium list and appointing the sub-committees, which will aid in the detailed plans for the coming event.

A tentative premium list was agreed upon, both for group and individual exhibits, and from the tentative program it was estimated that \$500 would be needed for premiums if all exhibits were made.

Mr. Cooney reported that W. S. Carpenter is arranging for an exhibition of boys and girls club work, and that he will need an appropriation of \$70 to carry out his plans. The grant exhibits, it was reported, will number six, and possibly more.

In going over last year's premium list, the committee decided to follow it in a general way, but a few changes were made various sections.

In regard to the community exhibits it was decided to use the same plan as last year in awarding \$20 bonus to each community scoring 65 or better. A partial change was made on the score card. Last year 30 per cent was allowed for diversity; this year only 10 per cent. 60 per cent was given for quality and 30 per cent for appearance, stressing quality more than was done a year ago.

The premiums for the community exhibit will be the same as last year, \$25, \$15 and \$10. An effort will also be made to secure exhibits from individual farms and their prizes for the best farm showing will be the same as the community exhibits.

A change was made in the potato premium, allowing three prizes of \$5, \$3 and \$2. The corn prizes will also be in the same amounts. A deleted change was made in the premium list for fruits. No attempt was made last year to display fruits outside of the community exhibit, but as it is felt by the committee that fruits for the principal products, it was decided to plan a table of plate and tray displays. The most important commercial fruits of the county were considered, and seven varieties of apples were selected, the first prize for each being \$1 and the second prize 50 cents. The apple varieties allowed were: Yellow Newtown, Spitsenburgh, Johnathon, Winter Banana, Delicious, Orley and Gravenstein.

The committee also named seven varieties of pears, Bartlett, Bose, D'Anjou, Winter Nellie, Comice, Howell and Shelton. The prizes will be the same as on apples. Grapes are to be shown on trays, five varieties being allowed: Flame Tokay, Black Prince, Cassless Rose, Malaga and Concord.

Four varieties of peaches were selected, Alberta, Hale, Late Crawford and Cling. Any variety of Clingstone may be entered. Prunes will include Italians, Petites and Date prunes. Walnut varieties will be Franquette and Mayette, and filberts will be the Barcelona variety. Sweepstakes will be given on plate and tray displays, and prizes of merchandise will be provided for each variety.

It has also been recommended that individual farm displays of vegetables be arranged, barring commercial gardeners. Flower displays will have prizes of \$7.50 and \$3. A special display is also proposed consisting of fifteen blooms, Asters, Gladiolus, Dahlias and Zinnias, with prizes of \$3, \$2 and \$1.

A committee consisting of L. L. Crocker, Royce Busenbark, Roger Royer and Mr. Jenkins, was named to take charge of the financial side of the show, and the county court will be asked to aid in taking care of the premiums by an appropriation from the fair fund.

The publicity committee selected consists of Bert Bates, A. T. Lawrence and Frank Clemens. The program committee is Walter Day, Frank Hills, and Roy Bellows.

RIOT IS REPORTED IN CHINESE FACTORY; BRITISH SUBJECT SHOT

PEKING, Aug. 1.—Unofficial addresses from Nanking say that a riot in which one British subject was killed took place at the factory of the International Export Company after a wage dispute last night. The British employes of the factory are reported to have fired on the rioters, killing four and wounding several of them. British marines are now guarding the factory. Most of the British employes have been taken aboard warships, but one of them is reported to have been made prisoner and taken to Nanking University.

FORMER HEAD OF MULTNOMAH SCHOOL IS GIVEN SENTENCE

HILLSBORO, Ore., Aug. 1.—R. F. Robinson, who for many years was superintendent of Multnomah county schools, was today given a suspended sentence of one year in jail and a fine of \$1,000, following his conviction March 9, of being "implicated in issuing checks" on the Sherwood Bank for which he had no funds deposited. Robinson was given until October 1 to adjust his account with the bank. Execution of the sentence was made contingent upon the character of the report made to the court on that date.

TWO SENTENCED FOR LIQUOR ACTIVITIES

WASHINGTON, Aug. 1.—Ben L. Moses and Harry Sattler, of Pittsburgh, indicted last year with Representative Langley of Kentucky on charges of conspiracy to illegally withdraw liquor, pleaded guilty today in the District of Columbia supreme court.

They were sentenced to serve two years each in the penitentiary, but were placed on probation for that time. A fine of \$10,000 each was assessed, and they were allowed a week in which to raise the money.

HIGHWAY STRETCH TO BE OPENED SOON

EUGENE, Ore., Aug. 1.—The Harrisburg-Junction City section of the Pacific highway, recently paved, will be opened to traffic August 7, it has been definitely announced. Several small bridges remain to be surfaced, but this work will not alter plans for the opening of the paved section.

The stretch of highway is the last to be paved, and provides unbroken pavement on the highway from Canada to California.

MINERS VICTORS IN SETTLEMENT OF COAL STRIKE

British Laborers Will Continue at Same Hours and Rate of Pay.

GOVERNMENT TO AID

Ten Billion Dollars Will Be Given Owners to Make Up Deficiency—Labor Joyful.

(Associated Press Leased Wire.)
LONDON, Aug. 1.—Notwithstanding that the financial assistance which the government is to give to the mine owners will add, according to unofficial figures, something like \$10,000,000 to the country's budget, there is a great sense of relief that a miner's strike, affecting more than a million men, has been prevented.

Strike notices had been issued several days ago to take effect at midnight last night, and the carrying out of the threat was averted only by the last-minute offer of the government to give financial aid to the mine owners to enable them to maintain the present wage scale. The agreement carrying the present scale of wages, was to have expired at midnight and it was a new agreement proposed by the mine owners to supersede it, with its clauses involving decreased wages and a longer working day that brought to the strike threat.

Under the arrangements made yesterday to prevent a strike which would have caused one of the worst industrial calamities in recent times, the miners will remain at work receiving the same wages as they did under the old agreement, and remain in the pits the same number of hours each day as at present.

The government will grant financial help to the owners until May 1, 1926, if in any month the wages paid to the men exceeded the recognized ratio of division between wages and profits are lower in any district than the wages payable at the minimum percentage under the agreement the exchequer will make up the deficiency. In any month in which the estimated average profit of a district in which subvention is payable exceeds fifteen per cent, the excess will be used in the reduction of the amount of the subvention.

Yesterday's victory for the miners, for they regarded it as such, has brought joy to the entire labor world and the labor leaders attributed it to the solid support given to the miners by the trade union movement. The coal industry is to undergo a complete investigation while the government's subvention is in effect.

CANADIAN STEAMER REPORTED ON ROCKS

CLEARING HOUSES SHOW LARGE EXCESS

BANK CLERKS ON STRIKE IN FRANCE

ASK VALUATION GOOD WILL BE CANCELLED

OAKLAND PRUNE GROWERS TO FORM AN ORGANIZATION

The Oakland prune growers have sent articles of association to the state commissioner, and are planning to complete their organization at once. The organization of a cooperative concern at Oakland follows the meetings recently held there by R. H. Kipp, manager of the marketing department of the Portland Chamber of Commerce. It is expected that they will meet on Aug. 8, at which time the organization will be definitely completed, and the work of the association in handling the prune crop of the Oakland district undertaken.

SALVATION ARMY OFFICERS PAY A VISIT TO ROSEBURG

Adjutant and Mrs. Rooney of Portland, the new commanders of the Salvation Army for the state of Oregon, are spending a short time visiting in Roseburg. They have been recently transferred from San Francisco to the state appointment. They have been salaried army officers for nearly a quarter of a century, and come to Oregon highly recommended as fitting officers for this command. They speak very favorably of a return visit to Roseburg during the coming week at which time they will be accompanied by Captain and Mrs. Gifford, also of Portland. They expect to hold services at the Salvation Army hall during the evening. They are full of pep and the local officers are expecting a very profitable time. Captain and Mrs. Emert, the local officers say that the exact time will be announced later.

HOLMES BELIEVED A FORMER CONVICT

SALEM, Ore., Aug. 1.—Little doubt exists with authorities at the state penitentiary that George Holmes, who was shot and killed in a fight at North Bend, is the same George Holmes who was paroled from the state penitentiary here, February 14, last. The dead man is said to have been from Longview, Washington, and when Holmes left the prison he said he was going to Longview, where he had a position. In one letter to the parole officer he said he was married. The description of the dead man tallies with that of the former convict. Holmes was sent to the prison from Multnomah county to serve two years for forgery.

OFFICIALS SURVEY PROPOSED RAIL LINE

Blankenburg of Tulsa, declared today that she will carry her fight to the highest court in the land to prove that she is the daughter of Lotta Crabtree and is entitled to share in the actress' \$3,000,000 estate. After Judge Prest denounced Mrs. Blankenburg as a perjurer in Suffolk probate court, he cited her and her brother, John W. Crabtree, to appear to answer contempt charges next Tuesday. Immediately all of Mrs. Blankenburg's attorneys withdrew from the case.

"I am the daughter of Lotta Crabtree," the woman said. "If they want to put me in jail, simply because I have refused to deny my own mother, very well, but in the end 'right will prevail.'"

Before citing Mrs. Blankenburg and her brother in contempt, Judge Prest said: "The case of Ida May Blankenburg is pockmarked with fraud. There is no mistaking it. The spots of fraud are so thick and so plainly visible as the ticks on the flyleaf of the Bible on which fraudulent entry recently written of Lotta's marriage and the claimant's birth.

"This claimant swears that she made extended trips with Lotta yet she could not even identify Lotta's Helioke photograph. This woman swears that Lotta sang to her a lullaby and read to her bedtime stories.

"But in my opinion she never saw Lotta face to face, and since Lotta's death she has heard stories that have made her and her agents lust for money—stories that so influenced her as to deny her parents in order that she might rob disabled veterans of the World war of the benefits of the trust fund in this estate.

"I justify these words that fly on the ground that Ida May Blankenburg and her agents have corrupted, I believe, some of the witnesses and that she and her brother, John W. Crabtree, have sworn falsely."

APPORTIONMENT SCHOOL MONEY TO COUNTIES GIVEN

SALEM, Ore., Aug. 1.—G. G. Brown, clerk of the state land board today announced the annual net apportionment to the counties of interest from the state school fund to be \$273,273.50, which is \$18,089.54 less than in 1924 and \$27,026.01 less than in 1923. The decrease is due to the increase in the number of persons of school age in the counties, the apportionment being made on a per capita basis. In 1924 the total was \$291,363.04, with the total number of persons of school age 238,626 and the per capita \$1.64. In 1923 the total was \$400,299.51, with the total persons of school age 231,387 and the per capita \$1.73. This year the persons of school age in the state number 448,849 and the per capita is \$1.50.

The apportionment include the following counties: Benton, \$7,321.50; Coos, \$14,205; Crook, \$1,423.50; Douglas, \$10,251; Jackson, \$11,944.50; Josephine, \$4,317; Klamath, \$6,448.50; Lane, \$20,541; Marion, \$23,644.50; Multnomah, \$112,377; Umatilla, \$10,801.50.

LIGHTNING STARTS ONLY ONE NEW FIRE

PORTLAND, Aug. 1.—Many lightning bolts struck in the Mt. Hood region in an electric storm last night, but forest lookouts had reported only one fire this morning. The fire was on Cedar Swamp Creek, and was expected to be brought under control today.

The new Wind River fire, at Pilot Knob, Washington, had burned over 200 acres late yesterday. A crew of 118 men were fighting the blaze. This fire was believed to have been started by a smoker.

The old Wind River fire, which has burned over about 4,000 acres was reported today practically under control.

Fire which broke out Thursday night burned over logging slashings of the Rock Creek Logging Company near Vernonia and went into an old burn. Two donkey engines and a railway trestle were damaged. Employees of the Rock Creek and East Side Logging Companies and Columbia County Fire Protection Association men are fighting the blaze.

HOP PICKING WILL START AUGUST 5
