## REPUDIATION OF KEARNS REPEATED BY JACK DEMPSEY

LOS ANGELES, Cal., Aug. 17.—If Jack Kearns persists in his efforts to represent Jack Dempsey in negotiations for a bout with Harry Wills, negro contender, the heavy-weight champion will cast aside his gloves and forget about fighting until his present contract with Kearns expires. Dempsey made this clear in a statement to the Associated Press.

"I understand that Kearns and the New York boxing commission are to meet today to have forfeits posted for a match for me with Wills.

"I take this means of announcing again to the boxing commission that Kearns has no authority to sign for me and anything done by him in my behalf cannot bind me.

"I state for the last time, that I am determined to do my own match making, but reiterate my word to give Kearns his 35 per cent cut during the life of our contract.

"If they go through with their plans today and Mullins signs for Wills, covering Kearns' forfeit, Mullins will lose the match and I will not fight anyone until that contract (the Kearns contract) runs out on September 1926) is expired, which will cause Kearns the loss of a few hundred thousand dollars."

NEW YORK, Aug. 18.—Tex Rickard, fight promoter and Jack Kearns, manager of Jack Dempsey, each posted a \$25,000 forfeit this afternoon for a Dempsey-Wills match. This action was taken immediately after the New York athletic commission had re-investigated Kearns and granted him a license to do business within this state.

Paddy Mullins, manager for Wills, is expected to post Wills' forfeit for the same amount this afternoon. The commission ruled that in case Dempsey refused to live up to the terms signed by Kearns, that Mullins could claim the \$25,000 forfeit posted by Kearns. It was made known that Kearns signed definitely for a Dempsey-Wills fight with Rickard yesterday.
