PORTLAND, Ore., Aug. 19.—The home nest of the Order of Owls, in South Bend, Ind., has appealed to the government, through the local federal court, for a hearing to determine whether the keep-growing-wiser order of Hoot Owls, radio fanmakers, shall be permitted to keep the word "Owls" in its name.

The complaint, filed today, recites in detail its reasons for believing that "the light and frivolous character of the keep-growing-wiser order of Hoot Owls is injurious to the original Fraternal and Benevolent Order of Owls, and creates confusion in the minds of the public."

The complaint gives the titles of the Hoot Owl officers, such as Grand Sereech, Grand Scream, Grand Skippano, Grand Slumber, etc., and declares these cast reflections upon the dignity of the real title of the real officers of the Fraternal and Benevolent Order of Owls.

The plaintiffs ask that Edgar B. Piper, the Oregon Publishing company and members of the degree team of the Hoot Owls be decreed to answer the sundry allegations in the complaint.

(Continued from page 1.) Portland continued, with police today facing another day of alarms and "hot tips" that all ended in nothing. Local police scoff at the report from Centralia, Wash., that a truck driver had been fired on by three men in a roadster.

If that had been Murray, Kelly and Willos, they wouldn't have wasted a bullet," said one officer. "They would simply have stopped the truck. I rather imagine a flying pebble went through the truck's windshield."

A report that a registered letter bearing handwriting similar to that of James Willos had been sent to a girl at a Portland address, is being investigated today. The girl is said to be out of the city.

Murray's Home Watched. SEATTLE, Aug. 18.—The three escaped slayers from the Oregon state penitentiary, Tom Murray, Ellsworth Kelly and James Willos, are headed for this vicinity and plan to visit the parents of Murray who live on Bainbridge Island in Puget Sound, west of Seattle, was the belief expressed by police here tonight.

All roads to Seattle were heavily guarded and sheriff's deputies went to Bainbridge Island to be in readiness to close in on the convicts should they appear.

Curious Driver Shot At. TACOMA, Wash., Aug. 19.—Tacoma police officers here Wednesday were notified that three men were to be the trio who escaped from the Oregon prison last Wednesday night had fired on a truck 10 miles north of Centralia at midnight.

The report came from peace officers at Chehalis, who stated that Charles Taylor, a truck driver for a Puget telephone firm, noticed an automobile roadster standing near an oil station while he was going to Chehalis. As he slowed down out of curiosity he obtained a good view of the three men, he stated, and declared that they closely resembled newspaper photographs of the escaped convicts.

Apparently believing the truck was stopping, one of the trio fired at the driver, the bullet penetrating the windshield and passing close to Taylor. As Taylor sped up at this hint he looked back and saw the roadster get under way heading north.

Olympia Organizes Posse. OLYMPIA, Wash., Aug. 18.—Informed over the long distance telephone by Warden A. M. Dalrymple of the Oregon penitentiary at Salem that the three desperadoes who effected their escape last Wednesday were probably headed towards Olympia, Chief of Police C. H. Hansen and Charles Jackson, sheriff of Thurston county, were hastily organizing a posse at noon today to guard roads leading into Olympia from the south.

Warden Dalrymple informed local peace officers that three men who were seen washing up at a camp ground near Kelso this morning were heard to say that they intended to go either to Olympia or Shelton. All were reported as heavily armed. They were driving an old Ford touring car, it was said.

Pendleton Gets Excited. PENDLETON, Ore., Aug. 19.—Three men, claimed to closely resemble Murray, Willos and Kelly, accompanied by a woman, were seen in Umatilla last night, according to reports reaching here. A store was reported robbed during the night at Irrigon, near Umatilla. The sheriff's office is working on the case and finger prints found will be examined.
