**WASHINGTON, Oct. 2.**—A reduction in freight rates on automobiles and automobile parts moving from Detroit territory to all points on Northwestern Pacific railroads north of Willets, Cal., was ordered today by the Interstate Commerce commission.  
Jobber's supplies are limited. Although good buyers are not offering over 23 cents for the remaining bales unsold in this state, holders are not considering anything under 25 cents. Approximately 11,500 bales are unsold. Fuggles are scarce and firm at 28 cents.
