OFFICIAL BLAME FOR WRECK MAY BE GIVEN LANSDOWNE

(Associated Press Leased Wire.) LAKEHURST, N. J., Oct. 3.—The Shenandoah naval court of inquiry is to give immediate attention to the question of whether blame attaches to Commander Zachary Lansdowne, captain of the airship, for the disaster which cost his life and that of 13 other men.

This was decided on at an overnight conference between the court and Judge Advocate Poley. This phase of the inquiry will delay until Monday the winding up of the hearing here and the removal to Washington.

An opinion that a primary cause of the wreck was the failure of the officers in charge to observe obvious danger signals has been given by Captain Anton Heinen, a former German Zeppelin pilot. He is regarded in navy airship circles as one of the ablest of dirigible pilots.

His theory finds some indirect support in the testimony of Lieutenant Joseph R. Anderson, aerologist on the Shenandoah, that when he saw storm clouds moving in opposite direction in the wind in which the airship was bucking, he advised a change of course to the south and Commander Lansdowne ignored that advice.

PORT ARTHUR, Tex., Oct. 3.—Opinion that the ill-fated Shenandoah would collapse exactly as it did collapse, if it encountered a line squall was expressed by Commander Zachary Lansdowne to Captain George J. Meyers in command of the airship tender U. S. S. Patoka. Captain Meyers said here last night. The Patoka was in harbor here.

When shore press dispatches concerning the Shenandoah inquiry he expressed indignation that Commander Lansdowne should be blamed for the disaster. "He discussed with me on more than one occasion the danger to the Shenandoah from line squalls and thunderstorms," Captain Meyers said. "At our last conference on August 15, aboard the Patoka, Commander Lansdowne expressed himself as against the proposed trip of the Shenandoah to state fairs in the middle west."
