EXPANSION OF BROCCOLI CROP DISCOURAGED

Industry has Reached Limit With Present Facilities, Committee Says.

WANT MORE TRACKS

City Council Asked to Give Aid—Prune Committee Favors More Petite Orchards.

Further expansion of the broccoli industry in Douglas county is not advisable under the existing high cost of production, the vegetable crops committee reported last night in the concluding hours of the agricultural economic conference. The enlarged acreage of the past two years, and the problems pertaining to the handling of the crop, the lack of facilities for handling, all discourage further expansion, the committee reports.

The report is as follows:

Your committee appointed to investigate and consider problems relative to the growing and marketing of vegetable crops in Douglas county hereby submit the following report.

The Situation

At the present time the production of vegetables in the county is confined to the business of growing these crops for the various city markets of the county as well as some outside markets which are supplied with vegetables in less than car lots. One vegetable, however, namely, Broccoli, is at the present time grown in quantities for car lot shipments and inasmuch as this crop is widely grown and conceded to be one of the best cash crops in the county it has received the greatest part of the consideration of your committee.

Broccoli

Not since the beginning of the broccoli industry in the county has there been such an acreage as is now growing. In view of this greatly enlarged acreage and problems pertaining thereto chiefly with respect to the marketing of the crop, as a committee call your attention to the following recommendations and suggestions.

1. Based on approximate costs of production it is our belief that no grower of broccoli can expect to show a profit in his business if the yield is less than 150 crates of No. 1 broccoli per acre.

In view of the estimated high cost of production, we firmly discourage any expansion of the broccoli industry except on land well drained, in good physical condition, and that has proved to be sufficiently fertile to produce a satisfactory crop.

2. We recommend that special care be given by growers in the grading and sizing of the heads and that no broccoli classed as No. 1 grade shall be any smaller than 14 heads to the crate, also that no No. 2 grade be shipped in cars unless market conditions warrant such shipment.

3. We recommend that the matter of shortage of trackage for car loading be taken up with the Roseburg city council and the Southern Pacific railroad in view of the greatly increased facilities necessary this coming year for the loading of cars.

4. Appreciating the fact that a visible supply of ice for prospective requirements is entirely inadequate for the needs of the crop, we as a committee call the attention of this matter to the officials of the Southern Pacific railroad company.

5. We favor government inspection of cars such as is necessary so that at all times the broccoli shipped may maintain a high standard of grade.

6. We recommend that assistance be requested of the U. S. D. A. bureau of agricultural economics in the matter of furnishing news service and market reports with a view to better and wider distribution of cars of broccoli.

7. We favor a greater investigation of ways and means whereby the broccoli not shipped may be utilized in some profitable form and we appoint a committee of three, Messrs. Butler, Wood and Nichols to investigate the possibilities of broccoli in relation to the crop as a whole.

We understand that the local dairy is in a position to handle broccoli for canning up to 4 to 5 thousand cases.

8. We recommend that in view of a possible shortage of labor at the time of marketing the prospective crop of 1926, fruit packers, both men and women be encouraged.

FASTER BECOMES CRAZY AT SIGHT OF GIRL EATING

VON HINDENBURG'S SUPPORT OF PEACE PACT DRAWS FIRE

BERLIN, Nov. 21.—General Erich Ludendorff is attacking his war time chief, President von Hindenburg, for supporting the Locarno treaty. But since the Socialists in the Reichstag have definitely decided to vote with the government to accept the treaties, it seems certain that a representative of the Reich will be in London when the documents are signed formally to give his country's adherence to them.

General Ludendorff, who was first quartermaster general and von Hindenburg's chief of staff during the World War, has delivered a broadside against von Hindenburg which it is thought will sever the friendship existing between the two famous soldiers. A statement from Ludendorff in the Munich Fascist newspaper says: "I once shared honor and fame with v. Hindenburg. I may even say that I contributed to increase his renown. Today my German heart aches to see how the field marshal is ready to sacrifice his fame by signing a document which will bring dishonor. Rather let him resign his post than renounce the glory of his past."

\$75,000 WORTH OF STAMPS IS BOOTY FROM POSTOFFICE

SUPERIOR, Wis., Nov. 21.—Robbers early today looted the postoffice here of nearly \$75,000 in stamps and \$125 in cash, after binding members of the family of C. J. McGill, assistant postmaster, to a chair and robbing him of the combination to the vault.

The robbers early last night went to the McGill home, bound several members of the family, waited for others to return, secured them and then forced from McGill the combination of the safe and compelled him to turn over keys to the building and inner compartments of the safe.

MRS. THAW'S GRANDSON MAY HAVE TO RETURN FORTUNE

RELIGIOUS GLENDALE, FOLK ASK PARADISE FOR GAME LAW VIOLATION

PORTLAND, Ore., Nov. 21.—Southern Oregon seems to be undergoing a religious revival, according to State Game Warden E. F. Averill. He has received four letters within the last few days telling of conversion and asking forgiveness of the game commission and the state for breaking of game laws. The first letter came several days ago from Grants Pass. Friday Averill received two letters from Glendale and one from Ashland. In a postscript on one letter, the wife added her confession to that of her husband.

WOODWARD WINS FROM WOODS ON DECLARED FOUL

Portland Boy Stages Great Contest Against Big Weight Handicap.

FIGHT GOES 8 ROUNDS

Dundee Gains Unpopular Decision Over Boles in Battle Crammed With Action.

In the main event of the classiest ring card ever held in the city, a card that kept seven hundred fans at a high pitch of excitement for nearly two hours at the armory last night, Ernie Woodward, of Portland, won a decision over Specs Woods, of Bend, on a questionable foul in the eighth round; and in the semifinal, which went the six-round limit, Charley Dundee, of this city, got the call over Ace Boles, of Marshfield. The first decision was popular, the second was not.

Woodard's weight was announced as 145, and he looked lighter; Woods' weight was given at 153 and he looked heavier. Against this handicap of poundage, Woodward gave an exhibition of gameness and cleverness that completely erased any unfavorable opinion of his fighting qualities that might have been formed from his defeat by Cal Herman in this city two months ago. In the minds of the spectators at the opening of last night's bout it seemed to be only a question of how long Woodward would be able to last. He managed, however, to hold his own for the first four rounds, but in the fifth he took the count of nine on one knee, and the crowd got ready to cheer brief confusion. Referee Bill Kepper raised Woodward's arm aloft as a signal of victory. The gong sounded a few seconds later.

Woods made a vain protest against the decision while the crowd shrieked with delight. The blow in question was not the out-of-law rabbit punch nor any other kind of a foul, according to no less authority than Bert Tribbey, the Marshfield pugilist, who was one of the designated judges at the ringside, but whose verdict was not requested by the referee. Spec fought clean enough to refrain twice from hitting Woodward when he was turned around, and each time his reward was a salvo of applause. The crowd wanted Woodward to win, however, because of the weight handicap and it was useless for Spec to protest the declared foul in the face of such sentiment. The questionable nature of the decision in no wise detracts from the credit due Woodward for his fine showing. He appeared to be going as good as Spec after the fifth round and had he maintained the pace to the ten-round limit he would have earned a draw at least.

After robbing Lewis of all the money he had, the bandit tore out part of the distributor on Lewis' machine, and then climbed back in the car with his companion, who had not left the hold-up auto. The bandit car then sped on its way, with its lights out.

DOLLAR MAKES BID FOR FIVE VESSELS (Associated Press Leased Wire.)
WASHINGTON, Nov. 21.—A bid of the Dollar Lines for charter and purchase of the Admiral-Oriental Line, running from Seattle to the Far East, was submitted to the Shipping Board today by R. Stanley Dollar.

The offer is for charter of the line for five years at an aggregate sum of \$300,000 and purchase of the five vessels at the expiration of that period for \$3,000,000. The board is expected to consider the offer next week.

DEATH TAKES CLARA MORRIS, 79 YEARS (Associated Press Leased Wire.)
NEW CANAAN, Conn., Nov. 21.—Clara Morris, originally Morrison, once acclaimed as the greatest emotional actress of the English speaking stage and later as "the woman of sorrows" because of her illnesses and financial reverses, is dead of heart disease at the age of 79.

Sarah Bernhardt, witnessing a Clara Morris performance in the heyday of her career, exclaimed: "That woman is not acting. She's suffering." Miss Morris said of herself a few days before her death, "I am only the famous actress who only had one husband and never knew any family troubles."

Miss Morris' husband, Frederick C. Harriott, died in 1914 and, as far as is known here, she is not survived by any relatives.

CHINOOK EGGS ARE BROUGHT TO NEW UMPQUA HATCHERY (Associated Press Leased Wire.)
R. E. Clanton, director of commercial hatcheries and M. M. Ryckman, state superintendent of game hatcheries, were in Roseburg today on their way back to Salem after a trip to Curry county.

They brought in a large shipment of spring Chinook eggs, which have been placed in the new North Umpqua hatchery.

Five years ago some spring Chinook eggs were taken from the North Umpqua to the Tillamook hatchery. This year there was a big run of Chinook salmon in the Tillamook river, and having a surplus of eggs, an shipment was brought to the North Umpqua hatchery.

The hatchery superintendents report that the commercial and game organizations are now working in close harmony and that affairs all over the state are in very good condition.

Grange's College Fairwell. COLUMBUS, Ohio, Nov. 21.—The magic number "77," cut in orange and blended in blue, moves for the last time in University of Illinois football contests today.

Harold "Red" Grange, the super-untamed terror of the chalk lines, will wear that famous number just as he has worn it while streaking yardage in the most remarkable and spectacular football career the game ever has known.

When Grange leaves the park between Ohio State and Illinois, he will be on his way to the show-biz knowing that his intercollegiate career is ended and with prospects of earning a fortune playing professional football, if he chooses.

With no championship involved and with both Ohio State and Illinois out of the running, the game nevertheless will attract a record-breaking crowd of probably 80,000 spectators.

Grange to Tour South. OHIO STADIUM, COLUMBUS, Ohio, Nov. 21.—Captain "Red" Grange finished his brilliant intercollegiate gridiron career today by leading Illinois to a 14 to 9 victory over Ohio State before a record-breaking crowd of 85,500 spectators.

Grange told a Columbus Dispatch reporter after the game that he would lead his own professional team in the south for a series of games. Grange said that Britton is the only man that he is positive is going with him.

SALEM GRANGE ASKS SECRET VOTING IN LEGISLATURE (Associated Press Leased Wire.)
SALEM, Ore., Nov. 21.—A resolution attacking methods used by the state legislature in passing legislation, declaring the long rolling and other methods have frequently resulted in the passage of poor bills and the neglect of desirable legislation, was presented by the Salem grange at its meeting here this afternoon. The resolution demanded that in future all voting by the legislators be secret, with votes made public after their completion.

COLLISION SANK SUBMARINE THAT CARRIED DOWN 68

LONDON, Nov. 21.—Loss of the monitor submarine M-1, with 68 lives, last week now appears to have been due to a collision with a Swedish steamer, the Admiralty announced today.

Information sent by the captain of the steamer Vidar, now at Stockholm, that he felt a shock at the time and in the vicinity of the submarine's disappearance leads to the conclusion that the M-1 struck the Vidar and sank immediately. The Admiralty statement was issued after an examination of the Vidar's hull. The Admiralty thinks the collision occurred while the submarine was submerged and adds:

"Under the circumstances it is certain that the M-1 was rapidly and completely flooded and that the crew perished immediately."

The Vidar is a freighter of 2159 gross tonnage.

GANGSTER SHOTS WITNESS IN COURT ROOM AT CHICAGO

Slayer Is Brother of Two Men Assassinated in Previous Stages of the Feud.

CHICAGO, Nov. 21.—Gangland brought its feud into a coroner's court today when Sam Vincel brother of two victims of assassins shot and killed John Minatti, a witness. Minatti had just testified that he did not know Mike Vincel who was shot down last Thursday. Sam Vincel, brother of Mike, jumped to his feet and opened fire.

Another brother, Jimmy Vincel, driver of the auto in which "Bossy" Knight, slucker and gunman who was killed a few years ago, was slain more than a year ago.

The shooting precipitated the flight of witnesses and a crowd of the curious, but Vincel was seized and locked up. His victim expired in an ambulance.

The slain man was one of several suspects arrested after the shooting of Mike Vincel. He was a fruit store owner and was accused by Sam Vincel of having "made moonshine" with Mike Vincel.

CONDUCTOR HELD AFTER BRAKEMAN DIES OF SHOOTING

PASCO, Wash., Nov. 21.—John Covington, conductor for the Oregon-Washington Railroad and Navigation company, was arrested yesterday in connection with the death of David Coulter, a brakeman of the Spokane, Portland and Seattle Railway yesterday morning at Plymouth, near here. Sheriff's officers charge that Covington shot Coulter after Coulter had broken in the door of a station when he found it locked with Covington and Mrs. Bernine Wright, S. P. & S. operator inside.

Covington is in jail at Kennewick. Mrs. Wright was not held by the officers.

RIOT AT OREGON PENITENTIARY FILLS BULL PEN

Demonstration Staged Out of Sympathy for Four Condemned Men.

PRISON MADE BEDLAM

Fellow Prisoners Consider Constant Confinement of Murderers Is Ill Treatment.

(Associated Press Leased Wire.)
SALEM, Ore., Nov. 21.—The "bull pen" at the state penitentiary is filled to within one of its capacity, it became known today, as a result of a noisy riot in which 15 or 20 convicts participated last Sunday night. For about an hour, according to official information, the convicts turned the prison into a bedlam by yelling and pounding on the walls and doors of their cells. Three windows were broken, presumably by tobacco tins being thrown from the cells.

The tumult was quelled when eight of the leaders were rounded up by guards and chucked into the bull pen where they are still being kept in close confinement. The bull pen now has a population of 75 and its capacity is only one more.

The motive, based on the demonstration by the prisoners appears to have been one of sympathy for Frank Fallon, who was on bread and water in the dungeon, and for Tom Murray, Ellsworth Kelley, James Wilson and W. R. Lloyd, all of whom are under sentence of death. It was the conviction of the rioting convicts that the condemned men should be turned into the yard along with the other convicts during the day and not be kept constantly in their cells.

Fallon Held to Blame. It is believed the riots started with Fallon. He is the convict to whom Nagel Sorbus, a few weeks ago, attempted to smuggle a gun from outside the walls, some of the officers believing the gun was really intended for Tom Murray, who was then on trial for murder in connection with the prison break of last August 12.

Immediately after the gun smuggling incident Fallon was sent to the bull pen. Some time prior to last Sunday he became obstreperous in the bull pen and was put on bread and water in the dungeon. He is said to have tried to tantalize the guards by yelling and otherwise misbehaving. From the location of the dungeon in the bull pen it is believed Fallon himself might have started the clamor by the convicts last Sunday night.

Among other things charged to Fallon is that he sent word to Deputy Warden Little that he was ready to cut him up if he got the chance. Fallon is under sentence for robbery committed in Multnomah county.

The trouble Sunday night started shortly after the lights had been turned off in the cells at 9 o'clock.

STATE ROAD FUND SUIT BODIES ILL FOR MA FERGUSON

DALLAS, Texas, Nov. 21.—Governor Miriam A. Ferguson for the second time in a few weeks today faced the possibility of a special session of the legislature to investigate her state departments. Representative T. Irwin of Dallas used the word "impeach" in a special session of the legislature without naming any state department or officer. He issued the call, he said, "to impeach any state officer who has aided or abetted in any way this gigantic fraud on the people of the state."

Irwin said he referred to the highway situation. The call follows judgment for \$600,000 rendered yesterday by the district court at Austin, Texas, against the American Road company in the suit brought by Attorney General Dan Moody to cancel the company's road contracts in this state.
