SARGENT MEMO ON ALUMINUM CO. IS PROBED

Message Addressed to Col. Donovan Asked for No Publicity.

CAN'T REMEMBER

Attorney General Says He Does Not Have Any Recollection of Memo.

(Associated Press Leased Wire.)

WASHINGTON, Jan. 21.—Attorney General Sargent and his chief assistant, William J. Donovan, were recalled by the senate judiciary committee today for further examination concerning Mr. Sargent's memorandum of March 25, 1925, dealing with the department of justice inquiry into the practices of Aluminum Company of America.

The memorandum, addressed to Colonel Donovan, directed that there be no action or publicity in the case until a report had been made to Mr. Sargent. Secretary Mellon is largely interested in the Aluminum Company, which is charged by federal trade commission with violation of a federal court decree.

"Has your recollection concerning this memorandum been refreshed since you last appeared here?" asked Senator Walsh, Democrat, Montana.

"It has not," Mr. Sargent replied. He added that he had tried to recall the circumstances of the preparation of the memorandum, but had been unable to do so. He was excused after having been on the stand only five minutes.

Mr. Donovan then testified that the memorandum never had been filed in the department; that a copy was filed, and the original was sent to the anti-trust division of the department.

Mr. Donovan said the memorandum was turned over to John L. Lott, in charge of the Aluminum case.

With Lott on the stand, Senator Walsh called attention that when Donovan furnished the committee with a list of all correspondence pertaining to the Aluminum cases, the March 25th memorandum was omitted.

"That memorandum was sent to me and I kept it in a special envelope in my office," Lott said. Lott explained that he frequently kept original copies of orders so as to save him some time in referring to them.

The Roseburg high school basketball team will play its first conference game in this city on Friday evening, meeting the Ashland basket toasters. This is the opening game of the southern Oregon conference and as Ashland and Roseburg are old rivals, and both always have good teams, an interesting game is anticipated.

The Roseburg team has made a far better showing so far than had been anticipated by the fans of the city. The local high school is in a slump period so far as athletics are concerned. Such periods often occur in school life and must be reckoned with.

For some unknown reason the school's athletes are all small in stature and light in weight. Naturally they face a great handicap in meeting teams where larger boys are included. In football during the past season the high school suffered many defeats, although the team demonstrated a fundamental knowledge of the game in many respects superior to many of their victorious opponents. Lack of weight, and inexperience, however, gave the school a very poor season.

Prospects at the outset of the basketball season were very discouraging. The players are under average height and weight for basketball teams of high schools the size of Roseburg, and none of them has had any great amount of previous experience. Fans have been expecting the school to suffer many defeats, but it now appears that such is not to be the case.

What the team is lacking in height and weight and experience it is making up in pure fight, determination and team work. If the value of teamwork and coordination was never before plainly demonstrated the high school this year forms a real example.

Fighting a physical handicap the team has made an unusually fine showing. In every game played so far they have demonstrated a passing ability that has carried them safely through many dangerous spots, and their defense has been somewhat weak in basketballing, but is showing improvement with every game.

Under the directions of Coaches Doubt and Larson the boys have formed a team in which individuality is lacking and in which coordination is the keynote.

They may not win the southern Oregon championship as fans hope they will, but at least Roseburg will have a team of which she has no need to be ashamed.

REGULATION OF ROADHOUSES IS SHERIFFS' CRY

Oregon Association Wants Law That Places Will Close at Midnight.

MEET ATTORNEYS

Pass Resolutions of Sympathy to Families of Stricken Sheriffs—Other Groups Meet.

PORTLAND, Ore., Jan. 21.—A state law that would close road houses at midnight, a standard of salaries making them the same in counties of like population, and acceptance by county commissions of state compensation for peace officers were urged in resolution by the state Sheriffs' association today.

The resolutions were passed just prior to the opening of the joint session of the sheriffs with the district attorneys' association and the Association of County Judges and commissioners.

The sheriffs also passed resolutions of sympathy to the families of E. P. Ellington, sheriff of Coos county, who was killed in a wreck, and S. N. Warfield, sheriff of Benton county, who died of heart disease just following the sheriffs' convention here last year.

The proposed law directed against road houses would place the same regulation against the dancing and amusement features of 'road houses, irms and taverns,' as would hold against the dance halls.

The County Judges' and Commissioners' association late yesterday favored legislation that would require auto owners to pay an additional tax of 1 cent a gallon gasoline for county road purposes. It was pointed out that present state gasoline tax of three cents a gallon reverts to the state and that the counties, as such, receive no direct benefit.
