## SALEM SHOOTERS SPURT TO LEAD IN TRI-CITY FINALS

SALEM, Ore., April 5.—The Salem Rod and Gun club upset the dope in the final shoot of a tri-city event at Corvallis yesterday, nudging out the leading Eugene sportsmen for the tri-city title. When the shooting started yesterday, Salem was 29 birds behind and Corvallis 24 birds behind Eugene. Figuring on a sure win Eugene sent only five men to Corvallis. Salem got 444 birds out of a possible 600, making a total score of 2742 out of a possible 3,000. Corvallis finished the series second with 2713 and Eugene third with 2528.

## BASKETEERS OF BLIND SCHOOL WIN HALF-TECH GAMES

JACKSONVILLE, Ill., April 3.—The boys basketball team of the Illinois school for the blind closed its winter season with six victories out of 12 games against opponents with full vision and a total of 166 points scored to 21 for their opponents.

With an average of only 15 per cent of normal vision, the blind boys took up basketball last December and developed the short pass, the dribble, close guarding and short shots for the hooper with great effectiveness.

The star forward with but one eye and only partial vision in that one, played all 12 games and scored 84 points a game.

The rosters, themselves without vision or nearly so, are kept advised of their team's movements on the floor by a play-by-play account from the cheer leaders and their rooting is thus, entirely normal.

### NETTING OF STEELHEADS FOR SALMON FEED PROTESTED

MARSHFIELD, Ore., April 5.—Sportsmen of Curry county have entered a protest against the netting of steelhead trout near the mouth of Rogue river, which are alleged by the red and gun club to have been fed to the 4,000,000 Chinook salmon fry at the Indian creek hatchery. The hatchery is two miles from the ocean and it was not clear whether it now belongs to the state or the Macleay estate.

The red and gun club passed resolutions objecting to this practice and also objecting to the naming of B. K. Lawson as representative of the Coos and Curry Game Protection association. Appeal has been made to State Warden Averill.

## FORMER RESIDENT OF WILBUR DIES FROM INFLUENZA

Nolan Grubbe, for more than forty years a resident of Douglas county, died on Saturday at La Crosse, Washington, following a severe case of influenza. The body was brought to Roseburg yesterday and interment services were held this afternoon at 2:30 o'clock at Wilbur, where the deceased made his home for many years.

Mr. Grubbe was 68 years of age, a native of Douglas county, being the son of Mr. and Mrs. Nelson Grubbe, pioneers of 1852. He attended the old Umpqua Academy and then engaged in farming at Garden Valley. He was married in 1878 to Esther Morehouse, a member of a pioneer family. In 1900 he moved to Pendleton and recently into Washington where his death occurred.

He is survived by the widow and four children, Albert Grubbe of Chehalis, Mrs. Eva Thompson of Wilbur, Gertrude Stanford of La Crosse, and Elgin Grubbe of Seattle. He also leaves five brothers and two sisters, and a number of more distant relatives.
