BUD TAYLOR GETS ONLY EVEN HONORS AGAINST HELLMAN

(Associated Press Local Wire.)
PORTLAND, Ore., June 26.—Chuck Hellman, "clever Portland bantamweight, battled Bud Taylor, Terre Haute, Ind., contender for the world title to a ten-round draw here tonight.

The decision was unpopular with newspaper men and ringsters who gave Taylor five rounds, Hellman one and called the other four even. Hellman's best round was the second when he kept Taylor away and bombarded him with a barrage of lefts and rights. Taylor came back in the next four frames and left the game Hellman gasping from the effects of his murderous right.

Ray Burrer, Globe City heavyweight, knocked out Young Jack Dempsey, Tacoma, in the second round of the scheduled six-round semi-windup and Denny Wolf, Los Angeles welterweight, took a four round decision over Al Gracie, Spokane.

Results at Eugene.
EUGENE, June 26.—Ansell Bell, who claims New York as his home, and Tommy O'Brien, of Portland, battled to a ten-round draw in the main event of a special boxing card for the Elks here last evening. O'Brien weighed in at 124 and Bell at 126.

The two went at it from the start, and the bout was popular with the fans.

Tommy Howe of Portland tossed his own towel into the ring after making it for a while with Harold Davis of Eugene, and Davis was given the bout a technical knockout. Howe went to his corner when the gong sounded, picked up a towel, hurled it into the ring, and left for his dressing room. Billy Wilburn knocked out Neal Long in the final round of a four-round event.

Tod Morgan Whipped.
BOSTON, June 26.—Tod Morgan of Seattle, Wash., junior lightweight champion of the world, was defeated by Babe Herman of Los Angeles in a 10-round bout here Thursday night. Morgan's title was not at stake, but Herman won a clear-cut decision over the champ.

After an even first round, Herman stepped out and piled up a good lead on points, flooring his rival in the third round. Morgan, however, was on his feet before any counting was done. Morgan rallied in the late rounds, but Herman's lead was too much for him to overcome.

Dundee Whips Walker.
NEW YORK, June 26.—Under the pale glare of Madison Square Garden's ring lights, Thursday night walked the shadow of a once great champion and was forced still further back into fette oblivion.

Mickey Walker, former welterweight champion of the world, fighting for his pugilistic life, was beaten and bruised by Joe Dundee of Baltimore and was traveling toward a still worse beating when Referee Eddie Forbes stopped the fight in the eighth round of a scheduled 10-round mix.

Wool Market Displays Increasing Strength

BOSTON, Mass., June 25.—The Commercial Bulletin tomorrow will say:

"While the demand for wool may have been somewhat smaller in the eastern seaboard markets this past week, the market itself is unquestionably a bit stronger and prices have advanced slightly over the values obtaining a week ago, possibly a cent a pound in the green, while operations in the east in the new clip have been accelerated with the tendency of values against the buyer."

"While certain manufacturers loudly deplore the advancing tendency in wool, there seems no good reason to doubt that the situation in the goods market is fairly healthy and that the outlook is better."

THE GIST OF THE BIBLE BOOK BY BOOK
By ALVIN E. BELL, D. D.
ARTICLE No. 24
JEREMIAH—"THE WEeping PROPHEt"

Jeremiah was more than a prophet. He was a statesman, a patriot and a martyr. His was the sad ministry of accompanying a doomed nation to the death-chamber for its execution.

He prophesied during the reign of the last five kings of Judah, the good king Josiah and his three wicked sons and grand-sons, Jehoahaz, Jehoiakim, Jehoiachin and Zedekiah.

For a half century Jeremiah ceased not to warn king and people alike, even with tears, of the doom and destructions which must come upon them for their perverted idolatry.

But, despite his warnings and the sad experience of the captivity of the northern kingdom of Israel in 721 B. C., they rushed on to a like fate and God raised up Nebuchadnezzar to destroy Jerusalem and carry the people away into captivity in Babylon for seventy years.

This captivity which Jeremiah prophesied so clearly and repeatedly came in 586 B. C., for with nations, as well as with individuals, "the wages of sin is death."

Jeremiah is called "the weeping prophet" from the way he poured out his soul in tearful pleadings and bitter lamentations in his effort to avert the captivity and destruction of his beloved people.

But his message to King Jehoiakim was cut into pieces and burned in the fire, a treatment of the Word of God not greatly different from that accorded it in some quarters today when it runs counter to the notions of the wilful and self-indulgent.

The prophet is charged with treason and with weakening the hands of the defenders of Jerusalem, and imprisoned and thrown into a filthy pit to die, had he not been rescued by his friends.

The burden of his message is embodied in the vision given him in the house of the potter. There in the vessel of clay whirling on the wheel, and marred in the hand of the potter, he saw the sad outcome of the Divine Potter's efforts to make his nation a vessel of beauty and usefulness.

The vessel that made of clay was marred in the hand of the potter; so he made it again another vessel, as seemed good to the potter to make it." (48:2.)

This remaking of the marred vessel is the message of hope Jeremiah saw and preached through his tears.

God would not utterly destroy his people, but would bring them back after the seventy years and "make it again another vessel."

Jeremiah's passionate love for his people and his desire for their salvation, his rejection by his own people, and his own suffering and destruction, remind us of the greatest of all Judah's prophets, Jesus of Nazareth, who "when He beheld the city wept over it" and said, "O Jerusalem, Jerusalem, thou that killest the prophets and stonest them which are sent unto thee, how often would I have gathered thy children together even as a hen gathereth her chickens under her wings, and ye would not."

WASHINGTON, June 26.—The Ku Klux Klan, the churches and the wets and dries, and all others whose organized influence has been felt in senatorial elections will be asked to testify about their activities before the senate funds committee.

This announcement was made today by Chairman Reed after it had cancelled today's session so that more details of the operations of the Anti-Saloon league could be supplied by Wayne B. Wheeler.

The chairman told Wheeler the committee "will welcome any information that you have" about other organizations, but the dry leader replied with a smile: "We have lost it."

Senator Reed said that Captain William H. Stayton, head of the association against the prohibition amendment, would be among those questioned.

Ashmead Bartlett, Conservative, resigned from the seat which Mr. Murfit was attempting to win, but the socialist candidate, J. P. J. Gardner, defeated the Conservative and Liberal candidates by an overwhelming majority.

LONDON, (A. P.)—Princess Helena Victoria, cousin of the King, first of the Royal family to attend this season's opera at Covent Garden, unlike those who believe it undignified to show enthusiasm, applauded every act. The opera was Siegfried, and the Princess, who occupied the Royal Box, did not miss a second of the performance.

The Princess displayed enthusiasm almost from the beginning. This spirit was taken up by many others so that in the end there was much more applause than is usual on these occasions.

CONSTANTINOPLE, (A. P.)—Turkish women rebelled at posing as nude models in the Government School of Fine Arts in Stamboul. A group of them were recently induced to pose undressed for a setting in a marine sculpture, but after the first setting they refused to appear unless allowed to wear draperies. Their places were taken by Russians, Jewesses and Armenians.

Turkish women have been slow to adopt the profession of models not only because of religious and moral scruples, but because they do not possess the necessary physical attributes.

SALEM, June 26.—Already entries have come in from drivers for the Big Race at Salem, July 10, from Seattle, Yakima, Tacoma, Ellensburg, No. South Bend, Wash., Corvallis, Spokane, Aberdeen, Portland, Medford and Salem, which is being a harbinger of the feelings that is being worked up by the drivers over the Northwest Championship and surely the Northwest is very well represented.

The races will be put on under the sanction of the American Automobile Association, which will secure only professional cars and drivers to compete, this will not be like some of the outlaw races that have been seen in these parts in the last two years, but will be a series of races in which the best remain in the memory of those attending.

The officials are all men who have had a varied experience either as amateur or professional drivers, or connected in the sporting world for many years.

Jack Rudy, one of the Seattle Entries, is a well known Puget Sound driver and on several occasions participated in the Tacoma Speedway battles. He formerly drove the car Earl Cooper made much money in racing, but this year is driving the fast Hiltner Special.

Dusty Rhoads will be known for the fast time he has made on the Salem track in past years and of the accident, in which he was badly hurt in Salem in 1922, he has since made no introduction, he has won races and broken records in the Northwest for the last twelve years.

W. I. McDonough has held Northwest and California records for racing cars which will be first seen in action at the Salem turnout, he was driver of the Hawley expedition to Mexico a couple years ago.
