Cudahy, yesterday, following a night spent in the Santa Barbara jail after she had taken drastic steps to prevent his marriage to the actress.

CO. COURT HEARS PROTEST AGAINST BOUNDARY CHANGE

A large delegation of Wilbur and Millwood residents met with the county court this morning to protest against proposed changes in the boundaries of road districts in the Millwood, Wilbur, Sutherland and Umpqua communities. It had been proposed to consolidate portions of districts 62, 28, 27, 77, and 59, which are all tributary to the road from Umpqua to Sutherland, but there were a number of the Wilbur and Millwood residents who objected to the move. The petition filed today, however, did not include all of these districts so the protest on the part of the Wilbur people was not necessary, but the court assured them that there would be no changes in boundary made without a hearing first being granted.

TRUCK AND BUS LINES MUST MAKE MONTHLY REPORTS
