COURTS HALT AS TEXAS GOVERNOR TURNS 'EM LOOSE

AUSTIN, Tex., Jan. 14.—Governor Miriam A. Ferguson's clemency proclamation total today stood at 2,243, while the district attorney of Dallas county sought to join Harris and Bexar counties in discharging all criminal court sentences during the remaining five days of her term.

When informed that Governor Ferguson had maintained her daily average in issuing clemency orders yesterday by signing 31 full pardons and approving several paroles, District Attorney William McGraw asked Dallas county district judges to postpone sentencing of criminals. The courts took the motion under advisement.

McGraw said he was unwilling to take any chances" on pardons being issued to men recently convicted in his district.

to normal size; whether stitches had been taken, her strength, etc. The attending physician should be consulted. The exercises should be begun but a very few movements and increased very gradually.

2. Chief cause for the flabby breasts is not that they are functioning but that they have been stretched out with the excess fat which has usually been gained during pregnancy and nursing. In young women the breasts may go back to normal after reducing, but in those who are older, they may not. There is no exercise or massage that I know of, that will help them. The chief thing to do is to prevent their formation. During gestation and pregnancy they should be held up by a supporting binder or brassiere so that they will not drag.

3. Broadened hips are also most often due to the excess fat, as hip bones in themselves are very little, of any, affected during pregnancy. The exercises for the relaxed abdominal wall will also correct the tendency to flabbiness here.

Some obstetricians do not advise the abdominal binder until the mother gets up; while others start to use it while the patient is in bed, as it seems to give so much comfort, both mentally and physically. Personally, I think a properly put on abdominal binder, not very tight, before the mother gets up, and afterward after she does, is helpful. DeLee of the Lying-in Hospital in California, under whom I had my obstetrical training, uses it.

MEDICAL PRACTICE
ACT AMENDMENTS
BEING PROPOSED

The state board of Medical Examiners has drafted an act to amend and bring up to date the medical practice act of this state. These amendments will be introduced at the coming session of the legislature.

The existing law was enacted 32 years ago and with the exception of minor amendments remains substantially as formulated in 1895. The practice of medicine has changed in many ways during this

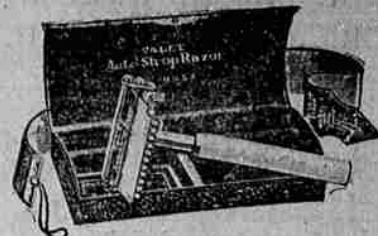

long period so that amendments to regulate the profession as it is now practiced are an imperative need. There are two main defects in the existing act; first, the absence of an up-to-date definition of the modern practice of medicine; and second, the absence of funds to enforce the law. As a result of these defects, the practice of medicine in this state is to a considerable extent unregulated at the present time. These defects are corrected by the amendments proposed by the state board of medical examiners. The definition of the practice of medicine has been revised so that it is now in keeping with the methods used in modern scientific medicine. Funds for the enforcement of the law are provided by the annual registration of licensed physicians which carries a fee of \$5.00. This latter provision has recently been introduced into many state medical laws. Another feature of the proposed amendments is that they do not affect the status of any persons who are already licensed by the state to practice some limited form of healing such as dentists, osteopaths, chiropractors, veterinarians, optometrists, chiropodists and cosmeticians; nor persons who treat disease by purely spiritual means.
