

NANKING GLASH
IS REGITED BY
U. S. FIGHTERRiotous Cantonese Troops
Mere Boys; Take Money
to Spare Lives.

LOOTING CHIEF AIM

Consul's Permit to Return
Fire Welcomed; Admits
Accounting for 7
of Attackers.

SHANGHAI, March 29.—John D. Wilson, son of E. L. Wilson, general manager of the Rumford Chemical Works, Rumford, R. I., shared the perils of Henry O. Warren, of Olin, N. C., and Dennis D. Taylor of Lincoln, Calif., as they signalled to the warships in the Yangtze during Thursday's attack on Socony Hill in Nanking.

When the United States destroyer No. 10 arrived here today from Uhu, where it was relieved by the destroyer Stewart, Wilson, who stands six feet one, told of his adventures with the two men of the William B. Preston and others of the landing party. He said that during Wednesday night they kept up a vigil on Socony Hill, but only on Thursday morning did they have an intimation of the hostility of the Chinese soldiers.

"A machine gun placed on a hill 200 yards away," he went on, "fired on our position, and we ducked. A little later word came that looting had begun. Then we saw the refugee party coming, with Consul Davis at the head with the Stars and Stripes.

"Money Saves Life.
"At noon, four others and I walked a short distance from Socony house for chow. Returning we were stopped by Nationalist troops. Our arms had been taken away earlier on Mr. Davis' orders, so as not to incite the Nationalists. The soldiers demanded money. One little devil stuck a rifle to my ribs and I thought the end had come. I gave the leader all the money I had, after which he kept the others from bothering me.

"This bunch were just kids—all under twenty but the leader—but they were armed to the teeth, much better than the southern soldiers. We finally got away when our money was gone. The soldiers then began looting Socony house and made a clean job. We were still unarmed and helpless. We could have cleaned out a whole lot of them with our automatic pistols."

Picked Off Seven.
As for the final tense moments, Wilson described them as "not so bad," adding, "The consul ordered us to resume our arms, which we gladly did. We returned the fire and I know I picked off seven. Then, on Mr. Davis' orders, we gave the 'begin firing' signal from the veranda and roof, and soon the shells from the warships came down, the No. 10 arriving first."

The men of the No. 10 who were members of the Socony Hill guards were Ensign Woodward Phelps, in command; P. R. Green, D. I. Larratt, A. D. Mossis, T. C. Calray, C. R. Arnold, T. H. Jones, G. O. Chazotte, R. D. Plumley, A. M. Townsend, C. D. Grimsley, Edward H. Kim, and John D. Wilson.

Old Stuff For Marines.
PHILADELPHIA, March 29.—Active duty in China will be old stuff for some of the marines of the reactivated sixth regiment which will leave here tomorrow on the first leg of its journey to that war-torn country.

Among the veterans is regimental Sergeant Major J. W. Thorp, of Philadelphia, the highest non-commissioned officer of the outfit, who wears six enlistment stripes and was with the marines in China during the Boxer uprising in 1900. He also served with the sixth in the World war at Chateau-Thierry and Belleau Wood.

Chen Defers Visit.
LONDON, March 29.—The correspondent of the Daily Express at Shanghai today learned that Eugene Chen of the Nationalist army, has decided not to visit Shanghai at the present time. He will leave governmental matters in that city, recently taken over by the Nationalist forces, in the hands of his political agents.

ROSEBURG ABOVE
THE AVERAGE IN
BUSINESS ACTIVITY

The directors of the Roseburg Chamber of Commerce held their regular weekly meeting last night. The meeting was largely given over to a general discussion of business activity and Chamber of Commerce work. Secretary Cully gave an interesting report on the conference of secretaries held at Eugene. Mr. Cully stated that he discussed business conditions with representatives of practically every city in the state, and that Roseburg is above the average in activity of business and industry. He stated that from all he could learn Roseburg at present is one of the liveliest of the cities of Oregon in a business way.

Six new members were added to the Chamber of Commerce, O. M. Berrie, Dr. C. B. Wade, Roseburg Super Service Station, Dr. J. R. Chapman, E. L. and F. L. Cockle, and Ira B. Riddle.

The membership committee which is interviewing the members with a view of obtaining increased pledges in order to support the enlarged budget for this year, reported that the work has been practically half completed and that the increase has been nearly 100 per cent. In nearly every case the members have agreed to double their subscriptions. This will enable the chamber to carry out much of the development work that has been outlined.

A letter was read from the Eugene Chamber of Commerce stating that the rabbit industry is showing a rapid growth in that locality and that arrangements have been made for a rabbit dinner to be served by the Girls Clubs of Eugene Thursday at which time the industry will be discussed. An invitation was extended for Roseburg people who are interested in the industry to attend.

\$25,000 DAMAGES

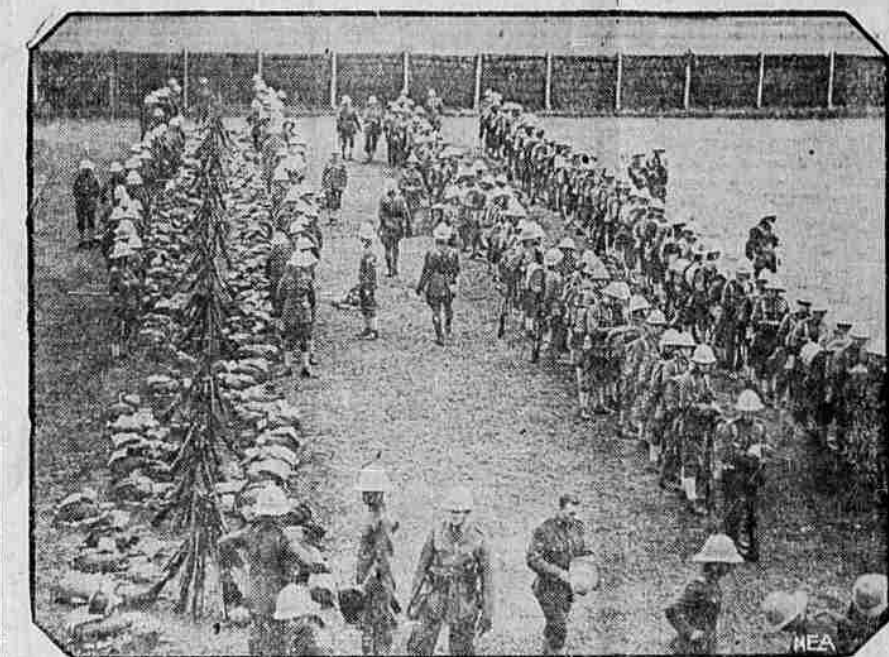

The suit is the result of an accident in October when Kite's lumber carrier at the Willamette Valley Lumber company mill was struck by a Southern Pacific freight train.

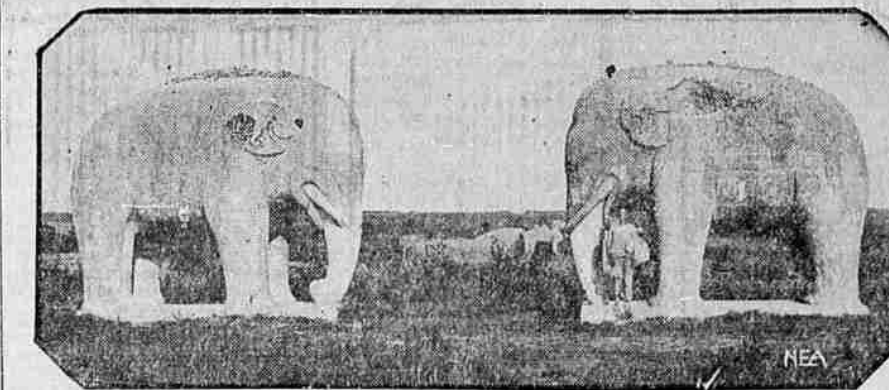

SIX YEARS' FEUD
PRECEDED MURDER
OF EDITOR SNYDER

Slain Husband Alleged to
Have Beaten Gray Upon
Finding Him at Home
With Mrs. Snyder.

NEW YORK, March 29.—A six years' feud between Albert Snyder, slain magazine art editor, and Henry Judd Gray, his accused slayer, over the affections of the

former's wife, was the subject of investigation by police today.

Contrary to statements by Gray and Mrs. Ruth Snyder, also under indictment for her husband's murder, that Gray and Snyder never had met, Judge Nathan Leberman last night confirmed reports that Snyder had consulted him several years ago on divorce plans. Judge Leberman was also quoted as a fight between Snyder and Gray which was said to have occurred in the Snyder home on June 14,

1924, when Snyder surprised Gray and his wife together.

The new angle in the case was disclosed while lawyers for Gray and Mrs. Snyder prepared defenses against evidence which District Attorney Newcombe believes strong enough to convict them both.

Judge Leberman recalled Snyder's version of the fight. The husband, an out of door enthusiast, is said to have admitted that he had "had a tough fight," despite the small stature of Gray, his cor-
