BOARD OF TRADE BAN HITS ARMOUR GRAIN COMPANY

Suspension Follows Two Years' Investigation of Deals Alleged to Be Crooked.

(Associated Press Leased Wire.) CHICAGO, April 12.—The Armour Grain company, the world's largest grain trading corporation, has been ordered suspended from the Chicago Board of Trade under charges of dishonest and wrongful acts.

Privileges of the company as to trading through the board were ordered removed, effective Saturday.

No officers of the grain company have been suspended but the Board of Trade directorate in its statement last night said such officers would be brought to trial later.

The Armour family is understood to hold large interests in the company which was organized in 1890.

Suspension of the Armour Grain company has come at a time when the state legislature, through special committee is investigating practices of grain trade in Chicago.

The suspension was the result of two years of investigation by the Board of Trade into the organization and subsequent wrecking of the grain marketing company, the Rosenbaum Grain company and Rosenbaum Brothers company, with eventual control to go to farmers who were expected to buy stock in it.

The farmers, however, were apathetic toward the corporation which after a year was dissolved. There followed charges by the Rosenbaum Grain company that the Armour company had falsified its records "and deliberately set forth to cheat the grain marketing company."

A public hearing on the investigation, assessed damages of \$2,700,000 against the Armour Grain company, principally in favor of the Rosenbaum concerns.

Publicly attending the organization and dissolution of the grain marketing company prompted the state inquiry which within the past fortnight has produced testimony now although its investigation still is under way.

OREGON'S FIRST SUPREME JUDGE TO BE HONORED

(Associated Press Leased Wire.)

SALEM, Ore., April 12.—A ceremony in commemoration of appointment of the first court official in Oregon on April 15, 1841, will be held by the Oregon state supreme court on April 15, 1927. Arrangements were made public at the supreme court here this morning.

It was 86 years ago that Dr. L. L. Babcock, resident of Tualatin Plain, was made "supreme judge with probate power" at a meeting of settlers at Chamooec. His appointment was made necessary by the death of Erving Young, who left a considerable estate which resulted in the first litigation ever to be officially transacted in Oregon.

The court did not begin to keep a record of its activities until nearly three years after the appointment of Dr. Babcock. The first entry of court procedure made in the original record is dated January 15, 1844, and tells of a writ of replevin granted Abil Smith, who had brought action to recover possession of a yoke of oxen withheld by one Nilsveh Ford.

REBEL ARMY IN NICARAGUA LOSES ALL OF MUNITIONS
