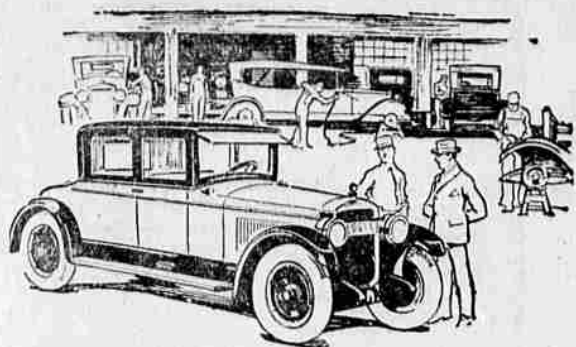

JUNIOR P-T TO HOLD IMPORTANT SESSION TONIGHT

The last meeting of the Junior Parent-Teacher association for this school year will be held at the auditorium this evening at the usual time. A short business meeting will be held, and the slate of officers for the coming year, prepared by the nominating committee, will be presented and elected by the organization.

Following the business meeting, a musical program by the glee club composed of 87 voices, and in charge of Miss Hazel Goodwin, music supervisor, will be presented. Attendants at the meeting will then inspect the exhibits of the 369 junior high students, which have been arranged in the hall. These exhibits will be comprised of art, English, science, occupations, home economics, and in fact, every phase of the work done in the classes this year, and every pupil will be represented by specimens of the work in which he excels.

In the art exhibit, every child in Roseburg, from the first grade to the eighth, will be represented by his best work. The walls of one room have been devoted to this display alone. The industrial art department will have furniture and other products of their training on display. Wild flower collections, and many other interesting features of the students have been arranged.

In the home economics section, in charge of Miss Georgia English, there will be room displays. The furniture for the bedroom exhibit was loaned by McKean, Darby and Baldwin's store. Methods of arranging tables, and general home making activities will be shown by this class. They will also serve refreshments of their own cooking.

In another room the art exhibit of 150 famous paintings brought to the school, will be on view. There is an admission fee of ten cents for this, however. The proceeds derived from it will be used to provide pictures for the school. All the other exhibits are free and all parents and friends of the students are invited to attend the meeting and view the displays to night.

PASTOR OF CHURCH OF COOLIDGES IS SUED FOR \$50,000

WASHINGTON, May 17.—The Rev. Dr. Jason Noble Pierce, widely known as pastor of the First Congregational Church, which is attended by President and Mrs. Coolidge, has become the defendant in a \$50,000 libel suit growing out of letters written to the shiping board about Howard T. Cole, an engineer of the board.

Cole's attorneys have filed a complaint with the District of Columbia supreme court, attaching to it copies of two letters they said Dr. Pierce had sent to Brigadier General A. C. Dalton, in charge of the board's ship operations, demanding that Cole be dismissed, and containing charges reflecting on Cole's private life.

The attorneys characterized these assertions as false and malicious and designed to blast his reputation. Dr. Pierce has retained Frank J. Hogan, who successfully defended E. L. Doheny and Albert B. Fall in the Elk Hills oil reserve case, as his counsel. Mr. Hogan has declared he has advised Dr. Pierce that his actions were "entirely in line with his duties as a pastor."

One of the letters spoke of the investigations by deacons of the First Congregational Church, but a later one asked that portions of the charges be stricken out. The writer explained this by saying that he had been "led to suppose that officers of my church had followed Cole more often than I find they have." Therefore, it was added, one paragraph of the charges were "circumstantial and not clearly proven."

Cole's complaint said he had always been a "law abiding, upright and moral man," and that the sole purpose of the pastor was to bring him into "scandal and disgrace, to humiliate, mortify and embarrass him, and to drive him from the city of Washington and to cause him to lose his position."

There's Publicity In It--So Film Folk Jam Paul Kelly's Murder Trial at Los Angeles

AS KELLY TRIAL BEGAN

LOS ANGELES, Calif., May 17.—A murder trial means only one thing in Hollywood—an opportunity for reflected prominence.

Men, and women too, who parade themselves before blazing klieg lights, give scarcely a thought to the person suddenly robbed of life or the one who perhaps must pay the penalty. All have a single thought—to grab a beam of the spotlight for themselves.

Free Publicity
During the trial of Paul Kelly, screen juvenile, for his alleged murder of Ray Raymond, son and dance man, the courtroom has

been crammed with movie folk. Most of them knew Raymond or Kelly. But it was not this acquaintance that lures them to the hall of justice—it is a determination not to miss out on anything that has the aspects of free publicity.

Even in death, Raymond is not

to enjoy an uncontested prominence that he would have loved in life.

Newspaper photographers are greeted on all sides with "I'm a friend of Raymond's—you had better take my picture" or "I have known Kelly for years—don't you want my picture for the paper." And whenever a camera is pointed toward one of the principals, the crowd surges forward—each endeavoring to get his, or her, face in the picture and hoping it will get by staff artists.

Special guards are needed to keep the publicity seekers from crashing into the already overcrowded courtroom. And those who do manage to get inside the doors spend little time listening to court procedure.

They don't care particularly whether or not Kelly beat Raymond to death with his bare fists. Their business is to attract the attention of newspaper men in order to be mentioned in dispatches.

One girl in particular, a popular Los Angeles stage celebrity, is all over the place. One would think she is connected in some way with the alleged crime. But in all probability it is merely a case of jealousy over the position of prominence occupied by Dorothy Mackaye.

"Inside Dope"
Another scheme now being used by some who have failed in earlier attempts to get into the foreground is to approach a press correspondent during a recess with, "I know a few inside facts about Raymond's death. I don't want to be mentioned at all—but in case you need it my name is So and So and I work at Such and Such studio."

For several years I have watched Hollywood folk strive to "crash" newspaper headlines. But never until this trial opened did I realize that their frenzy for publicity has reached a stage where they will even attempt to "cash in" on a dead actor and a suspected murderer.

WOMAN PEDDLER IS NOT ENDORSED

Telephone calls were received at the office of the Roseburg Chamber of Commerce this afternoon to the effect that a woman peddler is abroad in the city attempting to sell "corsets," stating that she has the endorsement of the chamber of commerce. Secretary Cully states this is absolute false as the chamber gives no verbal endorsements and he suggests to the citizens of the city that the peddler be refused a hearing. The chamber of commerce is watching the invasion of peddlers with an alert eye and requests that all who call on a house to house canvass be reported at once if they do not carry a written endorsement of the civic organization.

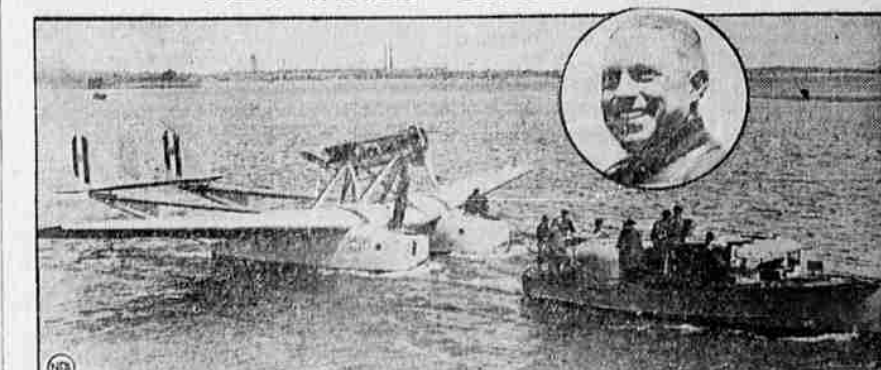
DAMAGE AT LONGVIEW
