defendant was indefinite, being "he's about the size."

A sales slip of the purchases of Ray and Roy was identified by Love. The two knapsacks and canteens were also identified.

Witnesses have testified the train robbers wore khaki colored clothing. A brown cap was found near the crime scene.

Under cross-examination Love said "I'm not positive Hugh was in the store, but I believe he was."

Purchases Told

George E. Love, of Eugene, son of H. P. Love, identified cost of Ray on the canteens and knapsacks and the sales slip. Love identified the purchases as Ray and Roy de Autremont, in October, 1923, from a circular photograph but said he was unable to identify Hugh as the third member of the party.

The witness said he remembered the sale because "one of the canteens had become a store relic." The defense was unable to shake his identification in a long quiz.

R. W. McCullough, a salesman of Portland, in 1923 manager of the People's Supply Store at Eugene, testified that on September 14, 1923, Roy and Ray de Autremont accompanied by "a third young man of their general appearance," purchased a grocery order which he helped carry to a green automobile. In the lot was a round can of pepper, afterwards found near the holdup scene.

The witness testified that his attention was attracted to the purchase "by the large amount of raisins and cracked walnuts" in the order.

Identified by Alias

COURT HOUSE, Jacksonville, Ore., June 15.—The identification of Hugh De Autremont, on trial for the murder of Charles O. (Coyne) Johnson during the Slaktyoun tunnel holdup on October 11, 1923, as "E. E. James" was renewed this morning by the prosecution.

O. B. Hitchcock of Sublimity, Oregon, employed in the summer of 1923 as a bed maker in the bunk house of the Silver Falls Lumber company of Silverton, the first witness of the day, pointed out that the defendant as the worker he had known as "E. E. James." He also knew Ray and Roy De Autremont.

The eyewitness witness, a trunk and cabinetmaker by trade, testified to seeing a locked chest under the bed of the defendant and his brothers.
