ever undergone. Five months ago he began working in the Ojai Hills of California, and after satisfying himself that he had regained the physical power so noticeably absent when he lost to Tunney, he came east to complete the process of preparation.

The former champion and his manager, Leo P. Flynn, came to New York last night from Saratoga with an air of conviction.

New York Has Doubts
Still it is the question of Dempsey's condition that adds to the uncertainty regarding the outcome. The Dempsey camp, most observers are convinced, would dispose of the Sharkey of today without much difficulty—but Dempsey is much older, somewhat slower and there is grave doubt as to whether he can hit as hard now.

While Dempsey's triumph or his downfall will provide the soul-searching drama of the night, Sharkey's performance will decide once and for all the mooted question of his class. The Bostonian's backers are cocksure of him. Those who lean toward Dempsey discount Sharkey's victories over Mike McTigue, Harry Wills and Jimmy Maloney. If Sharkey beats Dempsey he will have established clearly his claim to pugilistic greatness. If it has not already been established.

Weather Favorable
Proverbial "Tex Rickard weather" for the fight was promised this forenoon. The sun broke thru a dense fog at 8 a. m., and the weather sharps predicted the "border of fight fans would be able to enjoy the encounter without worrying about the weather."

Rickard has had uncanny luck with the elements for his open air shows—except the memorable deluge in Philadelphia last September when Dempsey lost his crown.

Sharkey Once Ignored
The only thing that worried Sharkey on the eve of his fight with Dempsey was that he was being held in a game of hearts when he had to leave for a ruckdown at Madison Square.

After he had returned from the garden to his hotel he insisted on renewing the card game so that he could win back what he had lost.

This is the same Sharkey that one year ago in New York refused an offer of Jack Dempsey to use him as a sparring partner for the Tunney fight.

"Sparring partner? Say, I may push you over myself," was the Bostonian's answer.

It is the same Sharkey, also, who applied early in New York in 1923 for a manager. Some of the same managers who refused to listen to his claims of greatness paid fifty cent apiece to watch Sharkey's workouts for the Dempsey fight. A few of them will help to swell the estimated \$1,250,000 receipts at Sharkey's fight tonight.

Firpo Picks Dempsey
BUENOS AIRES, July 21—Luis Angel Firpo, who in 1923 came very close to knocking out Jack Dempsey, only to be dropped himself in the second round, believes that the former champion will knock out Jack Sharkey.

"Dempsey will win because he is the same fighter he was," Firpo said. "He possesses the same strength, the same speed and has the advantage over Sharkey in experience. His long rest from the ring is bound to be beneficial. Dempsey is not yet old enough to have slipped too far back."

"I have never seen Sharkey box only in training, but if I were called upon to risk my money in betting I would put it on Dempsey without any doubt whatever."

NEW YORK, July 21—Jack Dempsey has high blood pressure and is not the superman of two years ago, when he knocked out Luis Firpo, but he will enter the ring tonight against Jack Sharkey "as physically fit as any human being could at 32."

This was the finding of Dr. William Walker, official physician for the state on the commission, today after the former champion had completely upset advanced expectations of scaling a pound and a half less than his young rival in tonight's 16-round battle at the Yankee Stadium.

"Dempsey is as physically fit as any human being could be at 32," said Dr. Walker. "but he is not the superman of two years ago. He is no longer the holder of nerves that faced Firpo. The most obvious change in his physical response was a blood pressure test which, although not abnormal, seems very high for an athlete. Sharkey's blood pressure was about normal."

Dempsey's high blood pressure, from a medical viewpoint, might tend to slow him up as the fight progresses," Dr. Walker continued. "Furthermore, Dempsey's pulse rate—73 and 79 after exercise—indicated that the former champion's heart action would be slower returning to normal than Sharkey's, whose pulse at rest was 68 and 74 after exercise."

"Dempsey's increasing blood pressure is doubtless due to his age," Dr. Walker said.

"Ho, ho! So he was afraid to see me now, was he?" Sharkey remarked, retorting to Dempsey.

"The main bout, Rickard announced, will be put on at 9:30 p. m., eastern daylight time, instead of 10 p. m., as originally scheduled. The promoter decided on this after consulting the boxing commission."

Wife in Seclusion
LOS ANGELES, July 21—Estelle Taylor, motion picture actress, wife of Jack Dempsey, today was under her physician's orders to remain in her rooms and not to answer telephone calls. The physician said her nervous condition wrought by her husband's heavy weight battle tonight was not serious.

RED TAPE DELAYS REWARD FOR THE DE AUTREMONTS

PORTLAND, Ore., July 21—Governmental rewards for the arrest and subsequent conviction of Hugh, Ray and Roy de Autremont cannot be paid until three months have elapsed following conviction of the murdering trio, C. B. Welter, postal inspector for the Portland district, said today in answer to a query.

As a result, the \$6,000 reward offered by the government for the arrest and conviction of the three youths who confessed to the murder of three Southern Pacific trainmen in the Siskiyou tunnel October 1, 1923, will not become available for two months. They were sentenced June 23.

The Southern Pacific railway reward of \$7,500, the American Railway Express company reward of \$900, and the state of Oregon reward of \$1500, however, can now be claimed. It was assumed.

MARKETS

PORTLAND, Ore., July 21—There seems no end to the new price upturn wholesale eggs are taking this week on the local markets. Extras have gained 2 cents on the local dairy exchange since the beginning of the week. Today they are a cent higher than yesterday at 27 cents. Current receipts are also a cent higher at 23 cents while standard and medium grades are firm at 26 and 24 cents respectively. However egg quotations are going up all along the coast at principle marketing centers.

A firmer tone to the butter market forced all grades of cube butter up from 1 to 1c on the local dairy exchange yesterday afternoon. Today standards are 39 cents, a half cent higher while prime firsts and firsts gained 1 cent each to 38 and 36 cents respectively. With the rise in price for standards, unseam butterfat is 40 cents per pound.

Clear transparent apples are still selling at a good price ranging from \$2.75 to \$3 per box. Receipts of new apples continue light.

Tomatoes are practically at an over supply with several cars received yesterday and warm weather almost certain to bring increased shipments from The Dalles district. Recent wholesale quotations were \$3.50 for repacked quats, \$2.50 to \$3.00 for originals and \$3.50 to \$4 for The Dalles 29-pound boxes. Hot house stocks have been selling for 25 and 30 cents per pound.

CONTRACT IS LET FOR EXCAVATION CHURCH BUILDING

Work to Be Started Within Next Few Days on Structure for Christian Church.

The contract for the excavation on the new Christian church building, to be erected this summer, was let today to C. A. Catching, who is to start work at once. Revisions in the original plans have caused a delay of almost a month in getting the work started, but an extra effort is to be made now in order to get the building under cover before the fall rains set in. Mr. Catching will start work within the next few days, and expects to complete the excavation within 29 days. The construction of the forms for the pouring of the concrete will be in progress while the excavation is being completed. Although Mr. Catching's bid was slightly higher than that of an outside firm, the contract was let to him, as the committee in charge of the construction is favoring local contractors wherever there is no extra great differential in price. Bids on other units of the work have been received but no contracts have as yet been let.

The church is to be erected across from the county court house on the intersection of Kane and Douglas streets. The building will be 80 by 110 feet in size and will be of reinforced concrete with stucco finish. It will be two stories in height, with a full basement, and will have a seating capacity of about 750. The arrangements for the Sunday school are said to be the most complete of any church building in the state. An gymnasium is provided in the basement for the use of the young people of the church and particularly the Boy Scouts, the Third Troop of that organization in Roseburg being sponsored by the church.

A most complete electric kitchen is to be provided, and the banquet hall will be the largest in the city with a seating capacity of around 400.

The auditorium is so arranged that different sections may be opened up to accommodate almost any sized crowd, the main portion having a seating capacity of 250, while each of three wings has a seating capacity of 90. A big balcony will afford about 250 more seats. Space is being provided for a pipe organ, which it is hoped to be able to install at a later date.

The church has been working on a building program for the past five years and in addition to securing the land, which has been fully paid for, a considerable cash fund for the building construction has been established. The value of the building and property is estimated at about \$45,000.

idge will decline a renomination in preference to the third term tradition.

Even should Coolidge be renominated, which Senator Walsh believes improbable, the Montana senator believes he will be defeated.

Senator Walsh said he had no doubt that Senator La Follette would again introduce his third term resolution which failed of action by the late congress.

"I assume," said Walsh, "that it will receive the full Democratic vote in the senate, and with Senator La Follette sponsoring it and Senator Moses of New Hampshire and some other Republican members openly against the third term, I have no doubt it will be adopted."

Senator Walsh predicted the tariff and the trusts would be the leading issues in the 1928 campaign and that prohibition will not figure as a national issue, although it may become dominant in some congressional districts.

GLOTZBACH NOT TO RESIST RETURN ON FORGERY CHARGE

PORTLAND, Ore., July 21.—Deputy Sheriff William Keller will leave tonight for San Francisco to take into custody Floyd Glotzbach, ex-chauveur-husband of Madame Matzenauer, grand opera singer, who is wanted here on a charge of forging the name of Mrs. R. D. Inman, wealthy Portland widow, to a \$5,000 check. Keller will return with the prisoner Sunday night or Monday.

Telegraphic information received yesterday by Sheriff T. M. Hurlburt was to the effect that Glotzbach had waived extradition.

While Mrs. Inman signed the complaint against Glotzbach the prosecution is being carried on by the Hibernia Commercial and Savings Bank of Portland, which cashed the alleged forged check.
