NEWLY ACQUIRED POOR RELATIONS WORRY STILLMAN

(Associated Press Leased Wire)

NEW YORK, July 28.—The New York Daily News, in a dispatch from Grand Mere, Que., says Mrs. James A. Stillman, Mrs. Wilson's "Bad" married Lena Wilson, her one-time servant, is now suing for the financial and social status of her newly acquired kinsmen.

Mrs. Wilson and Lena's six sisters have for years lived on the wages they received as servants from the Stillmans.

"Of course," said Mrs. Stillman, "I can't have Lena's mother and sisters employed here as servants after Lena's marriage to my son. At the same time, I refuse to permit Lena's family to even think they can profit financially as a result of the marriage of Bud and Lena. It was on that question that the Wilson family and I broke last week."

Mrs. Stillman, who said at the time of the dispute that she would turn them from the home she had provided and stop their charge accounts in her name in stores, indicated she would deal with them more leniently.

"These are my people and I know them," she said, remarking that to natives of the region sums above one hundred dollars were beyond their understanding.

TAX REDUCTION NOW LOOMS FOR COMING SESSION

RAPID CITY, S. D., July 28.—A slash of one or two per cent in the corporation tax seems destined to form the keystone of the prospective tax reduction program.

Administration leaders who have conferred here with President Coolidge have put this move forward as one of the first to be considered in the tax cutting planned for next session and no concerted action on this point, at least, appears probable.

Other points which seem likely to gain administration favor include repeal of the remaining war "outrage" taxes, including those

on theatre admissions and club dues. However, a row is impending on elimination of the automobile passenger car tax. Republicans who have come here have endorsed a cut in this tax now amounting to three per cent, but have gone on record for its repeal.

While no administration plan will be announced until after the president has conferred with the chairman Green of the house ways and means committee and Secretary Mellon—and there may be none even then—it has been ably aided by those who came to the summer White House that the total reduction must be held to \$300,000,000 or \$350,000,000.

Pointing to the surplus around \$600,000,000 which has piled up in the treasury during the fiscal year ending June 30, some Democratic leaders have indicated there would be a fight to make the total slash at least \$500,000,000. A larger reduction was sought by Democrats two years ago.
