Johnson's Greatest Thrill and Biggest Disappointment

Billy Evans Says That Peerless Walter Admits Those Two Experiences Came to Him During Series of 1924 and 1925 and Can't Be Forgotten

The greatest thrill of Walter Johnson's remarkable career, he himself tells me, was centered in the last four innings of the final game of the 1924 world series.

After having waited 16 years to get a chance to work in the baseball classic, the opportunity finally arrived when Washington won the American league pennant in 1924. The fans, like Johnson, had been pulling for the chance to see the smoke ball king pit his stuff against the cream of the National league.

After being beaten in his first two starts, losing the first game after 12 innings of play, in which he struck out an even dozen, it seemed as if the opportunity to strut his stuff had come too late.

Prior to the seventh and final game of the series, with the games standing at three all, I had a long chat with Johnson in the dressing room at the Washington club. He was mighty disconsolate. Those two defeats had created more sorrow in his heart than all his other reverses in 18 years of glorious victory. He seemed to think that in the one big test he had failed loyal fandom.

"A lot of things may happen before this ball game is over," was my parting remark as I left Johnson alone in the big dressing room, methodically packing his belongings for the return to his home in the west.

"Maybe. At least I hope so," was his rejoinder. I could see by the expression on his face and the way he spoke, that he held out little hope for a chance to wipe out the two reverses.

Things did happen in that ball game. Going into the eighth inning with Washington trailing 3-1, Manager Stanley Harris began rushing in his reserves, in the hope of at least evening the count.

With one out, Nemo Liebold, batting for Tommy Taylor, a min-



or leaguer who was filling in at third, smashed a line drive to left for two bases. Ruel, who had not made a hit in the series, broke in with number one, which put men on first and third and still only one out. Tate, batting for Pitcher Marberry, walked, filling the bases. As Tate went to bat in place of

as McNeely fled out to left and the runners held their bases. It was up to Manager Harris, the next hitter. With two strikes on him, he singled to left, the ball bounding over Lindstrom's head, Liebold and Ruel scoring, evening the count.

From this spot on, Walter Johnson dominated the game, until Washington put over the winning run in the 13th. In four innings he struck out five men, most of them coming with men on bases.

Those four innings provided Walter Johnson with the greatest thrill of his long and brilliant career. In four innings, after waiting 16 years, he did what the fans expected him to do—shine brightly in a world series.

The greatest disappointment of his career? Walter prefers not to discuss that unpleasant happening. However, it came in the following world series, that of 1925, between Pittsburgh and Washington. Fate stacked the cards against him this time.

Johnson opened against the Pirates and pitched a wonderful game. He allowed only five hits, struck out 10 men and finished in front by the score of 4-1. He followed this up by a 4-0 shutout in the fourth game of the series, allowing six hits and fanning six of the opposition.

Since the series went seven games, the issue was put up to Johnson as to whether Washington was to repeat as a world's champion. When his teammates gave him a four-run lead in the very first inning, the series looked all over but the shouting from a Washington standpoint. In the previous 18 innings Pittsburgh had made only one run off his delivery and that was a homer.

It wasn't in the books for Washington to win, however. Johnson was wretchedly supported and the strain of the two other games had robbed him of much of his stuff. Fate had given him just the opposite break of the previous series.

COLUMBUS KNIGHTS OPEN 45TH ANNUAL CONCLAVE

PORTLAND, Ore., Aug. 2.—The 45th annual convention of the Knights of Columbus was formally opened today with pontifical mass at St. Mary's cathedral.

Mass was sung by his excellency, the Most Rev. Pietro Fumasoni-Biondi, papal delegate to the United States. This is the first time in the history of the north-west that a papal delegate has conducted mass in this section.

The new cathedral was crowded beyond capacity. Early this morning members of the Knights of Columbus and their families began wending their way to the church and four before time for the formal opening services to begin, every unreserved seat was taken.

The sermon was delivered by the Most Rev. Edward D. Howard, D. D., archbishop of Oregon City. Scores of visiting clergy were present.

Following the religious services, a public meeting was held in the assembly room of Multnomah hotel, where the sessions of the convention are being held. This meeting was likewise largely attended.

Governor L. L. Patterson and Mayor Baker are on the program to welcome the visitors to Oregon and to Portland.

Archbishop Howard welcomed the supreme officers and delegates on behalf of the archdiocese of Oregon.

The response on behalf of the visitors was made by James A. Flaherty of Philadelphia, supreme knight of the order.

KINGS PRODUCTS COMPANY FORECLOSURE DEFERRED

SALEM, Ore., Aug. 2.—In an order issued Circuit Judge L. H. McMahon overruled a motion to strike out a petition for intervention by the stockholders' committee in the case of Nassau company against the Salem Kings Products company and gave a reasonable time as agreed on between the parties and the court in which to make further pleading.

The petition for intervention came following foreclosure of a mortgage on the Salem plant to \$225,000. The foreclosure went by default before the intervention proceedings were instituted. The order of the court today virtually holds in abeyance the final steps in foreclosure proceedings.

NEW GOLD HILL BRIDGE WILL BE OPEN AUGUST 15

MEDFORD, Ore., Aug. 2.—The Pacific Highway cement bridge at Gold Hill, over the Rogue River, will be officially opened for traffic on or about August 15, according to County Engineer Paul Rynning. The bridge proper is completed and ready for acceptance. It cost \$55,000. Of this sum \$10,000 was paid by the Southern Pacific railroad; the balance being evenly divided between the state and Jackson county. The contract price for the fills was \$13,500.

The old bridge over Rogue River will be abandoned and dismantled, the material being salvaged for use in other parts of the county.

With the completion of the paving next spring, the Pacific highway will be a continuous line to Canada.
