Mabel Strickland Is New Round-Up Queen



Mabel Strickland, Queen of the 1927 Round-Up at Pendleton whose reign begins on September 14. Besides being queen, Mabel is a "top hand" in the arena and is one of very few cowgirls who can rope, bust and tie a steer.

PENDLETON, Ore., Aug. 25.—Mabel Strickland was the choice of the Round-Up Committee for this year's queen. A saddle for a throne, a two-gallon hat for a crown, an arena for a kingdom, the top hands of cowland for subjects, and a buckskin riding habit instead of the satin and ermine usually associated with royalty are what Mabel will find awaiting her when she becomes Queen of the Pendleton Round-Up September 14.

Those who have seen Mabel—and who in Oregon haven't—agree that she has all the qualifications for queenhood. Dainty and pretty is Mabel. She is almost the "five-foot-seven-of-blue" type, about which college boys have been singing. With the blue eyes in a saucy blonde bob.

But it was not for puerile beauty alone that Mabel was chosen queen. Queens, it seems, must have sterner stuff also. And Mabel has plenty of the latter. She knows the arena over which she will preside just as well as any of the top hands who will be her subjects.

For years she has been an uncrowned queen there. She has thrilled the crowds with her daring riding and roping and been envied by other cowgirls not so skilled in the sports of the great open spaces relay races, flat races, trick and fancy riding, bronk riding and roping—in all these lines Mabel participated. The roping, perhaps, has been her most distinctive accomplishment, for few of the other cowgirls have tried that.

Roping as Mabel does it is not mere twirling of a lariat—no indeed! The lariat is twirled all right, but twirled as she races across the arena in pursuit of a steer. The loop falls over his horns, a bust and a tie follow quickly. Mabel does it all alone, and in record time, too. Her records at Pendleton in the past have been better than those made by several of the cowboys who participate in the steer roping event.

The new queen of the cowgirls can ride too. She has ridden a number of racing ponies to first in relay races. She has hung head downward from the saddle as a trick riding horse galloped down the track, or climbed under his belly, or stood up in the saddle.

The hurricane deck of a wild bronk apparently has no terrors for Mabel either, for she has tried out the worst ones without pulling leather.

Steer bulldogging is about the only one of the major contests which Queen Mabel has not attempted. But none of the subjects want to see their hundred pounds of queen in an uneven struggle with eight hundred pounds of steer. Some of her most sturdy subjects have volunteered to attend to this part of the program, and will not permit their queen to participate except as an onlooker.

If the queen did not have beauty or skill, or a thorough knowledge of her kingdom, her lineage alone would entitle her to it. She is an Oregon girl; and it was on one of the big ranches of the state that those blue eyes first peered out on an interesting world. It was on one of the ranches that she learned to ride and to rope. Her first attempts as a professional cowgirl were made in the Pendleton arena. She is a real daughter of the Round-Up.

And now she has been given the highest honor that can come to a cowgirl. Mabel smiles and is pleased, and on September 14 the thousands crowded in the grandstands of the Round-Up arena will smile back and cheer their cowgirl ruler.
