gram of Observance
of Holiday.

PARADE IS FEATURE

Comic Procession Will Be
Given This Year In-
stead of Formal
Parade.Plans for the Armistice Day
celebration are now well in hand
and the various committees are
actively working out the details
for the program in observance of
the holiday. The general commit-
tee has been meeting regularly,
while the special committees have
been making the arrangements for
each of the events of the day.

As now outlined the celebration

will start with a victory salute at 9 a. m., followed by a comic parade at 10 o'clock. The patriotic meeting, which is always a part of the observance of the holiday, will take place at 11 o'clock and at noon will be given the annual free dinner for all ex-service men of the county. Following the usual plan this dinner will be for all veterans and not alone for members of the American Legion.

At 2 o'clock Roseburg and Grants Pass high schools will play a football game at Finlay Field. These teams meet each year playing one year at Roseburg and the next year at Grants Pass. This is Roseburg's year for a game.

In the evening at 7 o'clock will be held a free fireworks display, and at 7:30 a boxing and wrestling contest will be held at the Armory, and perhaps a vaudeville show at one of the theatres. The annual Armistice Day ball will take place at the Armory at 8:45.

LOYOLA TEAM IS
THE SENSATION OF
SOUTH CONFERENCE

NEW ORLEANS, La., Oct. 14.—(Associated Press Leased Wire) Virtually unknown in the athletic world seven years ago—a college without a football team—Loyola of New Orleans in this brief interval has become one of the strongest gridiron foes in the South.

So impressive was the team's showing in going through last season without a defeat that Notre Dame has given it a place on the 1928 schedule. Sweeping through to ten victories in 1926, Loyola scored 355 points, topping all other eleven in high scoring and winning the sobriquet of "The Maroon Cyclone."

Only three teams succeeded in crossing the Louisianans' goal line and these amassed a total of only 31 points. Loyola of Chicago was defeated 40 to 14, Baylor 13 to 10, and the Tennessee School of Medicine 14 to 7. Jefferson, Detroit, Catholic University, Spring Hill, Lincoln, Fort Benning and Little Rock were smothered with scores ranging from 6 to 76 points.

Although the Jesuits were pioneer educators in old Louisiana and Loyola was founded nearly a hundred years ago, the student body never went in for sports on a large scale until 1921, when its first football team was sent forth. The first five years saw a gradual rise of the eleven and then came the sensational season of 1926, when the undefeated freshman team of 1925 became the varsity.

Eddie Reed, who had coached the Frosh, became the varsity coach and he centered his attack and defense on Bucky Moore, generally recognized as one of the

greatest backfield stars ever produced in the South. Bucky ran wild with the opposition, leading the entire South in point scoring with 105 to his credit.

New Orleans made him its idol. He was called "The Dixie Flyer." A race horse and a candy were named after him. Great in his ability to tear through the field for substantial gains, Moore has strong assistance from his teammates. Spaulding, for example, named 18 Louisiana football players on its all-star list last year and of these six were members of "The Maroon Cyclone"—Smith, Gremillion, Palm, Moore, Ritchey and Drouilhet.

Moore's significance in the line-up, however, is seen in the recent game with Howard, resulting in a scoreless tie. Bucky was knocked unconscious early in the game and Loyola was never able to launch its offensive successfully. In another game this season "The Maroon Cyclone" defeated Rice Institute, 13 to 0.

Clark D. Shaughnessy, who was coach of Tulane for 12 years, turned down six Southern Conference and two "Big Ten" propositions to become coach at Loyola this season. Reed is his principal aide. Last year the team lost only two regulars and only a substitute is expected to be dropped this season. So Loyola, when it journeys to South Bend for the opening game in 1928, will send a veteran eleven against Knute Rockne's charges.

She had gone to Seattle to visit her son and had been there about one month when taken ill. She is survived by her husband, and the following children: Melissa Norman and Ray of Seattle; Tilla Emmitt, Umquah, Boyd, Oscar and Rose Cook of Oakland, Ore., and Charles of Tyee, Ore. Also several brothers and sisters in different states, including Mrs. M. A. Minter and E. D. Powell of Oakland, Ore. There were eleven children born to this union, four of them having gone before. Thirteen grandchildren and two great grandchildren also survive. Services will be held in the Elktion cemetery by the Order of the Eastern Star of Oakland at 2:30 p. m. Sunday afternoon, with Rev. WILDCAT WILL
FIGHT SLOW-STARTER
IN TITLE BATTLE

(Associated Press Leased Wire) LOS ANGELES, Oct. 14.—How will a slow-starting welter champion, whose crown is at stake, fare with a two-fisted challenger whose driving tactics have earned him the nickname of "Wildcat" and who is on his man before the opening bell rings?

October 29 will tell the story. On that day, in an outdoor ring here, Joe Dundee, body-puncher extraordinary and, by virtue of that, welterweight champion, will meet the on-rushing swings of Ace Hudkins, "cocky" ring man and crowd-pleaser de luxe.

Joe is from Baltimore and Ace is from the corn country of Nebraska.

The champion took the crown from Pete Latzo nearly a year ago and took it decisively.

But if local fans, who watched Ace start from the ground up two years ago and develop into one of the most aggressive fighters of the present day, are anywhere near right, that crown is in danger of passing to another brow.

Hudkins, with his brothers Clyde and Art, rammed into Los Angeles in a battered flivver about two years ago. Ace grew up with a reputation for licking all his school boy rivals from the time he was 9 years old. He had had a few professional bouts before coming here.

So Clyde took the role of manager and Ace, rather quiet and decidedly non-belligerent out of the ring, started in on local talent.

One after another he put them to sleep and rapidly stepped up the gate receipts for the promoters by demonstrating his ability to carry the crowds through in gleeful satisfaction. He won nearly all his bouts the first year against such contenders as Lou Paluso, Dick Hoppe, Spug Myers and Joe Benjamin. Then he went to New York and tickled the fancy of Gotham's ringsters.

His first real setback came this year in the east when Sergt. Sammy Baker was awarded a technical knockout over him. The Nebraska came back to the coast, got a re-match and in a slashing fight trimmed the sergeant decisively.

Hudkins swings long, hard and often and soaks up punishment. His principal offensives are directed toward the body.

Dundee, whose original name was Samuel Lazzaro, followed a more conservative route to fight fame, both as to years of fighting and to the number of bouts won over those lost.

Those who have seen him in action say he is slow to get going, seeming to take four or five rounds to get thoroughly warmed up. Most of his fights have been won through vicious midriff attacks. Latzo was battered into submission that way.

TALK OF PEACE
BETWEEN DEMPSEY
AND JACK KEARNS

(Associated Press Leased Wire) NEW YORK, Oct. 14.—Talk of peace between Jack Dempsey and his ex-manager, Jack Kearns, was intensified today after Kearns made known he had agreed to an indefinite postponement in Trenton, N. J., of action to recover \$125,000 from Dempsey under terms of a former contract.

The foreign contestants are Georges Guitgullian of France; Frederick P. Hotson of Canada; James W. Watson of England and Arturo Garcia-Ferment of Mexico. All will speak on some contribution of their country to world progress or an outstanding development in its history.
