We had more faith in them than to believe that this could happen. We had more faith in life than ever to think that 44 years of companionship could be broken by so mean a thing as pride. Must our faith be shattered in this rude way?

The wedding day when Grandma Hancy was all white and radiant and lovely, their hours of planning, the first baby and his first tooth. Little good points about Grandma are going to crop out suddenly, things that he overlooked, little deeds of mercy of hers that showed her heart was big and warm after all. Grandfather Hancy says he's happy. Far be it from us to tell him that he isn't. We can only wish that we never become just as happy as he is going to be after about two months of this single blessedness.

Grandma Hancy says she is better off, too. There'll be no one to annoy her in that cozy little living room. That cross old man won't be asking a lot of foolish questions. Of course she'll miss such little things as locating misplaced hats and shoes, hearing him move about in the kitchen or bedroom as she sits there dozing and dreaming, and his eager interest in this or that fool thing, whatever it was.

Multnomah county, the third congressional district, has a new congressman today in the person of Franklin F. Krell, republican, who was ushered into office by a special election held yesterday. It cost the county approximately \$40,000 for this effort, the law providing that a governor cannot appoint a congressman, though he is privileged to appoint anything else from "soup to nuts" when an office becomes vacant. We see no good reason for such a law applying to congressmen only and think that the machinery to correct this expensive procedure should be put into motion. Forty thousand dollars saved would help a little to lift the load from the shoulders of the taxpayers. And, it could have been done had the governor the authority to make the appointment.

A Pennsylvania congressman has suggested to the American Legion a project to have all the Gold Star Mothers of the World War make a pilgrimage at government expense to visit the graves of their sons in France. The money could be spent in worse ways. We have sent diplomats, conferees, investigators abroad in the interest of peace. Here would be the greatest indictment of war that America possibly could set before the world. Such a pilgrimage of "heroes who stay at home" would be something to remember before entering another war. Besides, some very important people would thus be enabled to see the land where their boys fought and died. The suggestion is worth consideration.

Sun Bronzed Face Contrast-

ATLANTA, Ga., Oct. 19.—Earl Carroll has paid the fine of \$2,000 which was levied against him at the same time he was sentenced for a year and a day on charges of perjury and now only awaits the papers from Washington for release from the Atlanta federal penitentiary on parole.

ATLANTA, Ga., Oct. 19.—Earl Carroll today at the Atlanta federal penitentiary awaiting papers that would give him liberty, was paroled, recommended by the prison board and approved yesterday by Attorney General Sargeant at Washington, was somewhere in the mails with indications that release probably would come tomorrow.

The Broadway producer faced a limited freedom after serving slightly more than four months of his year and a day sentence for perjury in connection with his sensational "bath tub" party on the stage of a New York theatre featuring Joyce Hawley, a chorus girl, Countess Cathcart, who gained entrance to the country after her detention on charges of "moral turpitude" was in attendance, was reported guests including Harry K. Thaw, Irvin S. Cobb and Al Jolson among others.

The same celebrity will be paroled to Herbert Adams, New York attorney, whom he aided in his application as his first trial. In conformity with the usual requirements for conditional release, the lawyer will be responsible for Carroll's good conduct during the parole period and subject to the actor's conformity to a list of good behavior conditions.

The picture will find Carroll the picture of health. His shrewd features and sturdy countenance after marked contrast to his sickly appearance when he entered the prison on a stretcher after a collapse at Greenville, S. C., while on his way here. Light work and the regularity of penitentiary life proved strengthening and soon after his entrance he was made librarian and removed to the "honorary" of the prison inmates.

Carroll faces Broadway with hope of new successes on the street that reared him to the heights of fame. He recently remarked to some of his companions that he would attempt to come back as soon as he was released. In business interests in New York in the meanwhile have been handled by his brother and Mrs. Carroll.

Flowers Douglas county comes second to none in soil and climate and the products of various kinds which can be raised can not be surpassed. The annual products display gives an opportunity to see just what can be done, and many out of town people are attracted by the exhibitors. This indicated, D. H. Busenbark and J. B. Parker have charge of the building and will arrange booth space.

Local firms and organizations which have already engaged booths for displays at the fair are: Douglas Co. Creamery, Coca-Cola, Valley Products Co., C. H. Kohlhaugen, Douglas Co. Flour Mills, Crown Mills, Farm Bureau Cooperative Exchange, Kerr Jar Company, Pacific Cooperative Producers, High School (athletic funds), Camp Fire Girls, Agricultural Classes, Roseburg High School, California-Oregon Power Co., Newland & Son, O. MAINE RETAINS
DIRECT PRIMARY

(Associated Press Special Wire)
PORTLAND, Maine, Oct. 19.—Maine has chosen to retain the direct primary. By a vote of nearly 2 to 1 the state in a special election yesterday rejected a referendum seeking a return to the caucus and convention system of nominating candidates for public office. Although an active campaign has been carried on for weeks to bring about a repeal of the primary law, the election brought only approximately sixty thousand votes. The normal vote of the state is in the neighborhood of 200,000. With forty-nine small points missing out of 633 election precincts in the state, the vote stood: For repeal 19,556; against 35,357.

SALEM, Ore., Oct. 19.—Charging that the bus service of the railroad companies is operated at a loss and only to stifle competition, and alleging that use of railroad funds to operate stages is in violation of the transportation act of 1920, the Columbia Gorge Motor Coach System and the Oregon Stages yesterday filed with the public service commission a complaint demanding cancellation of the permits held by the Southern Pacific Motor Transportation company, the Oregon-Washington Railroad and Navigation company and the Union Pacific Stages, Inc.

The bus service of the railroads took the place of some of the trains operated by the railroad companies.
