

"DAWN" HOPS OFF BUT RETURNS FOR THE THIRD TIME

OLD ORCHARD, Maine, Oct. 24.—A broken exhaust valve which but for good fortune might have caused an explosion of the motor and sent the plane, the Dawn, into the sea, was found today by S. T. Harold Kinkade, motor expert, in his investigation of the trouble which forced the Grayson plane to return yesterday after a five hour flight toward Europe.

OLD ORCHARD, Maine, Oct. 24.—Notwithstanding three failures after starting a trans-Atlantic flight, Mrs. Frances Wilson Grayson was determined today to make another attempt to get to Copenhagen, in the monoplane Dawn.

The time for the next attempt depends on favorable weather and the condition of the motor which practically failed during Sunday's flight after the machine had covered more than 450 miles of its outward trip.

Mrs. Grayson who is in command of the expedition and has as aides, Bruce Goldborough, navigator, and Wilmer Stultz pilot, was undaunted by the successive reverses and delays which have been their fate for nearly two months. That no abandonment was contemplated until weather conditions make such action absolutely imperative was seen in the hastily telegraphed requests which recalled T. Harold Kinkade, Wright motor expert, and Igor Sikorsky, designer of the Dawn.

Kinkade and Sikorsky left for New York after the Copenhagen bound machine apparently had at last got under way and were well on their way to their destination when news of the enforced return was received here.

The failure of the left side motor remains a mystery today to Stultz pending the time when mechanics will have an opportunity to take it down. The machine had nearly reached Sable Island off the tip of Nova Scotia when "suddenly the motor made a terrible noise and great quantities of smoke poured out," as Stultz described the difficulty.

The fliers feared it might blow out. Goldborough jumped to the gasoline release lever and for the third time the plane was saved by the speedy release of a part of its load of fuel.

Twice before, when the big ship seemed headed for the waves in take offs here it was righted by the quick acting release mechanism.

Freed of 260 gallons of gasoline, the plane rose rapidly and fears that had led to the sending of a hasty S. O. S. message and the making of tentative plans to land in the water alongside a nearby ship, were found to be premature.

The Dawn was headed back on "one and a half engines," and the return trip made without further incident.

The Dawn hopped off at 6:13 o'clock and came back ten hours later reaching the vicinity of Sable Island off the coast of Nova Scotia. The aviators calculated they had covered 984 miles.

LOVE LETTERS TO WOMAN SUING FOR \$60,000 ARE DEAD

PORTLAND, Ore., Oct. 24.—Testimony that Mrs. Adeline M. Gates, plaintiff in a \$60,000 breach of promise suit, had attempted suicide at her apartment in December, 1926, was given when trial of the case was resumed today.

Dr. F. Floyd South testified that Mrs. Gates was suffering from the effect of a drug when he was called. She admitted that she had taken it with suicidal intent, he added.

Several love letters from S. Russell Smith, the defendant, to Mrs. Gates, were read in court. They contained many endearing terms, but nothing to indicate proposal of marriage. Smith, a Portland clubman and former Northwest golf champion, was charged in testimony last week by Mrs. Gates with attentions to her and promises to wed.

Mrs. Gates was recalled to the stand today. The court room was packed.

In the course of cross-examination Mrs. Gates was asked by Attorney W. W. Banks, Smith counsel: "Did you ever threaten to kill the defendant?"

"Not," snapped Mrs. Gates. "But I wanted to kill him several times, I might have killed him many times when he was unconscious."

Several of Smith's love letters to Mrs. Gates, extending over a period of years, were read.

"Sweetie, dear, I feel like jumping over the moon or taking a fat drink," he wrote when Mrs. Gates was in Washington. "I love you to death and will write every day," he said in another.

Even the telegraphic exchanges were full of terms of endearment.

"Adeline, dear, I would give my right arm to see you," Smith wrote Mrs. Gates at Boston. "Please, dear, be a good girl," in his letter he sent "a world of love and a million kisses."

Questions as to how often she heard from Smith, Mrs. Gates said: "He wrote every day; so did I."

Carl M. Little, attorney for Mrs. Gates, had difficulty in deciphering Smith's hand writing. The letters were turned over to Mrs. Gates when she suggested she was familiar with the hand.

"Sweetie, dear, there is not a—"
Mrs. Gates paused to inform the court there was a "swear word" in the letter and ask his advice about reading it.

"Just read what's there," instructed the judge, and Mrs. Gates resumed:

"Sweetie, dear there is not a damn bit of news—"

In other letters, Smith reiterated his undying love and insisted he could "hardly wait" until they were together again.

Explaining other communications Mrs. Gates said she had lived with Smith for three months in her apartment at New York in 1920. They also lived together, she said, for two months on a ranch in Montana.

Mrs. Gates relinquished the stand for a minute to Smith when her counsel was endeavoring to get certain telegrams in the evidence.

The messages were signed "Rosa" but Smith said he could not recall having written them.

LINDY RETURNS AFTER A TOUR OF THE NATION

Twenty Two Thousand
Miles Traveled by
Firm of "We."

NOT IN POLITICS

Spikes Rumors That He Intends to Run for Congress—After Rest Goes to Michigan.

NEW YORK, Oct. 24.—Back at the starting point of his flight to world fame and his 22,350 mile tour of the country, Colonel

Charles A. Lindbergh rested today without revealing definite plans for the future.

"I have no plans," he said. "I'm going to rest a few days and then make a short visit to Michigan. After that I frankly don't know."

Tanned, bright eyed and smiling, the Lone Eagle swooped down out of the sky over Mitchell Field and landed his Spirit of St. Louis at 1:59 o'clock yesterday afternoon, one minute in advance of the time of an appointment made on July 20 when he started a tour that brought him before 30,000,000 people in 82 cities of the 48 states of the union.

Ten thousand persons, including Harry F. Guggenheim, president of the Guggenheim fund for the promotion of aeronautics, under the auspices of which Colonel Lindbergh made his tour, greeted him as he arrived from Philadelphia. The flier said he had no immediate plans, but only a desire to "drop out of the public view for a while."

In the few moments he failed to talk of his plans. Colonel Lindbergh, spiked reports that he would enter the political field or join the department of commerce.

"Absolutely not," he said, as he was told of reports he might enter politics, possibly running for congress. "When I know myself what I'm going to do, I'll announce it."

Clad in a blue worsted suit over a white shirt and a leather pilot's coat, the flier seemed to be in perfect health as his bright eyes flashed in his tanned face. "I never felt better in my life," he said.

Usually the colonel shifted the conversation from himself to the merits of the plane that had carried him through 35 hours of flying since he left San Diego previous to his hop to Paris.

"The Spirit of St. Louis is in fine shape," he said. "But this looks like a good time to do it so I'm going to have it completely overhauled. It isn't destined for a museum yet. Eventually, but not now."

Lindbergh rejected chances to earn several million dollars even before he came back from Paris, through work in the movies and on the stage and through thousands of business endorsement proposals.

He said he would engage in nothing that would not further the progress of aviation.
