

SENIOR TEAM WINS CHAMPIONSHIP OF THE CITY SCHOOLS

Sophomores Defeated in Hard Fought Game Played at Finlay Field.

The senior class football team last night won the championship of Class A and the American Legion cup by defeating the sophomore team by a score of 6 to 0.

Recently these two teams met for the championship contest and the sophomores carried a lead until the last thirty seconds of play when they lost their chance for a victory by thoughtless play.

The contest last night was a nip-and-tuck game, with neither team having an advantage. Aided by darkness, however, the seniors succeeded in getting the ball across the line in the last quarter and so scored out a victory.

Until it became too dark to play real football the game was one that it was a pleasure to watch. During the first half the play surged up and down the field the ball never passing either team's 25 yard line.

Both teams did a great deal of fumbling and this made the game uncertain. Several times the seniors obtained advantage on breaks when they recovered punts, which the sophomores fumbled.

In the third quarter the sophomores drove down twice to the senior 10-yard line, and once passed from that line to the goal line, where the pass was intercepted.

By the middle of the third quarter it was so dark that it was almost impossible to follow the ball, and anything was possible. The seniors punted out to the middle of the field and recovered the ball when it was fumbled by the sophomores.

The sophomores tried to open up with a punting attack in the last few minutes, but owing to the darkness was unable to complete the tosses.

The tournament this year was one of the best stunts ever attempted to develop new football material. Two classes were created, Class A and Class B, Class A being the various classes of the senior high school and the junior high school team, and class B the teams of the lower grades. As a result of these contests nearly every boy in school had an opportunity to get into the game and those who showed any ability were coached and trained for the interschool contests.
