CORDON MAY GO INTO RACE FOR HAWLEY'S SEAT

(Continued from page 1.)

trict Attorney Cordon into the race has been growing rapidly, and gained impetus during the past few days, since Cordon has been in Portland. The prosecutor himself is not discussing the probability of his entrance, but this matter is being attended to for him by a number of ardent admirers, and it may safely be called a boom.

Basis for the Cordon campaign will be the work he performed in the tax refund by the federal government for the Oregon and California grant lands. There are 17 counties in the first congressional district, and many of these have received substantial sums from the government. Mr. Cordon went back to Washington with William H. Gore of Medford, who conceived the idea originally, and had much to do with the drafting of the bill. The state of Oregon is now trying to secure a slice of the money received from the counties, and Cordon is fighting this case. If Cordon succeeds in preserving for the counties the grant-land money and preventing the state from taking a percentage, then his candidacy for the congressional nomination, say his friends, is a certainty.

Hawley, Scouts Proposal In addition to the kindly feeling felt for the Douglas county district attorney for his activity in the grant land money, there are other assets claimed. It is also pointed out by Cordon supporters that Representative Hawley threw cold water on the proposal to have the government turn money back to the counties, and the work for the bill in the house was handled by Representative Stanott of the second district, which district was not being benefitted.

Among other assets claimed for Cordon is his close working friendships with the other district attorneys of the congressional district, and also with the sheriff and assessors, for prior to becoming district attorney, Cordon was the Douglas county assessor. He is credited with being a good campaigner, and on top of all this, he is an ex-service man. Some of the "Mexican generals" are now talking up Cordon's stock.

Mott Makes Campaign Mr. Mott of Astoria is already allied for the nomination. He has visited the coast tier of counties of the district and some of those inland. He, too, is aggressive in his campaign methods. Mr. Hawley, while strong in all counties in his district, is especially so in Marion, but Mott lived in Marion county before he moved to Astoria and has strong friends there.

It is not expected that Mayor Thomas of Marshfield will succumb to the temptation to enter the race. He has been president of the state retail merchants' association for several years and has an extensive acquaintance among merchants although his name is not so familiar to the general public. Like Cordon and Mott, he is active, and knows the needs of the first district, Coos Bay, however, feels kindly for the interest taken by Hawley in the harbor development, and Mayor Thomas may decide not to oppose him.

The voters of Cordon realize that it is not unlikely, if Hawley is to be defeated, to have the anti-Hawley vote split by a couple of candidates. It is a tough-and heretofore impossible—job to beat Hawley with one candidate, and with two candidates the incumbent would have a double assurance of victory. This being the case, some of the Cordon supporters are saying that when, and if, the district attorney of Douglas county decides to run against Hawley for the congressional nomination, efforts will be made to have Mott step out of the picture. Those who think that they know Mott, however, are of the opinion that Mott has not the self-sacrificing complex.

CONTRACT IS LET FOR S. P. MACHINE SHOP AT EUGENE

PORTLAND, Ore., Jan. 16.—Contract for construction of a machine shop to cost \$250,000 at the Southern Pacific company's terminal at Eugene has been let to H. E. Wilder, Eugene contractor. The machine shop is another unit in the Eugene terminals which already include a repair shop, tie-treating plant, roundhouse and switching tracks. Additional trackage, not yet authorized, are expected to be included in the plans for the terminal.

The machine shop will be a steel and concrete structure, and is expected to be finished in about three months. It will be used for repairs to engines running in and out of Eugene, said E. L. King, division superintendent of the Southern Pacific.

Southern Pacific engineers will go to Eugene to aid in laying out the details of the machine shop.
