Want German Track Star

Stimulates Interest

Lloyd Hahn Develops

NEW YORK, Jan. 25.—Instead of doing the Olympic program any harm, as athletic authorities fear, the competition of Dr. Otto Peltzer on American indoor tracks is more likely to stimulate interest in the forthcoming international sports carnival at Amsterdam.

The fact that the famous German runner not only has beaten the world's best but broke Ted Meredith's old half mile record, a long cherished American possession, lifts him out of the ranks of ordinary athletic visitors. As a world's champion in his particular specialty, he not only is entitled to display his prowess, but should be urged to do so, observers feel, if for no other reason than to help arouse American talent.

Much has been written about Germany's return to the Olympics this year and her threat to American athletic supremacy. Peltzer typifies the new German athlete era so that by running in this country under official auspices there is an opportunity to bring home the strength of his "Teuton" menace.

It will be remembered that Paavo Nurmi, the Finnish phantom, stimulated interest in American distance runners in the winter of 1924-25 as it had never been stirred before. In the face of Paavo's achievements, the American talent outdid itself.

Joey Ray, Lloyd Hahn, Jimmy Connolly and others turned in the fastest races of their careers in the wild chase to keep up with the flying Finn. They never succeeded in catching him, but profited from the competitive urge. In addition the younger element, always ready to emulate an outstanding star, obtained some valuable lessons from Nurmi's performance.

It might have been a different story at Paris for America's distance runners if they had experienced such a stimulating influence before, instead of after the 1924 Olympics.

Lloyd Hahn, a fair to middlin' miler in 1924, has developed into one of the great American middle distance runners of all time by taking a test or two from Nurmi's book of success.

Perseverant by nature, the Nebraska adopted the Finn's method of year-around training as well as Paavo's racing tactics. Nurmi set his own pace, for the most part, running against time rather than

his opponents, figuring out what sort of a performance was necessary to win a race or set a record and carrying along a stopwatch to guide him.

Whether or not Hahn and Peltzer have a chance to match strides indoors, in New York or Chicago, they will be two of the main contenders for Olympic honors over the 800 and 1,500 meter routes. Tossing in the present champion, Douglas Lowe, of England, in the 800 meter race and Nurmi in the 1,500 meter contest, there is a three cornered scramble of epic proportions in either event.

TUNNEY WANTS TO FIGHT IN CHICAGO

CHICAGO, Jan. 25.—If Gene Tunney, boss of the heavyweights, has his way the next "battleground of the century" will be held in Chicago some time next summer. Opposing Mr. Tunney is Tex Rickard, who favors New York, with the date of the bout late this fall.

Such were the latest developments in Chicago's effort to get the next championship bout as disclosed in a telegram from the Cook county board, who is sojourning with the champion in Florida.

"Rickard wanted to hold the elimination bouts in Madison Square Gardens and put Tunney on late in the fall," read the telegram. To this Tunney objected.

Final agreement provides Rickard name opponent by February 1 and post \$100,000. Tunney will then reject or accept this offer or make a counter proposal.

"Rickard favors Madison Square Garden Corporation and New York for the fight. Tunney prefers Chicago."

Governor Len Small of Illinois yesterday issued a statement approving of staging the championship bout in Chicago this summer.

AMERICAN BOXERS GOING TO GAMES ARE NOT SO GOOD

BOSTON, Jan. 25.—Al Lacey of Chelsea, assistant trainer of the 1924 Olympic boxing team, thinks that the United States has a fine chance to "take it on the chin" at the Olympic bouts at Amsterdam this summer.

"Scandinavians, Frenchmen and South Americans," he said, "will be the big guns this year. They build their bodies, and if they are just one little bit more scientific than they were in 1924, American boxers, from what I've seen, won't have a look-in."

America's best chances of success lie in uncovering strong talent in the Grand Rapids, Detroit or Pacific coast districts of the A. A. U., before the national championships here in April, Lacey believes.

REAL BATTLES SHARKEY DONE EXPECTED ON AS CONTENDER, CARD TONIGHT SAYS MULDOON

Preliminaries as Well as Main Events to Afford Action.

HERMANN TO REFEREE

Salt Lake Boxer and Wrestler to Be Third Man in Ring—Expect to Have Six Bouts.

A boxing card, with every indication of being one of the best ever seen in Roseburg,

Only five bouts are advertised, a double main event, a special 4-round bout and two preliminaries, but Mr. Ward stated this afternoon that he has another fight in prospect and may be able to offer the fans six fights instead of the five as originally promised. Last card Mr. Ward added a bout to the program and the added entertainment was greatly appreciated by the fans.

While interest, of course, centers in the two main events and the special event, each of which promises plenty of excitement and some real boxing exhibitions, the preliminaries are apt to furnish the real "fights" of the evening.

In one of the preliminary bouts Promoter Ward has lined up "Comet" Gibson of North Roseburg and Johnny Grout of South Roseburg. Representing two of the rival "gangs" of the city, these youngsters are out for blood and plenty of it, and slugging, not science, is expected to predominate.

Another preliminary that will not be in the nature of a love feast will be a 3-round battle between two of the Draper brothers. These youngsters have a grudge to settle and have asked permission to go into the ring to settle their argument with the gloves.

Mr. Ward, for the third preliminary, is endeavoring to find a match for a young Looking Glass boy, a newcomer here, who has had some ring experience. An opponent for Eugene is being brought in and if all necessary arrangements can be made in time this extra engagement will be put on.

Each of the three other bouts have every indication of being fast and full of action. Jewett and Sauer who feature one of the main events are known to be hard hitters and able to absorb a great deal of punishment. They have never been matched before, but they have each been up against the same opponents and from their records in these bouts it would appear that they are very evenly matched.

The Davis-Stewart bout is expected to be one of the hardest hitting exhibitions ever seen in a local ring. Davis, who is a Eugene fighter, carries a terrific wallop, while Stewart is also a hard hitter and is able to stand up under a bombardment that would have most boxers groggy from the start. They were on the last card and fought to a draw, Stewart being the aggressor throughout. Despite the fact that Davis swung blows that would have knocked a horse down. Neither of the boys was satisfied with the outcome and they have asked for a return bout to settle the argument. From Eugene and Portland word comes that both fighters have been training harder than ever before to get in readiness.

The special event is not expected to go its scheduled four rounds. O'Neill and Sales, who fought last time in a whirlwind engagement, are expected to battle at the same pace again tonight. O'Neill who was out of training at the last card, has been working hard to get in shape and is in far better condition than before. Sales has recovered from the injury received in the last night, when he strained his thumb in delivering one of the terrific blows struck during the two rounds of milling.

Promoter Ward has been assured that Cal Hermann, well known boxer and wrestler from Salt Lake City will be on hand to serve as referee. With Hermann as the third man in the ring, there is no question but that the fighters will be treated with absolute fairness and that the fans will not have to witness any stalling. Hermann is a good referee and keeps the fights moving at a rapid pace.

VETERAN SEES SLUMP

Disappointing Battle With Heeney Shows Effect of Mauling From Jack Dempsey.

NEW YORK, Jan. 25.—A sort of premonition that the fluster star of Jack Sharkey is about to set has gripped William L. Muldoon, grand old dean of American boxing, and the man who first called Sharkey "great." Loss of incentive is the great factor that threatens to bring it about.

Two years ago, a splendidly muscled youngster with the gleam of a conqueror in his eyes climbed out of comparative obscurity and into the Madison Square Garden ring to fight Sallor Eddie Hoffman, light-heavyweight. When the dreary battle was over, that same youngster climbed down out of the ring and back into obscurity as far as most of the rhapsodic observers were concerned. He was Jack Sharkey, of Boston, once of the United States navy.

At the same ringside sat William Muldoon, 59 years old then, snowy-haired and calm with the wisdom of a half dozen decades spent watching fighters come and go. He was there as a member of the New York State Athletic Commission, of which he once was chairman.

"Some day that boy will be a great heavyweight," Muldoon said then. "He has everything that goes to make a champion. He's keen and sharp, the cleverest big man in the game today."

Dempsey Halts Rise That was two years ago. Since that time, Sharkey ripped through the heavyweight ranks past Harry Wills, George Godfrey, Mike McTigue and Jimmy Maloney and fattered only last summer before the crushing flats of Jack Dempsey with the championship goal in sight.

Two weeks ago, Sharkey fought a disappointing draw with Tom Heeney. He is matched to battle Johnny Rakos March 12 and again a title millstone with Gene Tunney. He is just ahead of the winner. But William L. Muldoon has changed his mind.

"Jack Sharkey today is no longer the fighter who blazed so brightly against the fiercest kind of opposition," he said.

"A lovely home, wife and family, all the money he needs have costed the man, taken away his keenness. The urge to battle, the incentive, is gone. Will he ever get it back? That's the question," and William L. Muldoon shook his snowy head.
