CONFERENCE ON PLAN FOR COLONIZATION OF WESTERN LANDS CALLED

PORTLAND, Feb. 2.—Colonization of reclaimed lands throughout the west will be the subject of a conference at Washington, D. C., February 14 and 15, at which W. C. Ide, manager of the Oregon State Chamber of Commerce, will represent the state and Portland chambers of commerce and the Oregon Reclamation Congress. The conference has been called by Dr. Herbert Work, secretary of the Interior, and Dr. Elwood Mead, commissioner of reclamation. Mr. Ide will present to the conference the results of his recent study of the Stanfield and Westland reclamation projects in eastern Oregon and he will make a plea for their completion.

NEGRO FIGHTER BOXING CARD NEXT TUESDAY

Scott Holley, Who Was in Action at Last Battles, to Be Back.

JOSSI IS OPPONENT

Local Promoter Has Arranged Card Fully Up to Standard of Those Previously Given.

The three chief bouts for the boxing card scheduled for next Tuesday, Feb. 6, have been arranged by Clyde Wiard, local promoter, and from all indications this will be another program fully up to the standard of those previously given under the auspices of the local boxing commission. Because of the smoker being given by the Ellis Lodge next week, Mr. Wiard is holding his public card on Tuesday instead of waiting until later in the month, and while Tuesday is a day seldom used for boxing locally, yet it is believed as any other day in the week, as in many cities it is found to be the best, Portland holding practically all of its cards on that date.

For the main event Mr. Wiard is staging a 10-round battle between Scott Holley, colored fighter from El Paso, and Bill Jossi of Tacoma. Holley fought on the last card against Joe Jewett. He had been out of training for several months, and so was not able to do his best, but convinced that he is in his old timer at the ring game, as he exhibited a cleverness seldom seen locally. Jossi is a boy who has been knocking over the best of his weight in the Tacoma and Longview district, and judging from the relative records of the two boys the fight should be a humdinger from start to finish. This will be the first 10-round fight to be staged in Roseburg since boxing was officially authorized.

The six-round semi-final is to be another fast engagement, according to expectations. Eddie Carwright, a well known Portland boxer, and Frankie Bernell, a tough slugger from Vancouver, B.C., will engage in this bout, which will be fought at weights of 150 pounds. Both of these boys have been appearing regularly on Portland cards, but have never met, prior to this time.

Joe Wilde of Eugene and Freddie Warnick of Portland will fight the special event, which will be four rounds. Wilde is a red hot kid on the last card and displayed a good deal of boxing cleverness and hard punching. These youngsters will fight four rounds. In addition to these bouts, Mr. Wiard is promising the usual schedule of preliminaries.
