COLONEL CHAS. A. LINDBERGH LOST

Field at 2:26 a. m. for his home port of St. Louis, a flight of 1200 miles. Night still hung over the waters of the straits of Florida as Lindbergh headed over them on the only water jump of his flight to Key West, Florida.

As the Spirit of St. Louis left the dimly lighted field only the steady thrub of its motor traced its course to the open sea. From Key West his route led along the Gulf of Mexico to a point south of St. Louis. From there it turned north to that city.

The plane was loaded with 225 gallons of gasoline, half its capacity. It was estimated this would carry him for twenty hours. The flight, the fourth longest of his career, was expected to end at Lambert Field soon after 2 o'clock this afternoon. The three flights which have exceeded the present one were New York-Paris, 3600 miles; Washington-Mexico City, 2,200 miles and San Diego-St. Louis, 1550 miles.

Fit and Smiling—Lindbergh, fit and smiling, arrived at the field accompanied by Ambassador Nobel Brandson Judah and Mrs. Judah at 1:50 a. m. The Cuban band struck up a lively march and the Spirit of St. Louis was wheeled from the hangar, while the flier walked about the field hunting a suitable place for a take-off.

He returned to the plane, stowed luggage and a few sandwiches aboard and taxied to the far end of the field at the opposite end from the hangars. Ambassador Judah and Mrs. Judah followed in an automobile lighting the way.

He started from the polo field and as the plane sped over the bumpy ground it passed close to one of the goal posts. Half way down the field he was in the air, and rushing along just raised the plane to clear the hangars. The spectators and a large number of the Cuban flying corps cheered and threw their hats into the air.

Flashes a "Goodbye"—For fifteen minutes the sound of his motor was heard as he circled apparently seeking his bearings. Lindbergh made a final circle over the field and gave three flashes of his signal lights in farewell to Ambassador Judah and Mrs. Judah.

Another chapter had been added to the history of aviation and a new one begun.

HAVANA, Feb. 13.—Lack of reports of Colonel Lindbergh's progress had caused uneasiness in Havana, although several days before his start, he had declared that he would steer a course avoiding cities and large towns along the route.

Lindbergh intended to cross the Gulf of Mexico to Florida Key, in approximately one hour. Just before he took off at 2:25 this morning, he said:

"I will be over Key West at 3:30."

His idea was to follow the coast line of Florida, and alight until he reached a point on a direct tangent to St. Louis where he expected to take off cross-country in a straight line.

After the spirit of St. Louis was taken from her hangar at 2 a. m. today, the engine was tested by the American aviator, Lieutenant William Lindbergh, assistant. They both said the motor was functioning perfectly.

The take-off was without incident. On attaining an altitude of less than 1,000 feet Lindbergh's motor began missing.

What appeared to be motor trouble caused grave concern to the Cuban aviator, Captain Landrau, who was with the ambassador in the automobile, who had given Lindbergh final advice about the take-off.

HAND OF DEATH WIPES OUT QUACK-ENBUSH PIONEERS

(Associated Press Leased Wire) PORTLAND, Ore., Feb. 13.—The hand of death fell heavily during the past few days on the pioneer family of Quackenbush, Edward Quackenbush, 88, prominent in the early history of Portland in business, civic and musical circles, died yesterday, following the death of his sister, Miss Louis Quackenbush, 85, and his invalid son, Fred, 64. Miss Quackenbush died February 5. On February 4 Fred fell down a staircase, striking his head, which resulted in his death Thursday. In the meantime Edward Quackenbush was taken ill of fever, his death ensuing yesterday. The Quackenbush family lived for years on a farm between Tigard and Tualatin.

PORTLAND ATTORNEY DIES

(Associated Press Leased Wire) PORTLAND, Ore., Feb. 13.—Walter P. Laroche, prominent Portland attorney, died today at a hospital after seven weeks' illness. He was a city attorney for several years, resigning in 1921 to become chief counsel for John L. Etheridge, bond broker. Later he was appointed attorney for the Portland Dock commission. He came to Portland in 1905 from Georgia, where he had been active in legal work and politics.

FOSSIL TOOTH OF MAMMAL FOUND NEAR MEDFORD

(Associated Press Leased Wire) MEDFORD, Ore., Feb. 13.—A tooth of immense size, believed to have been originally in the jaw bone of a prehistoric creature, was found yesterday by Bernard Orwald, on his father's ranch in the Antelope district. The tooth is eight inches long and six inches across, and well worn down from chewing. The molar will be sent to the University of Oregon for classification. Young Orwald will start excavating next week in an effort to find the backbone and other parts of the monster.

HICKMAN MAY BE HANGED ON A NEW CHARGE

(Continued from page 1.) will be brought into court, while his attorneys argue for a new trial before Judge J. J. Trabacco. The general expectation is that this will be denied, and Hickman will be sentenced. Following this the defense, according to its announced program, will carry the case on appeal to the supreme court.

Jerome Walsh, defense attorney, has stated that he will not object to Judge Carlos S. Hardy as trial judge in the Thoms case. It was Walsh's objection that resulted in Judge Hardy disqualifying himself in the Hickman sanity trial which closed last week, and the calling in of Judge Trabacco from Medford.

Will Give Testimony—LOS ANGELES, Feb. 13.—William Edward Hickman, convicted kidnaper and murderer of Marian Parker, today definitely announced his intention of turning state's evidence against his 16 year old partner, Wilby Hunt, when the pair appear Wednesday before Superior Judge Carlos S. Hardy to answer to the charge of murdering Christmas eve, 1926.

"He had a lot of fun testifying against me. Watch me when I take the stand against him," Hickman declared.

This referred to young Hunt's testimony at Hickman's trial for the Parker slaying. Hunt testified that Hickman, in his opinion, was absolutely sane.

Despite all his lawyers are doing for him, Hickman himself seems, to judge by his own statements, to have no hope or expectation of escape from the gallows. "All this thing was planned long ago for me," he declared in the utmost sincerity.

"You have seen how cool and collected I can remain under stress and I'm going to show you a man who can mount the steps of the gallows with the same calm demeanor."

MISSING DEPUTIES BELIEVED DROWNED

(Associated Press Leased Wire) LAFAYETTE, Ind., Feb. 13.—The muddy Wabash, choked with ice, holds what Police Chief Everette believes to be the answer to the question authorities have sought since Tuesday to answer what happened to Deputy Sheriffs John P. Grove and Wallace McClure.

The police chief does not expect a river search will be possible for several days because of flood waters. Search parties again today were organized to scour the countryside for traces of the deputies and the two prisoners they were driving to the state reformatory at Pendleton. Although there have been the usual reports of being "seen" in several sections of the middlewest, the two prisoners who were sentenced to serve 5 to 25 year robbery terms have not been found. The two, Samuel Baxter, 19, and John Burns, 20, were last seen Tuesday, several hours after the party of four left Lafayette. They left Grove's automobile in a garage at Decatur, Ill. The firing of several shots at Maple Point, near here last Tuesday and the finding of Grove's hat and coat belt near there further substantiated the theory that the two deputies came to harm at the hands of Baxter and Burns.

ETERNAL TRIANGLE ENDS IN DEATH OF 2

WILLIAMSON, W. Va., Feb. 13.—Mrs. Daisy Lawrence, 17, and Emory Yarborough, 30, were killed by the young woman's husband, Robert Lawrence, 19, in his home in East Williamson Sunday, the state police reported today.

According to the police, Lawrence said he shot the couple when he found they were on intimate terms. Lawrence was lodged in the Miners county jail.

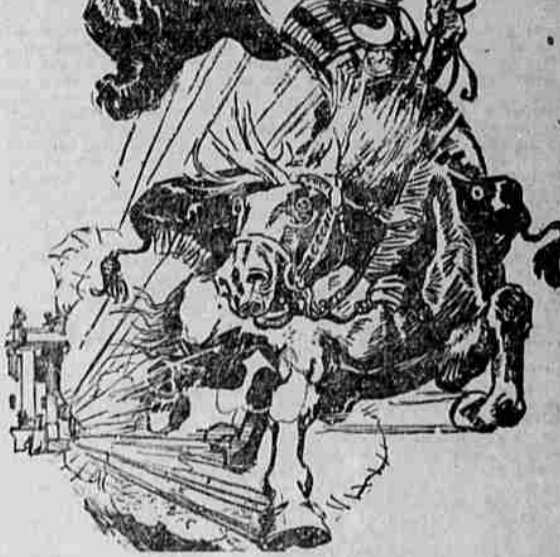
