LEGISLATURE OF N. Y. GIVES LINDY GREAT OVATION

(Associated Press Special Wire)
ALBANY, N. Y., Feb. 29.—Amid scenes of enthusiasm unequalled for years at the capitol, Colonel Charles A. Lindbergh appeared before a joint session of the New York legislature today to speak on the state's proposed aviation program.

Entering the assembly chamber with Governor Smith, Colonel Lindbergh was hailed with wild cheers and shouts from the largest crowd ever to be packed in the chamber in honor of a single individual.

Lindbergh and Lieutenant Lester J. Maitland, Pacific flier, sat on the speaker's rostrum.

Mayor Charles G. Hanna of Syracuse, temporary president of the state aviation conference, spoke first, briefly reviewing the state's interest in aviation.

"I don't know very much about this speaking thing," began Lieutenant Maitland, who was then called. After telling a humorous story about his flying colleague, he turned his attention to the pending state aviation legislation, urging it as highly necessary to the development of aeronautics.

Colonel Lindbergh was introduced by Speaker McGinnies.

"It now becomes necessary to regulate the type and operation of planes," he declared in reference to the pending state air laws.

"It would considerably help commercial aeronautics if the states of the union would adopt such regulation," he added.

"In New York state cities now have authority to purchase and construct airports," he went on. "Not long hence we will be using planes as we now use automobiles and railroads."

"I believe that the other states are looking on New York as leader in this new industry."

He concluded with a plea for continuance of New York state's lead in aviation legislation.

JAIL MAY SERVE AS MONUMENT TO FAMOUS WRITER

PORT WORTH, Texas, Feb. 29.—The proposal to convert the Travis county jail at Austin, Texas, into a memorial for William Sydney Porter, known throughout the world as O. Henry, short-story writer, the most famous prisoner ever confined within its walls, is seriously made by a Texas magazine published at Fort Worth.

"The last roof that sheltered O. Henry within the borders of Texas was the Travis county jail," the magazine declares, "and it ought to be converted into an O. Henry Memorial Library."

In February and March, 1898, just thirty years ago, Will Porter, who had been a citizen of Texas for 15 years, occupied a cell in that jail as a federal prisoner, charged with embezzling a few hundred dollars of the funds of a

national bank. And it was in that jail that he wrote:

"Right here I want to state solemnly that in spite of the jury's verdict I am absolutely innocent of any wrong doing in that bank matter, except so far as foolishly keeping a position that I could not successfully fill."

Porter served three years and three months in the federal penitentiary at Columbus, Ohio, to which he was sent from Travis county jail, and it was there he began to write under the nom de plume of "O. Henry." He was released on July 24, 1901, and went to New York in the spring of 1902. Eight years later, on June 5, 1910, he died in a New York hospital, but in that short period he had made himself the most widely known and best-loved story-teller in the world.

The Travis county jail stands opposite the grounds of the state capitol, and the land it occupies is the property of the state of Texas. It is proposed that the county shall find another site for a new jail and dedicate the present building to the memory of the most famous prisoner ever confined within its walls.

"It would be decidedly the kind of a memorial that O. Henry would appreciate," it is declared.

"The poetic justice of it would appeal to him strongly, and one can imagine him chuckling over it, out there across the Great Divide in whatever Celestial Bagdad he may now reign as Caliph. It would be a real O. Henry 'unexpected ending' to the story of Will Porter's trial and conviction, when he was 'absolutely innocent of wrong doing.' His humanity was his distinguishing characteristic. And what a human thing to do, to take this building, the erection of which was made necessary by human frailty and human passion—a jail—and convert it into the memorial of a man who possessed, as few others, an understanding of human weakness and a tolerant charity towards human shortcomings, a man who saw beneath the follies of all sorts and conditions of men a common humanity. What a human memorial it would be."

Newspapers Aid Schools, Educators Declare

National Association Told Press Best Means of Information to the Students.

BOSTON, Feb. 29.—The importance of publicity in school affairs was stressed today by two speakers scheduled to appear before superintendents attending the National Education association convention.

Citizens are entitled to full information about their schools, said Willard H. Bacon, superintendent of schools at Westley, R. I.

The typical report card, he declared, is lacking in real information. It abounds in lists of subjects, but for real information, he said, parents must go to the school, the principal, the teacher, or the child. The majority of parents, he added, do not do this unless they believe an injustice has been done. He urged that the schools take the initiative in giving parents real information of their children's work in a personal way.

"The best means," he said, "of keeping the public informed are the public press, especially the small local newspapers; the annual report, which in the smaller towns goes into many houses; special bulletins mimeographed or printed and sent to the parents by the pupils; public addresses and demonstrations, exhibits, window displays and posters, and teachers who are so interested in their work that they enthrall all of their friends."

In a community that is well informed good schools will be demanded by the people even if the costs are "rather high," said Dr. S. Monroe Graves, superintendent of schools at Wellesley Hills, Mass., in an address prepared for delivery before the convention. He suggested that superintendents should foster active parent-teacher associations and school news columns in their local newspapers.
