Ranch in Ruins—The Harry Carey ranch, where the film actor owner has staged many rodeos, was in ruins. Everything has been covered by the rush of water except the owner's cottage.

On a hillside there stood the pitiful figure of a little woman, huddled in a vivid red sweater, wringing her hands.

Her name was Mrs. Russell Eaton and she told the Associated Press correspondent that her little daughter had lived with her grandmother up San Francisco Canyon.

She pointed to the place where the grandmother's small home had stood beside a cottonwood tree.

It was nothing but a flat hillside-like surface of yellow sand and the cottonwood tree had been stripped even of its bark by the wild waters.

A Pitiful Figure—A grotesque figure in a long fur coat waded up and down the winding stream which followed in the wake of the 75 foot high torrent of a little after midnight.

It was Jimmy Erachow, a rancher, half crazed by the disaster, searching for the bodies of his wife and baby.

LADY CARBERY IS KILLED IN CRASH (Associated Press Landed Wire)

NAIROBI, Kenya, Africa, Mar. 12—Lady Carbery, wife of Paron Carbery, Irish peer, was killed yesterday in an airplane crash. A pupil named Cowie, with whom she was flying, was also killed.

DR. PAYNE TO TAKE OVER POSITION OF HEALTH OFFICER

Dr. D. Payne of Olive View, California, arrived in Roseburg today to take over the position of county health officer, recently made vacant by the resignation of Dr. Laraway, who is now employed as a physician for a large industrial concern in California. Dr. Payne has been connected for the past 18 months with the health department of Los Angeles county, specializing in tuberculosis work at the sanitarium maintained there. Last year he made a vacation trip into Oregon, and was so well pleased with conditions here that he applied to the Oregon State Board of Health for a place in this state, and was chosen to fill the vacancy here. He was accompanied to this city by his wife and small daughter, and they are preparing to establish their home in Roseburg. Dr. Storey, assistant state health officer, who has been in charge of the health unit work here since Dr. Laraway's departure, is returning to Portland in a few days. Dr. Frederick Stricker, state health officer, is assisting Dr. Payne in becoming acquainted with his duties here and with the local field.

NORTH DAKOTA TO LEAD OFF MAR. 20 IN THE PRIMARIES

BISMARCK, N. Dak., Mar. 13.—Leading the van of presidential preference primary elections, North Dakota voters will go to the polls March 20 to pledge formally the delegate strength of the major parties to Frank O. Lowden, republican, of Illinois, and Governor Al Smith, democrat, of New York. Neither has opposition. While the primary apparently will be a tame affair, there will be a state struggle in the republican ranks as to which of the two factions will have the privilege of supporting Mr. Lowden. Both the Non-Partisan and Independent factions have endorsed Lowden and each has entered a full slate of delegates. North Dakota is entitled to 13 republican and 10 democratic delegates.

The rush to the Lowden band wagon got under way when leaders of both factions became convinced that he was a favorite in the state. The Non-Partisan element tried to enter Gov. A. G. Swelle as a favorite son, but the republican state central committee, Non-Partisan controlled and headed by F. A. Vogel, balked the proposition.

B. F. Spalding of Fargo, once congressman-at-large from North Dakota, also heaped sweep Lowden opposition out of the way.

The petition placing Governor Smith's name before the voters was filed at the last minute by E. J. Hughes, chairman of the democratic state central committee.

CROSS COUNTRY HOOFERS FACING MOUNTAIN BARRIER

BY RUSSELL J. NEWLAND, Associated Press Sports Writer. OATMAN, Ariz., Mar. 13.—The rugged black mountains of Arizona stood today as a barrier before the hundreds of runners and walkers facing the tenth lap of the 2400-mile marathon from Los Angeles to New York City.

A hard packed dirt highway, winding thru the range, rose to an elevation of 3500 feet at the summit. From there it dropped to 2400 feet and rose again to 3300 feet. Kingman, 28.5 miles distant, was the destination today of the throng that swam off March 4 on the long trek to the eastern coast.

Some six hours advantage was held by Arthur Newton, the sun-bronzed entrant from Rhodesia, South Africa, in total running time for the 216.9 miles covered since the race got under way. The lanky and snowy Britisher jogged into this little mining community from Newell, California, a distance of 20.5 miles, in four hours, 43 minutes and 30 seconds, to set his

PORTLAND MEN GIVEN HEAVY FINE FOR KILLING DEER

Wayne Martindale, 222 W. Emerson St., Portland, and E. M. Fulton, 66th Ave., S. E., Portland, were arrested here this morning and fined \$250 each for possession of venison out of season. The two young men, according to the information given by Sheriff Webb, stated that they had been looking for home-stead land in the Camas mountain region and had killed two deer for their own use and were on their way back to Portland when arrested.

Sheriff Webb received information early this morning that the two men were traveling north and that they apparently had a load of liquor in their car. He stopped them on the highway south of Roseburg, expecting to find booze, but instead found nearly 200 pounds of fresh venison. He turned the case over to Deputy Game Warden Ed Walker who filed a charge against the two hunters in the local justice court, each of the prisoners entering a plea of guilty.

Believing the case to be one in which the two men were establishing a business of killing deer for commercial purposes, expecting to sell the meat in Poplarland, Judge Hopkins imposed a maximum fine.

The confiscated meat was given to the veterans at the Oregon Soldiers Home in this city.

MURDERED MAN'S WIFE AND PRESTON CLARK CONVICTED
