BULLETS THOUGHT FOR SANDINO ARE SEIZED ON VESSEL

NEW YORK, April 7.—Sixteen thousand rounds of rifle ammunition, believed to have been intended for the Sandino rebel forces in Nicaragua, were in the hands of customs authorities today as the result of a conversation heard through an open port hole by a customs guard.

The ammunition was seized in the stateroom of P. Traetvik, second engineer of the steamship Lempira of the Atlantic Navigation company, which plies between New York and Honduras.

Traetvik was held by customs authorities in the belief that he had been regularly engaged in running ammunition to Nicaragua. He was charged with violation of the presidential proclamation of March 22, 1914, limiting exportation of munitions.
